Biographical Sketch

Donald M. Blinken was born in New York in 1925. He joined the U.S. Army Air Corps in 1944. In 1948 he graduated magna cum laude in economics from Harvard. After 10 years in the retail business, including two in the United Kingdom with Marks & Spencer, he joined the investment firm of E.M. Warburg Pincus, the largest venture capital firm in the United States. He continued to be associated with Warburg Pincus as a managing partner until taking up government service.

In January 1977, Governor Hugh L. Carey appointed Blinken to the Board of Trustees of the State University of New York and subsequently appointed him chairman in July of 1978. He was re-appointed to that office by Governor Mario M. Cuomo and served until 1990. The State University of New York is

the nation's largest institution of higher education. It serves hundreds of thousands of students on more than 60 campuses throughout New York. It awarded Mr. Blinken an honorary degree in 1993.

Donald Blinken was sworn in as Ambassador to the Republic of Hungary by Vice President Al Gore on March 29, 1994 and served until 1997.

In addition to his services in education and government, Ambassador Blinken has dedicated his time and energy to the arts. He was named President of the Mark Rothko Foundation in 1976. Mr. Blinken edited *Eliminating the Obstacles Between the Painter and the Observer: The Mark Rothko Foundation*, 1976-1986. In recent years, Mr. Blinken has also served as vice- chairman of the New York Philharmonic Symphony Society, as a member of the executive committee of the New York Public Library, as a board member and chairman of the Commentary Publication Committee, as a trustee of the Institute of International Education, as overseer of the Nelson A. Rockefeller Institute of Government, and as a member of the Trustees' Council of the National Gallery of Art.

Scope and Contents

This collection documents the activities and concerns of Ambassador Blinken as a board member of the Board of Trustees for the State University of New York (SUNY) in 1976 and subsequently as chairman of the Board from 1978 through 1990. The bulk of the papers consists of correspondence between Blinken and members of the Board, the Chancellor, the campus presidents, and New York State government officials. There are also a number of reports regarding the SUNY system or individual SUNY campuses. Prominent topics of concern were the future of the SUNY system (Independent Commission on the Future of SUNY, 1983-1985), relations with independent colleges and universities in New York (Commission on Independent Colleges and Universities, 1978-1984), upgrading intercollegiate athletic competition (Intercollegiate Athletic Board regarding SUNY Buffalo upgrade to Division II, 1985-1986), SUNY and CUNY relations (1976-1989), and concerns about teaching controversial subjects and academic freedom (Dube controversy at SUNY Stony Brook, 1983-1990). SUNY's financial position in both challenging and stable economic times, SUNY's growth as a state wide educational system, and the changing role of the individual campuses are recurring topics.

Although the collection does contain information regarding SUNY campuses, not all of them are represented in this collection. There is little material regarding curriculum other than a 1982 proposal for a degree in Arts Management. There is also little documentation related to student life or faculty at the SUNY schools. There are no personal papers or papers related to other professional, civic, or government positions Ambassador Blinken has maintained.

Additional material acquired in 2003 contains documents related to the individual SUNY campuses, including campus brochures, statements of inauguration, and correspondence between Blinken and members of the Board, the Chancellor, the campus presidents, and the professors of each campus.

Related materials in the University Archives include: the records of the State University of New York, Board of Trustees (APAP-098); the records of the Office of the President (UA-000); and the records of the Student Association of the State University of New York (SASU) (APAP-046).

Scope and Contents

Blinken maintained a small group of files related to specific SUNY schools. The files are arranged alphabetically by the name of the school. The files in Box 5 were accessioned later and processed separately from Box 1, 2, 3, and 4. The files in Box 5 are also arranged alphabetically by the name of the school. Materials within the files are arranged chronologically. They include reports, correspondence, and news clippings regarding a variety of topics.

There are some files that contain material regarding a specific event or situation. In 1986 the Board of Trustees voted to lift the ban on athletic grant -in-aid at SUNY Buffalo. This change allowed the athletic department to upgrade to Division II in basketball and football with the possibility of upgrading to Division I in subsequent years. Reports from the Intercollegiate Athletic Board are included. Also included is correspondence among the Board members. There are two folders of community correspondence, these include letters from parents, alumni, and members of the community requesting the Board vote to lift the ban and allow the athletic department to upgrade. There are some, though few, requests that the ban not be lifted.

The Dube Controversy at SUNY Stony Brook, 1983-1990, concerns Professor Ernest Dube who was accused of teaching that Zionism is equivalent to racism. Materials consist of editorials, news clippings, statements from the Dean and other faculty members, correspondence from government officials and members of the Jewish community, and memorandum from the Faculty Rights and Responsibilities group. The issue raised questions of academic responsibility and academic freedom in the teaching of controversial subjects. The controversy continued for several years and Dube's tenure appeal prompted the involvement of the American Association of University Professors in 1986.

The controversial Louis Farrakan visited the SUNY Old Westbury campus in April 1985. See Box 2, folder 1.

Scope and Contents

The bulk of this series is correspondence between Donald Blinken and the other members of the SUNY Board of Trustees, Chancellor Clifton Wharton Jr., presidents of different SUNY campuses, New York government officials, and parents of students. The main subjects of the correspondence include responses to news articles, appointments or reappointments made to the Board, or SUNY related institutions such as the creation of the Rockefeller Institute of Government, the proposal to award a degree in Arts Management in 1982, and materials from symposiums and meetings related to education and budget concerns. There are also news clippings and some information related to state-wide school systems outside of New York. There are some biographical sketches and resumes of Board members. Correspondence in 1979 includes debate about the site of the Utica/Rome campus. There are memos and correspondence related to lawsuits, though there are no details or legal papers in the series or collection.

Trustee-NY State Legislative correspondence is between Blinken or other members of the Board and members of the New York State Assembly. The main topics of the correspondence are financial matters, reappointments, and new appointments to the Board.

Correspondence with individuals including Senator Javits, Senator D'Amato, then Congressman Shumer, Governor Carey, Governor Cuomo, and others is mainly related to SUNY budget and financial matters.

Scope and Contents

The Subject Files contain material related to SUNY organizations, institutions, personnel, and activities, as well as Board activities and responsibilities. The earliest item in the series is from 1969. There is some material regarding a proposed 1976 SUNY/CUNY merger. Files contain reports and correspondence related to this issue and financial concerns for both SUNY and CUNY. However the bulk of materials begin in 1977. The files include correspondence, reports, memorandum, and news clippings. There are a number of files on Chancellor Clifton Wharton Jr., the Commission on Independent Colleges and Universities (CICU), the Independent Commission on the Future of SUNY, and SUNY/CUNY relations.

Clifton Wharton Jr., former president of Michigan State University, became SUNY Chancellor in 1977. Early files include evaluations by Board members, biographical information about Mr. and Mrs. Wharton, and information about Wharton's accomplishments as an educator and administrator. After Wharton became Chancellor the files include correspondence between him and Blinken as well as other members of the Board, reports related to the SUNY system and individual campuses, memorandum, and news clippings related to higher education. Chancellor Wharton resigned in 1987 to become Chair and CEO of TIAA-CREF.

The Commission on Independent Colleges and Universities (CICU) files include correspondence between Blinken and the commission and reports regarding SUNY financial matters.

The Donald M. Blinken Academic Administration Fellowship was established in 1981. It was first called the Administrative Internship. According to Articulation Among Some Science Based Programs in SUNY Units In Western New York, (Blinken Papers, Series 3, Box 3, Folder 3), the objective of the program was to allow a senior SUNY faculty member to gain experience in administrative matters within the University, to look at some of the problems facing SUNY as a whole rather than only from the perspective of a particular campus, and to gain insight into the operations of SUNY central.[1] Reports were issued annually in the spring. The report's title and author appear in the finding aid.

The Independent Commission on the Future of SUNY was established in 1983. According to the Proposal for an Independent Commission on the Future of the State University of New York (Blinken Papers, Series 3, Box 4, Folder 6) its purpose was to go beyond faculty, staff, and SUNY officials to evaluate SUNY's role and investigate "how its mandate may be discharged more effectively, efficiently, and with greater benefit to citizens and institutions of the state and nation." Their report issued in January of 1985 recommended that SUNY be established as a "public benefits corporation" in order to be extricated from what the commission found to be overregulation from the state government. The recommendation was denied.

In 1976 there was discussion about SUNY merging with the City University of New York (CUNY) system. Files contain reports and correspondence related to this issue and financial concerns for both SUNY and CUNY.
