Biographical Sketch

Fred Pfeiffer has been involved in organized labor in the Albany, New York Capital District since the 1970s. He was a machinist at GE in Schenectady. He has worked with the Civil Service Employees Association (CSEA), International Union of Electrical, Radio and Machine Workers (IUE), American Federation of State, County and Municipal Employees (AFSCME), AFL-CIO, Solidarity Committee of the Capital District, Labor Committee for Safe Energy, Service Employees International Union (SEIU), the Campaign for a Livable Minimum Wage, and other national and local organizations. As a bargaining advisor, he helped to organize hospital workers, Capital District Off-Track Betting (OTB) workers, Albany Public Library employees, janitors in Albany, and others. He has also worked on behalf of various causes, notably NL Industries and the impact of nuclear power during the 1980s, and Latin American labor organizing and refugee programs, especially El Salvador, during the 1980s and

early 1990s. Pfeiffer served as coordinator at the Capital District Worker Center for the Building Skills Project in the 2000s. Pfeiffer remains a lively local activist, most recently demonstrating with the Occupy Movement.

Scope and Contents

The Fred Pfeiffer Papers contain records resulting from his work with various unions and activist organizations in the Albany, NY area, as well as a collection of union-related materials such as contracts, newsletters, and publications that have historical significance. While all of the series include material directly related to Pfeiffer's work, Series 1 and 2 consist of the most substantial amount of Pfeiffer-related papers. In particular, please see the CSEA and SEIU folders in Series 1 and in the Labor Committee for Safe Energy folder in Series 2. Series 2 contains information on nuclear energy activism and organized labor's engagement with energy issues, mostly during the 1980s. Series 3 relates to labor organizing in Latin America and internationally during the 1980s and 1990s. Series 3 also includes anti-NAFTA, anti-GATT, and anti-WTO materials. Series 4 is a diverse set of published documents and artifacts (mostly buttons and pins) related to labor organizations, conventions, government reports, protests and marches.

Scope and Contents

This series' biggest concentration of materials spans the late 1970s to the mid-1980s and contains Fred Pfeiffer's founding and organizing work with the Labor Committee for Safe Energy. The clippings, notes, publications, pamphlets, reports, official government documents, and flyers related to NL Industries are extensive. The folders for the PSC/CUB and GE PEP include materials related to Pfeiffer's work with the International Union of Electrical Workers (IUE) Local 301. There are also several publications relating to the Three Mile Island partial meltdown accident. Of interesting note is folder 5 in Box 1 which includes a stapled together package of various newspaper articles including one on a KKK recruitment drive outside the Seabrook Nuclear Power Plant.

Scope and Contents

This series contains materials related to labor organizing in Latin America, South America, and the Caribbean, with a strong collection of correspondence, clippings, government documents, and organizing materials about El Salvador. The series also contains materials on South Africa, the Philippines, and the Far East. The folder on Free Trade contains records on local organizing efforts and anti-NAFTA, anti-GATT, and anti-WTO materials. Pfeiffer was engaged with international labor organizing through unions and activist organizations in the Albany area. The Chilean folder is almost entirely in Spanish. A United Ireland newsletter from the Irish Republican Clubs in Albany, New York is found in Folder 11.

Scope and Contents

This series includes a box of pins and buttons related to political campaigns (including ones for Democratic U.S. Presidential candidates), union programs, protests, and marches. Most of the buttons are undated, although some are stamped with the date of the election or related special event. There is a 1993 *The Catholic Worker* about the death of Cezar Chavez, Guatemalan refugee crisis and GATT. There also is a collection of contracts and workers' agreements, historically significant publications from national AFL-CIO meetings, and U.S. Senate Reports related to organized labor. Two *NACLA's Latin America and Empire Report* about President Richard Nixon are included here.
