## Biographical History

The Rensselaer County Greens (RCG) was founded in January 1999. The organizations purpose is to strengthen the Rensselaer County community through the preservation of significant historical landmarks and through the encouragement of environmental-friendly procedures. The grassroots approach is designed to have the voice of every individual citizen interested in the community heard, with their

involvement dictating how their community is run. No matter gender, race, age, or class, the RCG strives for the equal treatment for members of the Rensselaer community.

Since its inception, the organization has worked to save, protect, and dissuade Rensselaer County from accepting proposals that will compromise the environmental and living standards of the community. The RCG was a founding member of Historic Action Network. In RCGs first year of existence the organization successfully prevented a microchip semiconductor plant from being built in North Greenbush, NY. Behind one of the partys spokesmen, Eric Daillie, the Greens used community pressure to stop this microchip plant, known as Chip Fab, from being built. The environmental destruction and physical health issues that RCG believed would result led to their involvement in the issue.

In a more controversial and time-consuming case, the RCG spent the years 2000-2004 attempting to keep Besicorp out of Rensselaer. Besicorp-Empire Development Company, LLC, or BEDCO, wanted to build a \$680 million state-of-the-art facility in Rensselaer in 2000. Besicorp planned to team up with Empire State Newsprint, LLC to create a recycled news clipping manufacturing facility and a cogeneration power facility. The desire to make the Hudson River waterfront aesthetically pleasing, protect the citizens from harmful pollutants, and to clean up the toxic by-products of the previous company, BASF, was the motivation for the RCG members to keep this new business out of Rensselaer. However, re-industrialization took precedence and both the power plant and the papermill received the necessary state permits to build. As of 2006, Besicorp has not constructed either facility.

The RCG has also been involved in many smaller projects during its existence. Preserving woodlands and farmland from being destroyed for the construction of highways, and the sprawl that would result, was an issue when the idea of an Interstate 90 connector was planned in East Greenbush. The preservation of historic landmarks is another issue RCG has been involved with including saving the Freihofer Building in Lansingburgh from being demolished and replaced by a drug store chain. Other initiatives undertaken by RCG are also documented in the organizations records.

## Scope and Contents

---

The records of the Rensselaer County Greens (RCG) contain relevant information behind its efforts to protect the Rensselaer County community from the destruction of environment and historical landmarks. The records consist of applications, permits, court material, environmental statistics and research, news clippings, visual information, rulings, and audiovisuals. The main focus of the records is RCGs conflict with Besicorp and the factory the company planned to construct in Rensselaer.

The records were donated to the M.E. Grenander Department of Special Collections and Archives by member, Eric Daillie. Many of the papers are records he personally created or collected, including correspondence, speeches, and political information he composed. The records came in boxes that were for the most part organized. Much of the information was already in folders and binders. The original order of the records in the collection was largely maintained with a few exceptions.

The records lack comprehensive information about the membership of RCG other than Eric Daillie. The strength of the records lies in documenting how the organization viewed individuals and other organizations who held opposing views.

Several collections in the M.E. Grenander Department of Special Collections and Archives provide further information on the environmental issues of concern to the Rensselaer County Greens. For a complete list of related collections see the subject guide for Conservation and the Environment. Of particular interest are the records of Tom Blandy (APAP-133), Jeanne Casatelli (APAP-150), and the Environmental Clearinghouse, Inc. (ECOS) (APAP-180).

#### Scope and Contents

The multiple issues that Rensselaer County Greens (RCG) raised with this company can be seen in the diversity of the records in this series. Environmental issues were the primary priority with information pertaining to water pollution, air pollution, traffic congestion, previous contaminants in the ground where the new site was to be built, and the noise and smell that would be given off by the plant documented in the records. Application and permit material make up a major component of the series while background statistics and material directly from the court proceedings account for another large section of the series. The environmental concerns and research files were created to be used by RCG, and as a result the majority of the information in the series documents RCGs claims against Besicorp. The pros and cons of what Besicorp could mean for Rensselaer and what it could do to influence the lifestyles of Rensselaers citizens is documented in the various newspaper stories on the topic. RCG handouts give a clear statement of why the organization was fighting against the newly planned plant.

Information on the employment and revenue impacts versus the pollution potential, health hazards, and industry instability is scattered throughout the series. Other semiconductor manufacturers in New York and their statistics are available here as well. Health hazards such as high employee cancer risks, and water pollution and usage cause microchip plants to be dangerous. A geometrical report and a water supply study are each located in folders in the series. Local news clippings show how the community rallied against the Chip Fab project and prevented it from being constructed despite the influence of politicians who wanted the company to be built in North Greenbush.

## Other Projects, 2000-2004

Physical Description: 0.33 cubic ft.

### Scope and Contents

This series contains information about other projects undertaken by the Rensselaer County Greens (RCG). A proposed I-90 connector in the town of North Greenbush was opposed by the Rensselaer County Greens and community opposition to the proposed project was organized. (They believed it was unnecessary and was not worth the destruction of woodlands and the sprawl that would result.) Other information on urban sprawl shows how proposed tax legislation would cause surrounding farmland and country to be quickly inhabited.

In 1913, Freihofer purchased a building constructed in 1896 in Lansingburgh, NY. The Freihofer building became a community fixture. In 2000, the drugstore chain Eckerd's planned on demolishing the building to replace it with one of its box design store fronts. The RCG intervened, and eventually the building was saved from demolition. The news clippings and handouts in the series depict this. It remains a historic site on the Hudson River.

In 2002, Rensselaer Polytechnic Institute began spending a quarter of a billion dollars on new buildings on its campus, becoming known as the RPI Expansion Project. The project became a sore spot for the RCG. Six houses built in the 1800s that were still structurally sound were to be destroyed to make room for the construction. RCG believed the area would also suffer aesthetically and traffic would become a bigger issue. This RCG project is documented in a report by the RCG in the series.

A Report to the Community located in the toxic spraying folder explains the RCG's opposition to spraying chemicals of unknown health risks in the community to prevent West Nile Virus. The question of whether the chemicals or virus posed more of a threat was an issue. News clippings and RCG handouts depict the efforts many of the members of the Troy community were willing to go to to prevent potentially harmful chemicals from being randomly sprayed throughout the city.
