Biographical History

Keogh graduated from the school of commerce of New York University in 1927 and from the school of law of Fordham University in 1930. Keogh worked as a teacher in the New York City public schools in 1927 and 1928, a clerk with New York City Board of Transportation 1928-1930; law clerk in 1930 and 1931; was admitted to the bar in 1932 and commenced practice in New York City; member of the New York State assembly in 1936; elected as a Democrat to the Seventy-fifth and to the fourteen succeeding Congresses (January 3, 1937-January 3, 1967); chairman, Committee on Revision of the Laws (Seventy-sixth through Seventy-ninth Congresses); was not a candidate for reelection in 1966 to

the Ninetieth Congress; resumed the practice of law; member, New York State Racing and Wagering Board, 1973-1976; was a resident of New York City until his death there on May 26, 1989.
