Gross was also extremely active with the Lighting the Torch of Conscience abolitionist campaign.

The records were created or collected during Gross' work with the National Coalition to Abolish the Death Penalty (NCADP), Journey of Hope...from Violence to Healing, Lighting the Torch of Conscience, and other activities in opposition to the death penalty.

The NCADP leads and coordinates the movement to end state killing in the United States. Its 120 member organizations include civil and human rights groups, legal advocacy and public interest groups, and virtually every major church or religious denomination in the country. Journey of Hope...from Violence to Healing is an organization that is led by murder victims' family members. It conducts public education speaking tours and addresses alternatives to the death penalty.

The collection includes NCADP administrative materials, state files, programs, and organizations; Journey of Hope...From Violence to Healing administrative files, videotapes, photographs, and press packets related to speaking tours; and material from the Lighting the Torch of Conscience march in 1990.
