She has attended death penalty trials, lobbied government, spoken to school groups about capital punishment, and testified before legislative bodies during state death penalty hearings, including ones in Massachusetts, Connecticut and New Jersey.

The majority of the collection consists of VHS tapes recording death penalty abolitionist events and speakers, especially those from Journey of Hope. There also are videos recording news of executions and a small number of paper records, including Hogenauer's testimony in New Jersey against the death penalty.
