### **Historical Note**

Deon Tumblin (1976-2004) was convicted of the February 2000 strangulation and beating death of a 75-year-old Texarkana woman. He was sentenced to death and was a prisoner on Texas' Death Row since 2001. In November 2004, Tumblin hanged himself in his cell with a sheet.
