Born in Silesia, Germany, Rudolph Schubert (1901-1994) was the head of the social welfare department in the State Administration of Hamburg until 1934. He emigrated to England in 1937 and then the United States in 1938. He was an instructor in German at the New London Junior College in Connecticut, and later worked in the consumer cooperative movement in the United States for several decades.
