
"This was mob rule and a denial of the right of free speech."

IUE delegates to last week's District 3 meeting in Schenectady heard reports from each local union, and drew up plans for better coordinating district activities after the NLRB elections. Delegates pointed out that under UE the District set-up was used as a propaganda sounding board for communist agencies. Re-organization plans will be submitted at the next conference in Elmira, N. Y.

'Clean Sweep' Forecast by IUE State Leaders

IUE-CIO leaders from all over New York State gathered in Schenectady last week to report on the "state of the union."

When the results were tallied-up it looked like IUE would make a clean sweep of District 3, when NLRB elections are held.

The New York district meeting was one of many similar state-wide conferences to come out with a report that IUE-CIO is on a victory march.

Frank Fiorillo, IUE District 3 Director, was chairman of the Schenectady session.

Local by local the picture looks something like this:

LOCAL 303: Rudolph Wurlitzer Corp., North Tonawanda, N. Y. UE, after pulling stalling tactics all during recent NLRB hearings, has now filed un-

fair labor practice charges to further delay elections. Despite the fact that UE is trying everything in its power to prevent a vote, the workers are solidly behind IUE.

LOCAL 310: General Electric Company, Elmira, N. Y. The shop is already operating under IUE leadership and steward system. The workers are patiently waiting for election date. R. J. Thomas, and other CIO leaders, are scheduled to speak to local in the near future.

LOCAL 310: (Amalgamated) Hilliard Clutch Corp., Corning, N. Y. The workers voted 44 to 1 to affiliate with IUE-ClO in a secret ballot election two weeks ago.

LOCAL 313: Ingersoll-Rand, Painted Post, N. Y. The IUE Local called a protest strike last month after 5 local leaders were suspended for leaving their jobs on union business. (UE President and other

officers scabbed.) Part of the strike settlement was guarantee by company that it would go along with a consent election. UE is trying to prevent vote in hearings that are now in progress by demanding that the plant be split into two units: foundry and production.

LOCAL 315: Westinghouse Repair. The shop is practically 100 percent IUE.

LOCAL 320: General Electric, Syracuse, N. Y. Out of 130 shop stewards, 128 are IUE. The IUE is processing grievances at the foremen level, with better results than UE had under the contract. In the last month local leaders have got 87 job rates up-graded. The UE is trying to cause disruption among new people, who do not know the issues. UE, badly beaten in the plant, is quietly encouraging a "no-union" vote in the NLRB elections.

LOCAL 321: Easy Washer, Syracuse, N.Y. An election date should be set

within the next ten days for this shop. The local is already paying its per capita to IUE-CIO. The election will be a walk-away for IUE.

This is just a small sample of what the state leaders meant when they said "IUE will take every major plant in the New York State district."

The conference also passed resolutions asking the NLRB to do everything in its power to bring about an early election in the Westinghouse and General Electric chains.

Other resolutions adopted:

- . Condemned UE for its betrayal of the Remington-Rand workers during their strike, (See story, page 8.)
- 2. Praised the workers in General Motors plants on their overwhelming vote for IUE-CIO.

UE Desperate in Dying Hours

UE, staggering and shaken from 19 consecutive defeats at the hands of American union members, has its back against the wall. UE, like any desperate and defeated group, is clutching at every straw trying every last trick, and underhanded method to salvage the remains of its thinning ranks.

UE is a weak and dying organization. It is contorted with a death paralysis: with a craze and fear that will drive it to any extremes.

Yes, UE is bankrupt, and defeated it is through as a power in the American labor movement. But in these last few days of its existence it will try to spread chaos, disruption and disorganization through the ranks of labor.

Here in Schenectady the UE will no longer be able to hide behind the weak and inoperative contract it holds with GE. That contract expires on April 1 and with its expiration UE will be left anaked; stripped of its legal immunities. UE will be seen for what it is an organization that represents only a tiny fraction of the workers in the GE plant.

In the past few months UE has failed miserably in its obligation to police the contract. It has failed to process grievances, to adjust unhealthy working conditions.

UE has let the grievances pile up, has let unrest and dissatisfaction grow and spread. UE has done this deliberately. It has provoked and agitated the workers, it has blamed its own failing and short sightedness on the IUE-CIO and on the company.

The UE has been protected with a contract in the last months. It has had the EXCLUSIVE right to process grievances. It could have operated under the present conditions as it always operated, because GE

would NOT recognize any but UE stewards.

But UE has fallen down on the job. UE has not serviced or policed the contract. It has deliberately let unrest and dissatisfaction mount to fever pitch.

There is a reason for UE's deliberate betrayal of trade union functions, and the reason is quite simple. UE intends to use these unsettled grievances, this unrest and dissatisfaction to provoke shut-downs, quicky strikes and other work stoppages.

Yes, it might go as far as to try to pull a strike when the contract expires—despite the fact that GE is forced by national legislation to maintain all the provisions and benefits of the existing contract.

Make no mistake about it—There will be trouble—trouble incited and agitated by the communist bosses of UE.

But we of IDE-CIO are confident that GE workers will no longer follow this misleadership, will not longer heed the cries of these communist trouble makers.

We of the IUE-CIO are sure that the workers will rally behind a real American trade union and reject this corrupt and crumbling citadel of foreign ideology.

We know that the workers in General Electric are as sick and disgusted with UE's underhanded methods, as were the workers in the other plants that have voted overwhelmingly for IUE-CIO.
