In fact, RPI does not seem even to remember that such a program exists. In fact, two of the continuation schools listed (Binghamton and New Paltz) have no chem engr program currently. Clearly, major discussions would be required to rectify these circumstances which make advisement well nigh impossible. Thus, we ask for deactivation for the time being; we will accommodate the remaining couple of students currently in the program.
