#### 2. For information:

The Council received a request from the Undergraduate Academic Council to review the London Business Program since there may be policy issues associated with offering an entire degree program at a remote site. Because the Council Chair did not receive the request for review until November 18 (the UAC received the request for UAC review on November 15), it was impossible for the Council to report to the Senate on the policy implications of this external degree program. The request has been referred to the Long-Range Planning Committee for review. The Committee will present its findings at the next Council meeting on December 16. The Council appointed Professors Bakru, Cannon, Grenander, Kim to serve as an advisory committee for the President's Excellence in Academic Service Awards.

#### 3. Committee activities:

Resource Advisory Committee

The Resource Advisory Committee has met several times to review the 1985-86 budget allocations with particular attention to the recommendations of last year's Budget Panel. The RAC will soon begin examining the budget requests for 1986-87. Special attention will be paid to temporary services, supplies & expenses and graduate student allocations. Finally the RAC will be discussing the impact of the new "flexibility" on resource allocations.

#### Long-Range Planning Committee

The LRPC has met twice to hear reports from Michele Deasy, Chair, Enrollment Management Committee, on the Committee's activities and Francis Lees, Associate Vice-President for Information Systems, on the "Five-Year Prospectus for Computing & Technology". The Committee will discuss these two presentations and prepare a report for the Council. Other agenda items for future meetings include long-range policy issues related to: capital construction with particular attention to the Library and graduate married student housing; international education.

#### Evaluation Policy Committee:

In light of current discussions in SUNY Central and Education Commissioner Bennett's recent announcements, the Committee will be examining the current evaluation procedures used by SUNYA.

#### PROPOSED TEMPORARY INCREASE IN MEMBERSHIP FOR THE COUNCIL ON RESEARCH

PROPOSED BY: Council on Research

December 9, 1985

#### IT IS HEREBY PROPOSED:

- I. That the Council on Research increase its membership from eight (8) teaching faculty to ten (10) and from two (2) professionals to three (3).
- That the increase in membership be temporary-til July 1, 1987 and at-which time the II. Council will revert to its current composition.
- III. That this proposal take effect immediately following necessary approval.

#### RATIONALE:

A copy of the current standing "Committee Descriptions" is attached.

A copy of the current "Membership" list is attached.

In addition to the Council's five standing committees it has two Ad-Hoc committees and a third pending. Excluding the Chair and Vice Chair, six of the seven faculty members chair committees. The Vice Chair sits on one committee and represents the Council as an advisor to a Center. There is a critical shortage of human resources to adequately address those issues and concerns which come before the Council for action.

An increase of three members would give the Council the necessary staff to carry out its charges.

Committee on Centers and Institutes

Charge: The Committee on Centers and Institutes shall make recommendations to the Council and the Vice President for Research and Educational Development on policies - - related to the organization, development, and evaluation of centers and institutes at the University.

#### RESOLUTION ON ALTERNATE-SIDE-OF-STREET PARKING IN CITY OF ALBANY

SUBMITTED BY: University Community Council December 9, 1985

IT IS HEREBY:

RESOLVED, That the University Senate encourages President O'Leary to urge the City of Albany to change alternate-side-of-the-street parking from midnight to 8:00 A.M. where it exists in areas heavily inhabited by SUNY Albany students.

RATIONALE: There is real concern within the University community about the impact of alternate-side-of-the-street parking from midnight to 8:00 A.M. on students' and particularly female students' safety. Where such regulations are in effect, students may have to walk several blocks from a parking space to their residence late at night.

Such parking regulations are justified by the need to clean and/or plow city streets. We believe these goals can be achieved without alternate-side-of-the-street parking from midnight to 8:00 A.M. For example, such parking regulations might be in effect during daylight hours when walking extended distances from a parking place to a residence would pose fewer dangers.
