A five-cent increase in the top hourly rate for millwrights, riggers, ironworkes, carpenters, masons, roofers, painters, tinsmiths and crane repairmen was offered by the company in the second building trades negotiations meeting Friday.

The same offer for the tinsmiths and crane repairmen had been made in the earlier cases for these groups, which are now pending between the top management of the company and the nation-

At Least 10 Cents Asked

The union, on instruction of the building tradesmen, has been insisting that the GE building trades rates, which are far below those on the outside, should be corrected at least to the extent of the 10 cents won for the electricians and steamfitters through the War Labor Board.

Speaking for the company, A. C. Stevens, assistant to the general superintendent, refused to offer any raise for the machine tool fitters, glaziers and

pipe coverers. Stevens offered to establish a single helpers' rate of \$1.101/2, without "B" classification, in the classifications of electricians, steamfitters, tinsmiths, millwrights, riggers, and carpenters, but only if the union would drop its proposal for an apprenticeship course under which all helpers could be trained to become recognized journeymen, and drop the proposed limitation of one helper to one journeyman. Committeemen in the negotiations were emphatic that apprenticeship courses are needed.

No raise was offered to the masons' and roofers' helpers, whom the company classes as "special" laborers.

Special Meeting Planned

A special meeting of the building trades members will be called within the next few days to hear the negotiating committees complete report on the company's position on all points, and take action on it. Another bargaining session was scheduled for yesterday to clear up some points in the company's stand.

Stevens agreed in principle that the building tradesmen should be fully utilized before an outside contract is let, and that the union should be given notice in advance of any outside contract and a chance to discuss the matter, "as far as possible." He objected. however, to the union's specific proposals for regulating outside contracts. \$1.231/2.

Shop Meeting Refused The company turned down the request for a shop meeting after receiving complaints from Brother Kelly on

1. Congestion of the iron floor. 2. Unreasonable and conflicting orders of foremen.

3. Bad conditions in crane service. The shortage of crane followers has caused long waits on the part of other workers. Many men have had to go home because there was no work to do. One crane in the main bay had no crane follower for two months.

4. Shortage of stockroom clerks causes other workers to lose time getting

their own stocks. 5. Under a new system employees lose considerable time waiting for tools

to be given them for boring mill work. 6. The planning and piece departments are so behind schedule that youchers are often not ready until the end of a weeks work Workers lose time trying to hunt up their vouchers.

Although the complaints involved arose in Bldg. 16, similar conditions apparently exist in other buildings. Kelly should be notified of them

Company Uncooperative

"The Bldg. 16 conditions could have been cleaned up immediately if the company had acted in a reasonable and cooperative way," Brother Kelly said "and agreed to visit the shop to check

"Instead, they are stalling us by insisting on dotting every "i" and going through every step of a formal grievance procedure.

"One big trouble in Bldg. 16,-the conflicting orders and the delays,—is that the place is top-heavy with 'executives'. The company laid off stockroom keepers and other necessary workers, who needed their jobs badly, and went out of its way to safeguard jobs of company sub-executives."

## Union Battles GE Shut-Down

A two-front attack on the General Electric Co. plan to shut down the Schenectady plant for half a day Election Day without pay was authorized by the Local 301 Executive Board at its Monday meeting.

Officers were directed to take the case to the district attorney's office with a complaint charging intended evasion of the Election Law and to demand criminal prosecution of the company if the shut-down is carried out as scheduled.

On the grounds of contract violation, the union will process a case through the regular grievance machinery for recovery of pay lost by the shut-down.

#### GE, Please Copy

In contrast to GE, the American Locomotive Co. has announced it will give its day shift workers eight hours pay Election Day, but send them home two hours early to meet the Election Law requirement of granting two hours off with pay.

Without hedging, ALCO agreed again this year to this arrangement with the United Steelworkers of America.

The union charges that the company violated the contract with UE by ordering the shut-down without first trying to negotiate a departure from the 40 hours work week for "an adequate

The union has asked GE to give eight hours pay for six hours work Election Day in order to comply with the section of the Election Law guaranteeing a registered voter two hours off with pay to go to the polls. The union charges that shutting the plant down at noon (Continued on Page 2)

## 301 Board Hits Latest Attacks Against Union

A series of recent attacks on the unon brought a sharp warning this week from the Local 301 Executive Board that the GE and the Republican machine are using "conscious and unconscious stooges" among the membership in their efforts to weaken the union and destroy its program.

The Board, at its meeting Monday, condemned an anonymous leaflet distributed at the plant gates last Friday as an attack on Local 301 "for the sole purpose of disruption."

The Board also condemned the action of John Saccocio in going to the press with business of the Board "bofore the Board had an opportunity to bring the matter to the attention of the membership."

Such an action "is grounds for charges against any so-called leader in our union." the Board declared.

Brothers Saccoccio and John Boyle, both Board members, walked out of Monday's meeting after the discussion of the recent attacks on the union be-

The remaining members unanimously went on record as mentioned above and also voted unanimous approval of the answer Leo Jandreau wrote to a letter of Sal Vottis' in the Schenectady Union-Star. The Vottis letter attacked the union, PAIC and Brother Jandreau.

### **Craft Groups to Act** On Wage Negotiations

All GE building tradesmen have been called to a meeting at 7:30 p.m. Monday at Local 301 Hall to act on the current negotiations for wage adjustments and a contract supplement covering special problems of these trades. The negotiating committee of building trades

representatives scheduled the meeting. Three bargaining sessions in Bldg. 41 found the company and the union far apart on the unions proposals. At the third session, last week, A. C. Stevens, assistant to the general superintendent of the plant, said the company expected Class A building trades journeymen to act as leaders on certain jobs, sometimes for long periods, without extra pay for this leader work.

He declared only those assigned regularly as leaders of fixed groups would be paid as leaders. The representatives protested strongly against this propo-

Stevens repeated the company's refusal to work out an apprenticeship system for the building trades. He even refused to meet with a federal apprentice training service official. The union had suggested the government representative might help work out the problem.
