G.E. Vice-President F.J.Borch, sold 2600 shares of G.E. stock leaving a balance of his holdings at 10,719. Under the Stock Option (reserved for "top brass") he could have bought this stock for as little as \$23.75 per share, so let's figure this out just for fun. June 16th closing stock market found G.E. stock at \$93. per share. \$23.75 from that figure is \$69.25 times 2,600 which gives Mr. Borch a total of \$180,050.

Despite the fact that it was Sunday, Fathers' Day and a beautiful day for picnics, over 200 Senior Citizens turned out to support the rally for medical aid for retired pensioners.

Jack Suarez, President of Dist. #3, IUE, and a Vice-President of the N.Y. State AFL-CIO, chaired the meeting. The theme was: "Best Gift for Dad-Medical Security with Dignity". The time: 3 PM; the place: at the TUE Hall on Erie Blvd.

Principal speakers were: Paul Benjamin, State Director of Senior Citizens of America, State Senator Begley, George Palmer (representing Sam Stratton), Jack Suarez, Leo Jandreau and Mrs. Leona Newton, Dept. of Welfare.

Bennie Geersen and Jack Lindsay representing the pensioners and retired workers, read telegrams from Gov. Rockefeller, Sen Keating, Assemblyman Egan, W. Clyde Wright and Mayor Ellis.

Leo Jandreau, in addressing the Fathers' Day Rally, said that the persons fighting legislation now to provide medical care for the aged are the same as those who fought social security, minimum wage and eight-hour-a-day bills.

Business Agent Jandreau said that "these people predicted all kinds of disaster" when the above bills were passed. "Instead, the country has prospered," he stated. "It took a depression to knock some sense into the heads of those people," he asserted.

Besides aid for senior citizens, Jandreau said the country should strive for full employment, better education and better housing.

"Three and one-half billion dollars for foreign aid ... I think we need it, but I also think we need another three and one-half billion for domestic aid," he added.

A resolution was adopted unanimously by the Rally, which stated, in part:


"We resolve, on behalf of the 16 million Senior Citizens in the U.S., that our representatives in Congress shall be put on notice that we will not let up in our fight to obtain that which we believe to be morally right and economically necessary...the right to adequate Health Insurance under our Social Security System for pensioners when they are forced to live on a 'fixed income'..."

In most cases the people on lack of work have heard from some one not qualified to know that they cannot qualify for Unemployment Insurance until their vacation period for which they have been paid when they go on lack of work is exhausted. This is not so as the vacation pay is an already earned bonus for work performed . To make matters worse, some departments will add to the lack of work slip a note saying paid thru a certain date, this date being to the end of the vacation period layoff. This confuses the issue no end.

My advice to anyone on lack of work is to go to the Unemployment Insurance Office immediately and process a claim. The unemployment insurance administrators are qualified to see that all valid claims are processed.

The Senate Will Decide

THE HOUSE HAS PASSED and sent to the Senate an omnibus social security bill containing a number of excellent provisions for improving the program. But the bill contains a "pauper's oath" approach to health care for the aged that contradicts all of the basic principles of a sound social insurance program. Hokum has been substituted for legislation.

The membership of the House has no choice. The bill containing the improvements and the "comprimise" on health care went to the floor under a closed rule preventing amendments of any kind. The House did not have the opportunity to vote on the Forand bi'll principle of using the time-tested social security system.

The fight to enact legislation to help retired persons meet the crushing costs of health care through the social security system has shifted to the Senate where the first round will be fought in the Senate Finance Committee.
