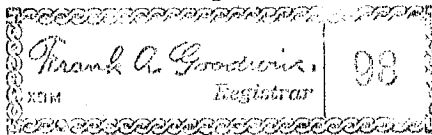

## THE NATIONAL SOCIAL SCIENCE HONOR SOCIETY PI GAMMA MU

### PURPOSE

The purpose of Pi Gamma Mu is the inculcation of the ideals of scholarship and social service in the study of social problems. Pi Gamma Mu was not organized to oppose or advocate any particular social movement, but aims rather to instill in the mind of the individual a scientific attitude toward all social questions. Its particular purpose is to send out from our colleges and universities young men and women imbued with social idealism, trained in scientific thought, and encouraged to help others to be scientific in their thinking on social questions. Incidentally, it aims at more cooperation among students of the several branches of social science, all of which must make contributions of knowledge if social problems are to be solved. Pi Gamma Mu aims to occupy a position in the field of social science comparable to that of Phi Beta Kappa in the field of literary studies and of Sigma Xi in natural science. Nevertheless, it differs from the ordinary honor society in having an active program for the Society as a whole, its chapters, and all of its members.

### SYMBOLS

The motto of the Society is the epigram of the Master Teacher, "Ye shall know the truth and the truth shall make you free." The Society's key has a wreath at the bottom to suggest that social science is the outgrowth and fulfillment of natural science. The strenuous running figure is reminiscent of the ancient Greek torch race and symbolizes humanity bringing knowledge to the solution of its own problems and passing on the light from generation to generation. The colors are blue and white—for truth and light. The official flower is the blue and white cineraria. The banner is a blue and white checkerboard design, symbolizing the multiplicity and complexity of

social problems. Each square represents a chapter of Pi Gamma Mu, on which the Greek-letter name of the chapter may be embroidered in gold. A national ritual has been adopted for optional use in initiating new members, in inaugurating officers, and in installing new chapters.

#### JOURNAL

The official journal of Pi Gamma Mu is *Social Science*, published quarterly by the Social Science Publishing company, a corporation organized by Pi Gamma Mu under the laws of Kansas. *Social Science* provides a medium for disseminating news of the national and chapter activities throughout the country, but its primary purpose is to promote the ideals of the Society through the publication of articles and reviews.

#### HISTORY

The first suggestion which led to the establishment of Pi Gamma Mu was made by Leroy Allen, then Professor of Economics in Southwestern College, at a meeting of students majoring in that department, held in April, 1924.

By the early fall of 1924, seventeen colleges and universities had agreed to establish charter chapters. A constitution written by the founder was discussed and adopted by mail and the following officers were elected by mail ballot: President, Leroy Allen; Secretary-Treasurer, William A. Hamilton; Vice-Presidents, D. O. Kinsman, J. C. Granbery, Grace R. Hebard, Robert C. Root, S. B. Laughlin, A. G. Weidler, and C. J. Bushnell. The constitution fixed 1928 as the year for the first national convention and an Executive Committee composed of Leroy Allen, William A. Hamilton, D. O. Kinsman, J. C. Granbery and Robert C. Root was elected to manage the affairs of the Society during the interim.

On December 1, 1924, charter chapters of Pi Gamma Mu were organized simultaneously in Southwestern College, College of William and Mary, Washburn College, Berea College, University of Akron, University of Toledo, North Central College, Lawrence College, University of Wyoming, Baylor University, Southwestern University, Hamline University, Willamette Uni-

versity, College of the Pacific, Montana State University, Iowa State College, Birmingham-Southern College.

The first chapter established in a large university was that at the University of Pennsylvania, organized in 1927 by Dr. S. Howard Paterson. The first chapter to be organized outside the continental area of the United States was established in 1929 in the University of Honolulu. The first chapter established in a foreign country was that organized at the University of Toronto, in 1932.

In 1929, Pi Gamma Mu was incorporated as a non-profit corporation under the laws of the State of Colorado. *Social Science*, established in 1925, was in 1929 taken over by a newly created corporation of the State of Kansas, called The Social Science Publishing Company Incorporated, stock in which is owned by Pi Gamma Mu, Incorporated, the parent corporation.

#### PRESENT STATUS

Although of recent origin, Pi Gamma Mu now has over one hundred active chapters and several thousands of members. Membership-at-large permitted, during the first few years of the new society, was discontinued in 1933. Members are initiated into the Society only through their respective collegiate chapters.

The financial condition of the society is excellent. Its books are audited each year by a competent firm of certified public accountants. The annual financial statement is published in the April number of *Social Science*. A steadily growing reserve fund is invested in United States Bonds, held as an endowment fund to promote scholarship in the social sciences.

As part of its program in the development of interest in the social sciences, Pi Gamma Mu has become associated with the American Association for the Advancement of Science. With this and other learned societies it holds jointly sponsored programs. A social science lecture, usually given at the summer meeting of the Association by some distinguished authority in that field, is sponsored by Pi Gamma Mu.



#### ORGANIZATION OF NEW CHAPTERS

New chapters are admitted to Pi Gamma Mu by the National Board of Trustees at its annual meeting in December from such colleges and universities on the approved list of the Association of American Universities as are thoroughly prepared to maintain such chapters and which have a sufficient number of specially trained faculty members, a sufficient number of appropriate courses, and adequate library and other facilities to offer students training of a high standard of quality in the social sciences.

#### THE PI GAMMA MU CHARTER

The Society was incorporated under the name, "The National Social Science Honor Society, Pi Gamma Mu, Inc.," under the laws of Colorado, on April 5, 1929, as a non-profit corporation. By its charter, the organization is authorized to carry on the activities of an honor society through a board of five trustees who are responsible for the management of the affairs of the Society.

#### THE SCOPE OF THE SOCIETY

Under the terms of its charter, Pi Gamma Mu has undertaken the task of encouraging the study of the social sciences by stimulating such interests among graduate and undergraduate students and faculty members in colleges and universities throughout the world. The privilege of membership in the Society is granted to those who have shown unusual interest and aptitude in the study of such sciences. The various chapters are permitted a wide latitude in carrying out their respective programs designed to further the general aims of the organization.

In addition to the assistance given local chapters, the national organization sponsors public lectures from time to time and offers a varied program of interest to students and faculty members alike at the national conventions of the Society which are held biennially.

## The By-Laws

OF

### The National Social Science Honor Society

#### PI GAMMA MU, INCORPORATED

Adopted December 29, 1931

Revised to January 1, 1945

#### ARTICLE 1—MEMBERSHIP

*Section 1.* Any person of good moral character who is, or was, an officer, or member of the teaching staff, alumnus, graduate student, senior or junior in any college, university, or other institution of higher learning, where there is a chapter of Pi Gamma Mu, may be elected to membership by a majority vote of the chapter under the supervision of chapter faculty members, or by a committee of chapter faculty members, providing that such person has had at least twenty semester-hours of social science with an average grade therein of not less than "B" or 85 per cent, and has further distinguished himself in the social sciences.

*Section 2.* A person so elected shall become a member upon the payment of the initiation fee.

*Section 3.* The national initiation fee shall be seven dollars (\$7.00). It shall include the cost of one year's subscription to *Social Science*, the official journal of the Society, a membership card, a key permit, and a diploma of membership. This initiation fee shall be a life-membership fee, and no national dues, fees, or assessments shall be imposed.

*Section 4.* The National Board of Trustees may from time to time recognize distinguished service in the social sciences by election to honorary membership and by granting a special hon-

or key to the persons who by their accomplishments have merited such recognition.

*Section 5.* The National Board of Trustees may choose nationally elected members from among outstanding social scientists who are members of the administrative or instructional staffs of colleges and universities in which there are no chapters.

*Section 6.* Subject to the provisions of Sections 2 and 3 of this article, each collegiate chapter may annually elect one associate member not connected with the institution, provided that such member shall have rendered outstanding service in some field of social science.

#### ARTICLE II—OFFICERS

*Section 1.* The officers shall be a National President, a National First Vice-President, a National Second Vice-President, a National Executive Secretary, and a National Treasurer. All officers shall be elected by the National Convention. The National President, National First Vice-President, National Second Vice-President and National Treasurer shall hold office for a term of two years, beginning January first following their election, and until their successors are duly elected and qualified. The National Executive secretary shall hold office for a term of four years, from January first following election, and until his successor has been duly elected and qualified. Such officers shall be eligible for re-election.

*Section 2.* It shall be the duty of the National President to preside at all meetings of the National Convention and of the National Board of Trustees, to execute the orders and policies of the National Board of Trustees and to report annually to the trustees on the work done by the corporation during the current year, the status of the Society among honorary societies in the United States and recommendations for the future development of the corporation and its work from data prepared by the National Executive Secretary.

*Section 3.* It shall be the duty of the National First Vice-President to assist the National President, and to preside in his absence. In the event of the death, removal, or resignation of the National President, the National First Vice-President shall become National President for the remainder of the term for which the National President was elected.

*Section 4.* It shall be the duty of the National Second Vice-President to assist the National President, and to preside in the absence of both the National First Vice-President and the National President. In the event of the death, removal, or resignation of both the National President, and of the National First Vice-President, the National Second Vice-President shall become National President, or National First Vice-President, as the case may be.

*Section 5.* In the event of the death, removal, or resignation of the National President, National First Vice-President, and National Second Vice-President, or in the event of any vacancy occurring in these three offices, which vacancy is not filled as indicated in Sections 4 and 5 of this article, then such vacancy shall be filled by an election by the National Board of Trustees.

*Section 6.* It shall be the duty of the National Executive Secretary to act as executive officer of the National Board of Trustees, to execute the orders and policies of the National Board of Trustees, to keep the minutes of the meeting of the National Board of Trustees, and of the National Convention, to conduct the business and correspondence of the corporation subject to the regulations of the National Board of Trustees, to receive and account for all funds acquired in any manner by the corporation, to deliver to the National Treasurer and secure his receipt for all funds which the National Board of Trustees directs him to so deliver, to disburse to all other persons funds authorized for disbursement by the National Board of Trustees. He shall also prepare and submit to the National Board of Trustees at least two weeks prior to the meeting:

(a). An itemized budget showing the esti-

mated expenditures for the next fiscal year for every activity of the corporation, and of The Social Science Publishing Company, Inc. The fiscal year shall be from November 1 to October 31.

(b). Detailed plans for the national and local program work of the corporation for the next calendar year.

(c). Detailed plans for the administration of the membership, fiscal, scholarship, and other affairs of the Society.

The National Executive Secretary shall present at each annual meeting to the National Board of Trustees a financial report prepared and certified by a reputable certified public accountant. The National Executive Secretary shall be properly bonded at all times at the expense of the society.

*Section 7.* It shall be the duty of the National Treasurer to receive and account for all funds of the Society held by him, and in accordance with written instructions from the National Board of Trustees, to invest and reinvest such funds, to disburse such funds in accordance with written directions from the National Board of Trustees, and to present at each annual meeting to the National Board of Trustees a financial report in conjunction with a similar report presented by the National Executive Secretary prepared and certified by a certified public accountant. The National Treasurer shall be properly bonded at all times at the expense of the Society.

*Section 8.* In the event of the death, removal or resignation of the National Executive Secretary, or of the National Treasurer, such vacancy shall be filled by appointment by the National President for the unexpired term subject to confirmation or change by the National Board of Trustees at its next meeting.

#### ARTICLE III---NATIONAL BOARD OF TRUSTEES

*Section 1.* The National President, National First Vice-President, National Second Vice-President, National Executive Secretary, and the National Treasurer shall constitute the National Board of Trustees of this Society, and their elec-

tion to office shall constitute their election as trustees in accordance with the terms of the charter of this Society.

*Section 2.* Unless otherwise determined, the National Board of Trustees shall meet annually at such time and place as shall be agreed upon by the majority vote of its members.

*Section 3.* Members of the National Board of Trustees may vote by proxy or by mail on any question before the Board.

#### ARTICLE IV---REGIONS AND PROVINCES

*Section 1.* The National Board of Trustees shall from time to time establish Regions, the number and boundaries of which shall be determined by the National Board of Trustees, each Region consisting of a number of Provinces. Each state of the United States, the District of Columbia, the Hawaiian Islands, and the Philippine Islands, shall constitute a Province, and the National Board of Trustees shall from time to time constitute such provinces, in the dependencies of the United States and in other countries as seem advisable and shall determine the boundaries thereof.

*Section 2.* Each Region shall be presided over by a chancellor and Vice Chancellor, and each Province by a Governor and Lieutenant Governor, all of whom shall be elected by a majority vote of all members of Pi Gamma Mu in attendance at Regional and Provincial Conventions respectively and shall hold office for two years from date of their election (and until the election of their successors.) In case such officers have not been elected by conventions in their respective regions or provinces, the vacancies may be filled by the National President. In case of the death, resignation, or removal of any Chancellor or Governor, the Vice Chancellor or Lieutenant Governor in that region or province shall succeed to the higher office.

*Section 3.* It shall be the duty of the Chancellor and the Governor to supervise the work of Pi Gamma Mu in his respective Region or Province, to promote its program therein in whatever

way possible, to call and preside at its conventions, and to perform such other duties as may be assigned to him by the National Board of Trustees.

*Section 4.* It shall be the duty of the Vice Chancellor and Lieutenant Governor to assist the Chancellor or Governor in all of his work, to serve as acting Chancellor or Governor in his absence or disability, and to succeed him in office in case of his death, resignation, or removal.

*Section 5.* The National Board of Trustees shall have the power to remove any Regional or Provincial officer for any cause it may deem sufficient, and its action in the premises shall be final, but any officer thus removed may be re-elected at any regular Regional or Provincial Convention, without prejudice to the right of the National Board of Trustees subsequent to such re-election to exercise the power given them by this section.

#### ARTICLE V—CHAPTERS

*Section 1.* There shall be two kinds of Chapters, Collegiate Chapters and Community Chapters.

*Section 2.* Collegiate Chapters may be established only in colleges, universities, or other institutions of learning which are on the accredited list of the Association of American Universities, which are thoroughly prepared to maintain such chapters, which have a sufficient number of specially trained faculty members, which have a sufficient number of appropriate courses, and which have adequate library and other facilities to offer students training of high quality in the social sciences. Each institution must be approved in advance of its organization by a four-fifths vote of the National Board of Trustees. Such chapters may be established in accordance with standards of admissions and methods of procedure established by the National Board of Trustees.

*Section 3.* Members of the Society residing in a community in which there is a Collegiate

Chapter may be elected as regular members of that Chapter by a majority vote.

*Section 4.* Community Chapters may be established by a majority vote of the National Board of Trustees in any community in the United States or Canada, provided geographical conditions make it reasonable and feasible for members to attend several meetings per year. Membership in Community Chapters shall be open to all members of Pi Gamma Mu who reside or are employed in the community included in the charter. Community Chapters shall have no power to elect any one to membership in Pi Gamma Mu. Community Chapters shall be granted a Charter by the National Board of Trustees.

*Section 5.* A minimum of fifteen chapter members shall be required for a new chapter, whether Collegiate or Community.

*Section 6.* All Chapters, whether Collegiate or Community, may work out their own program of activities, subject to these By-Laws.

*Section 7.* Chapters of either kind may be disbanded and their charters revoked only by unanimous vote of the National Board of Trustees; chapters of either kind may voluntarily surrender their rights and privileges by surrendering their charter to the National Board of Trustees and filing written notice that such action has been taken by the chapter concerned. The National Executive Secretary shall report to the Trustees at their annual meeting on chapters which have not been functioning properly. A college Chapter failing to elect some student members in any given year is thereby automatically discontinued unless special action is taken by the Trustees. It may be restored only by vote of the Trustees.

*Section 8.* All Chapters, whether Collegiate or Community, may impose upon their membership such local dues, fees, and assessments as they may deem desirable for local purposes.

*Section 9.* Each Chapter, whether Collegiate or Community, shall be entitled to one vote at the National Convention, but voting by proxy shall not be permitted.

#### ARTICLE VI—CONVENTIONS

*Section 1.* National Conventions shall be held biennially at such times and places as shall be determined by the National Board of Trustees. Special conventions may be held at the discretion of the National Board of Trustees.

*Section 2.* All members of Pi Gamma Mu shall have the right to speak at the National Convention, and to serve on committees, but voting on all principal or substantial questions shall be by Chapters, each Chapter having one vote, but no Chapter may vote by proxy. A majority vote of the accredited delegates of a Chapter present at a National Convention shall determine how such Chapter shall vote on any principal or substantial question.

*Section 3.* Regional and Provincial Conventions may be held at such times and places as respective Chancellors, Vice Chancellors, Governors, or Lieutenant Governors shall determine.

*Section 4.* Regional and Provincial Conventions shall have power to elect Regional and Provincial officers, respectively, to suggest to the National Board of Trustees amendments to and revisions of the By-Laws of the Society, and to recommend to the Chapters and members in their respective territories such action as they deem advisable for the prosecution of the work of the Society therein.

#### ARTICLE VII—OFFICIAL JOURNAL

*Section 1.* The Society shall maintain an official journal to be known as *Social Science*, which journal shall constitute the official organ of The National Social Science Honor Society, Pi Gamma Mu, Incorporated.

*Section 2.* The official journal shall be published by a separate corporation known as The Social Science Publishing Company, Incorporated.

*Section 3.* Five members of Pi Gamma Mu shall be elected by the National Board of Trustees for a term of two years to represent the interests of Pi Gamma Mu in The Social Science Publishing Company. The National Treasurer of Pi Gamma Mu shall have the custody of all shares of stock

of The Social Science Publishing Company except the qualifying shares held by the other stockholders.

*Section 4.* The Treasurer of The Social Science Publishing Company shall have the custody of all funds of that company, and shall be properly bonded at the expense of that company, and shall submit to the National Board of Trustees of Pi Gamma Mu at each annual meeting a financial report prepared and certified by a reputable certified public accountant covering the past year's fiscal operations.

#### ARTICLE VIII—ADVISORY COUNCIL

*Section 1.* The National Board of Trustees may appoint members of a National Advisory Council for the purpose of securing the advice and counsel of outstanding social scientists in matters pertaining to the general welfare of this Society. The number of such members shall be determined by the National Board of Trustees.

#### ARTICLE IX—WORLD WAR II

*Section 1.* The National Convention of the Social Science Honor Society, Pi Gamma Mu, Inc., scheduled to be held in December of 1943 shall be postponed for one year because of war-time conditions, and all members of the Board of Trustees and officers of the Society shall continue to hold office and perform their usual functions until January 1, 1945.

#### ARTICLE X—BY-LAWS

*Section 1.* The National Board of Trustees shall have power to make, alter, amend, or repeal such By-Laws as it may deem necessary for the proper administration of the affairs of this corporation at any regular or special meeting of the National Board of Trustees, provided that the By-Laws shall not be changed at a special meeting unless proper notice has been given concerning the changes proposed.
