- a. Chairman Salazar steps down and Vice Chairwoman Donelan chairs unfinished business
- 1. S.1920-BAA
 - i. Salazar Motion to add 514.3.3
 - 1. Howard Second
 - ii. Daquial Can we get a brief overview of the item?
 - 1. Salazar- A lot of people have approached me to change the student activity fee. I got the minutes from last time it was changed, which is 2016. I presented the process. If they wish to amend it, it becomes effective upon a majority. The second part is that the sponsors need to formally consult us because we are financial policymakers. We are here to assess finances and determine whether or not it helps or hurts students
 - 2. We can vote to or not to recommend and then it will be presented to senate
 - iii. Apronti- Were they requesting it be raised or lowered?
 - 1. Salazar I've had people want to increase it. We are not taking a position on it right now, but I want to make sure we are ready if the time comes
 - iv. Howard They need to come to you with a bill? Does it go through rules?
 - 1. Salazar They would have to come to our board meeting and let us critique it. We decide whether or not to recommend. Either way, it gets kicked to senate.
 - v. Apronti If it fails us, it can still pass senate?
 - 1. Yes
 - vi. Howard Can you take me through that process?
 - 1. Salazar Ultimately only senate can raise or lower the fee. They need to consult with us first, because we know financial policy and look at things independently. There should be recommendations set in place
 - vii. Howard When does the university know?
 - 1. Salazar The latest they'd have to know is the first day of February because they need to implement the mass change over the summer. If they do it spring semester, it

doesn't make sense because there would be an enormous surplus of money and the budget would need to be reopened to allocate it

- viii. Howard Feb 1? We get back very late January, so this probably won't happen
 - 1. Salazar Yes, this is just as a precaution for the future. We want to prevent clashing in Senate over this issue. This should be treated like a budget thing because we are set to monitor finances within SA.

ix. Debate

- 1. Daquial I like the bill. I find it really weird that adding senators would have to go through a referendum.
 - a. Howard- You think it should be a referendum to raise a fee?
 - b. Daquial No, I just think that ideally it would be nice if there was a more of a safety net like this, making it harder to change the activity fee
- 2. Apronti There should be more steps in place to change the fee
- 3. Salazar I just want to share this This is from the last time they changed the fee in 2016. Written like a resolution. They justified it and then said what it could be increased to. This is why it is currently \$220 per year
- x. Apronti- The raise was \$20 dollars per year?
 - 1. Salazar Yes, and it generated \$130k
- xi. Daquial What is the SUNY cap on student activity fees?
 - 1. Salazar SUNY sets a cap at \$250 per year. Which would make it around \$125 per semester. Right now, it is \$110 per semester
- xii. Salazar Motion to call the question
