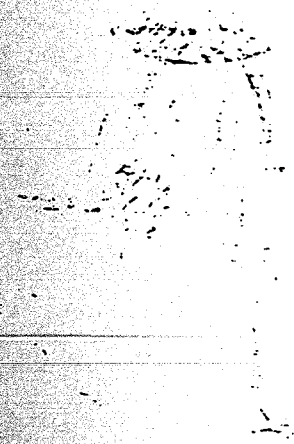
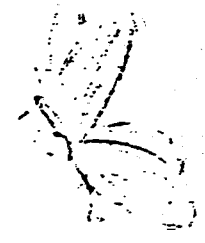
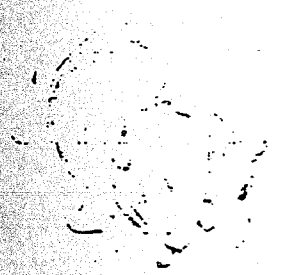

Dear Friends in Christ,

Our family would like to take this time to tell you of a very dear friend and brother-in-Christ of ours. You may be a friend that has already heard about Billy- if not let us share his story with you.

Ten years ago Billy Moore was put on death row in a Georgia prison. The crime he committed was murder. Instead of going into the details of this we would like to emphasize the miracle of salvation that he received through a loving and caring couple who brought him to Christ while waiting sentencing. Since his acceptance of our Lord and Savior, Billy has given his life, for however long that may be, to winning others to Christ. He has not only touched the lives of other prisoners by witnessing and sharing the Word, but has also carried on a beautiful and spirit-filled ministry through the mail to many who themselves may be free in the world but in prison spiritually.

We visited Billy this past December in the Georgia prison after knowing him for close to six months. What is so special about him is that although he is in what many would term an unendurable state of being, Billy does endure, though not for Billy, but for his and our Lord Jesus Christ! Praise God! Everyday that Billy lives is devoted to uplifting the name of his Savior.

"...naked, and you clothed Me; I was sick, and you visited Me; I was in prison and you came to Me" Matthew 25: 36

How ironic! Here in our own Warren County Jail, Billy visited a prisoner. On learning that a young local man was behind bars, Billy- through the mail- witnessed to him. When later we talked to the young man, he said he had received no visitors while in jail, but he had received a letter that impressed him, a letter that gave him a sense of hope and encouragement that no one else had offered him - the letter was from Billy, another 'prisoner' but a prisoner that somehow isn't in prison.

The second or third week of April Billy will be standing in front of the judge who sentenced him to death ten years ago. (Recently the Supreme Court refused to consider his case). It is our prayer that his death sentence will be changed to a life sentence. PLEASE pray with us, fervently, on this matter. Billy is not actively working on his case. His first priority is sharing the Word with others. Christ has taken first place in his life-not Billy.

We have set aside a date, April 11th, a day on which our family will fast and pray for Billy. Paul says in IThessalonians 5: 16, 17,

" Rejoice always; Pray without ceasing"

This is what we plan to do: We are going to praise the name of our Savior and rejoice and pray. Then we will give thanks to our Lord for the plan He has for Billy. We ask that you also lift Billy up in prayer everyday, but especially so on April 11th. "Truly I say to you, to the extent that you did it to one of these brothers of Mine, even the least of them, you did it to Me." Praise God!

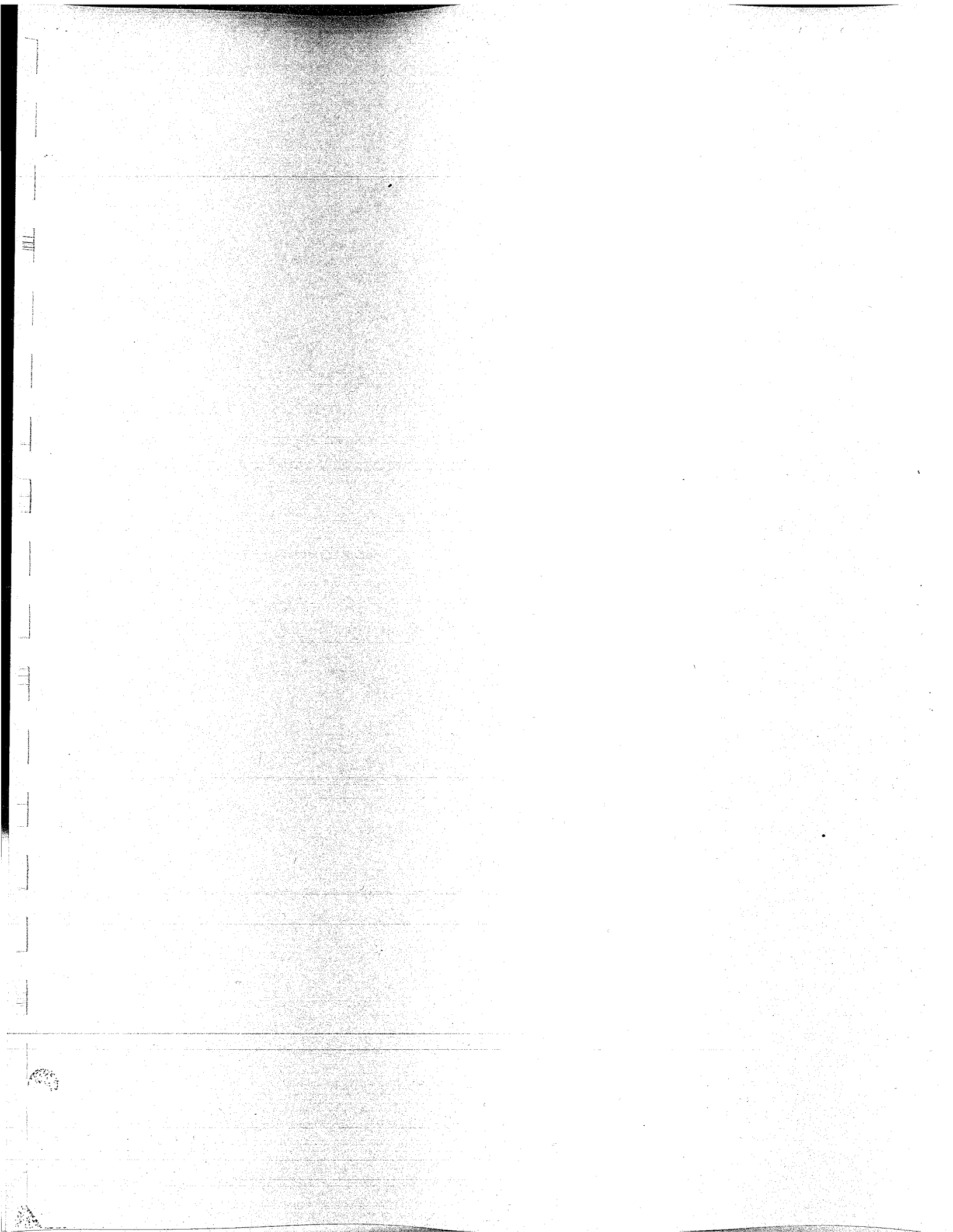
We were sorry the amendment didn't pass which would allow prayer back in schools. We believe there is power in prayer and that someday or someday we can have prayer back in schools.






Billy helped me to find myself. He was a positive influence on my life and I would not have made it without him. I know he has helped many other inmates in the same way.






