

Be it hereby proposed that the following be enacted:

- I. WHEREAS, The University at Albany uptown campus provides walkways, trails, and roads that accommodate all methods of travel for students; and
- II. WHEREAS, This creates multiple intersections and crossings around the campus; and
- III. WHEREAS, Students have reported that there have been on going issues with crosswalks, many experiencing dangerous situations over by an Empire Commons crosswalk; and
- IV. WHEREAS, The intersection where Excelsior Drive, University Drive West, and Colonial Drive meet has been an unsafe area of concern for students (see attached map for reference); and
- V. WHEREAS, There is currently stop signs in effect for vehicles coming from Excelsior Drive and drivers coming out of Colonial parking lot (see attached map for reference); and
- VI. WHEREAS, This area is highly trafficked by both vehicles and pedestrians; and
- VII. WHEREAS, It has been observed that drivers have not been following basic road laws which dictate they are required to yield for pedestrians crossing at any intersection; and
- VIII. WHEREAS, The safety of all UAlbany students is the Student Association's top priority; and
- IX. WHEREAS, The safety of all UAlbany students should be the University at Albany's top priority; and
- X. THEREFORE IT BE RESOLVED, That two new stop signs shall be placed at the intersection of Excelsior Drive, University Drive West, and Colonial Drive (see attached map for reference); and
- XI. THEREFORE IT BE FURTHER RESOLVED, That this intersection will be transformed into an all-way stop with proper labelling of all signage indicating thus; and
- XII. THEREFORE IT BE FURTHER RESOLVED, That the office of Campus Architecture, Engineering, and Construction Management and the office of Parking and Mass Transit complete construction in an effective and timely manner; and


