Ludlow Foundry Units Closed

The Ludlow Foundry's Troy and Cohoes Units were closed lown without notice to the workers on January 15; 1960.

On February 12th, 1960, a Mr. Daniel C. Richman who had purchased 66% of the stock, was given permission by Fed. Judge Foley to operate the Foundry.

On February 19, 1960, the IUE, IAM and Molders Union met with the Company's lawyer. The Unions were presented with a detailed list of Company demands which include: A 5c cut in pay, one less holiday, a piece work system at day rate wages, a 90-day moratorium on seniority, departmental seniority, rigid wash-up period limitation, elimination of night shift bonus and complete domination of the Unions by the Company.

The membership unanimously rejected the Company's demands. It is now reported that the Company is using supervision to operate the plant which may foment labor trouble.


