

# MINISTERS REPELL UE PLAY FOR RELIGIOUS DISSENTION

UE local 301, now certain of defeat at the hands of Schenectady's GE workers, turned last week to the ugly monster of religious hatred in a futile attempt to salvage its crumbling empire of corruption.

At a meeting requested by Leo Jandreau, UE-301 business agent, members of the Schenectady Ministerial Association heard Jandreau and Julius Emspak, UE national secretary-treasurer, attack the Catholic church, the CIO

and groups allied with IUE-CIO in the fight to rid labor of its communist parasites.

Emspak and Jandreau tried to smear the Catholic Church, and called upon the ministers to oppose what they termed the "Catholic control" of the CIO.

#### MEETING CALLED

The meeting place was UE headparters, 301 East Liberty Street. The time was 11:00 a.m. Monday, May 8. In attendance were 10 ministers, members of the association, Jandreau, Emspak, John Green and William Hodges.

Several ministers emerged from the meeting more convinced than ever that "Communism really is the issue."

Jandreau and Emspak specifically claimed that:

1. The Catholic church was interfering in union business:

2. The Catholic church controls the CIO, its top leaders and its national conventions. The basis for their claim was that "CIO conventions are opened with a prayer by bishops or priests." (Ministers and rabbis who participate every year in CIO conventions were conveniently overlooked by Jandreau and Emspak.)

#### LETTER READ

In a further attempt to arouse religious dissention, they read a letter sent by Bishop Gibbons to parishes in Herkimer County prior to the Ilion Remington-Rand election.


It was obvious to all of us that this an attempt to provoke Protestant feelings against Catholics, and against the Catholic church," one of the ministers stated later.

#### MINISTER REPLIES

Another minister responded to the reading of the Bishop's letter by point-

# IUE-CIO Deplores UE's Divide and Conquer Scheme

# WHO'S WHO IN UE

This is the eighth in a series of articles on the Communist leadership of UE. The material for these articles is taken from authentic government information.

#### WILLIAM SENTNER

One of the shining stars in UE's galaxy of Communist Party flunkies is Bill Sentner, former president of UE District Eight. At the time of the last CIO Convention, October 1949, Sentner was an organizer for the red-UE.

In July 1938 he was arrested in Newton, Iowa, for advocating criminal syndicalism. When arrested he openly admitted he was a staunch member of the Communist Party.

In September 1941 the "Daily Worker" reported that Bill was an ex - CP-organizer, member of the Central Committee, and assistant to Alfred Wagenkencht, former secretary of Missouri CP.

Sentner got out a letter to all St. Louis unions in 1943 praising William Z. Foster, then National CP Chairman.

1944-1945: He was an enrolled member of the CP North-Side Section, St. Louis.

1946-1947: Sentner was a first class citizen in the Weydemeyer Club of the CP.

He was a member of the St. Louis Central Committee of the CP, District Committee, and State Board of District 21. He regularly attended meetings of these groups, as well as section, general membership and special meetings.

### FBI ANSWERS IUE PLEA

J. Edgar Hoover, director of the Federal Bureau of Investigation, promised action on IUE-CIO's request that he look into Jandreau's communist record.

In a telegram dated May 6, Hoover confirmed the IUE-CIO wire, and assured that the matter would be given to the proper department for appropriate action.

The telegram read:

"Your telegram of May five, 1950 received. A copy has been made available to the Criminal Division of the Department of Justice for its appropriate consideration."



### UE Did It: Paid Holidays

THE IUE-CIO NEWS

A cartoon featured on the front page of "EU News" boasted about the great UE holiday pay.

Just for the heck of it take a close look at UE's so-called "paid holidays."
According to the agreement signed

with GE, three and one-half cents per hour is set aside from the "package pay increase" for paid holidays.

Take the case of a porter, for example. Every year he has \$72.80 clipped from his earnings. Last year this man, with an approximate rate of \$1.19 an hour, received \$19.04 cents worth of holiday pay. He contributed to the coffers of GE the remaining \$53.76.

Even in a year when all the holidays fall on a day recognized by UE and GE, this man will lose \$25.20 of his pay.

Yes, UE did it!

### YOUNG OR OLD; IUE-CIO HAS THE PLAN FOR YOU

The IUE-CIO, always out front with the economic answers, has scored another first in American industrial history by negotiating the famous Philco pension-severance plan. This is the plan that will serve as the IUE-CIO's model for negotiations with Westinghouse, General Electric and the other big electrical manufacturers.

Here's what a Philco pension plan will mean to you:

If you are an older employee, looking forward to retirement, the IUE-CIO plan will give you a minimum pension of \$100. per month. The best part is that the employer foots the whole bill,

and if any increases are made in government pension allowances the worker gets the whole gain.

#### \$100.00 PLUS

With the bill presently pending in Congress, you would receive better than \$125 per month. That spells security to many, many old timers. It means that workers can now retire with some feeling of independence. They know that the gas bill, the coal bill, the mortgage on their home, and many essentials of daily living will be taken care of.

Sure, IUE-CIO is fighting for biger and better pensions from the government, but it wants them added to employer paid pensions already in existence!

#### EARLY RETIREMENT

Do you want to retire at 60? IUE-CIO's plan will cover you there. You don't have to be 65 years old, with 25 years service to collect pensions under the IUE-CIO proposal. Workers 60 years old, with 25 years seniority, can get pension benefits figured on a proportionate basis.

For the "youngsters" who have pensions so far in the future that they don't even think about them, IUE-CIO again has the answer — termination pay.

#### TERMINATION PAY

You heard it right; employees at Philco, with two or more years service, have the company salting away five cents per hour in Government bonds—bonds made out in individual worker's name.

If you get laid off, quit, get fired, or et the employ of the company for any reason, the money is yours and only yours.

Young Joe Worker, low man on the seniority poll, won't have to sell his car because he owes one last payment. Mary Worker gets married and al-

ready has a nest egg to start off with, or the price of her wedding dress.

#### MARRIED MEN

The married men have a hunk of hard cash to fall back on as a supplement to Unemployment Insurance. That severance pay will buy a lot of groceries, pay a lot of bills and help a family thru many tight spots if unemployment strikes home.

And this same five cents per hour serves as death insurance. Should the worker die, his wife and family will not be left penniless—not with an IUE-CIO pension-severance plan. His widow, or children, get all the accumulated severance pay in Government bonds.

If a worker puts in the usual average of 2,000 hours per year he will have a termination pay nest egg of \$1,300.00 at the end of 10 years.

Remember, none of this costs the worker one red cent of his own money.

Whether young or old, married or single, IUE-CIO has the plan for you, you and you.

### Welders' Grievance Won By IUE-CIO

After two and one-half years of stalling; after permitting IUE-CIO members to carry the ball; and after issuing one sad excuse after another, UE now has the affrontery to claim credit for the welders' rate increase in Bldg. 273.

Here is what really happened on the welders' grievance:

Over two and one-half years ago a grievance was filed by welders Edward J. Blank and Alex Rozek, in Bldg. 60, to have the top job rate in the miscellaneous section raised from \$1.51 to \$1.62 per hour.

Because of UE laxity in policing the contract welders in different parts of the shop, had varying top rates. There was no attempt at equalization.

Meanwhile, the misc. group was moved from Bldg. 60 to Bldg. 273, and the grievance still was not settled. It was cornered in the UE upper areas.

Bill Kelly, UE - 301 president, told the stewards that their grievance was within the contract; in fact, he told them they should have 5c more per hour, because they were required to read prints. Neither Kelly nor anyone else in UE took any action.

The grievance was alternately handled by Larry Flagnan, Charles Lewis and John Warren, now all IUE-CIO men. The only thing UE stewards had to do was go in and hear that the company had agreed to the increase. Due to the efforts of this IUE group, the first raise of 5½ cents was won nearly a year ago.

The real groundwork was laid by IUE-CIO stewards, and the battle to bring the grievance to top manage-


James Goldsberry said:

# Left To Center Backs E. Miller IN DESPERATE ATTEMPT TO RECOUP HEAVY LOSSES IN MEMBERSHIP

SCHENECTADY, May 20—Appearance Wednesday in the GE Schenectady Works of a leaflet signed by a "Center Committee" caused renewed talk of a deep rift in the forces of the Left-wing UE.

UE, in a desperate effort to retain control of bargaining rights in the plant, apparently has dumped Leo Jandreau. The Center Committee leaflet, signed by E. Miller, allegedly comes from the office of Victor Pasche, not an elected representative of the workers here, but an appointee of Jim Matles, himself. It is believed that Pasche is now supporting Miller as leader of the local, instead of Jandreau, who seems to have dropped completely from the scene.

This incident also caused talk of another deep split... this time between UE President William Kelly and Pasche, who allegedly controls all local affairs, even though he was never elected by the membership. Pasche is, or was until recently, on the local payroll.

UE members themselves are spreading the rumor that Jandreau, after the expected victory of IUE-CIO on May 25, will be given a job in GE.

The tremendous trend toward IUE-CIO on the part of GE Schenectady workers is considered responsible for the battle being waged within the UE, GE workers are saying.

### \$100-Cash Award-\$100

THIS SUM will be paid to all G. E. workers in the Schenectady works and area who can prove that they were ever told how to "think and talk" or "vote and worship" and were forced to do so by U.E. officials and members.

THE CAREY-KRISS CLICQUE claims that the U.E. officials were leading the union members to evil and doom "By INTIMIDATION or INFLUENCE, because the majority of G.E. Workers were either scared or stupid.

THE CAREY-KRISS CLICQUE boasts much about their patriotism, wisdom, godliness and super-ability, but underestimate the intelligence and patience of the G.E. workers with such self-praise.

DOES THE CAREY-KRISS CLICQUE hope or imagine and believe that G. E. workers have short memories or could ever forget that the G.E. Big Shot Misers did not give wage increases and other benefits long ago only because "Carey's Conspiracy and Rebellion" made it possible and easy for the G.E.
