In 2018, the School of Education proposed and secured campus endorsement for three BS/MS "programs," coupling the B.S. in Human Development with M.S. programs as follows:

- 1. Special Education and Literacy II (certification qualifying)
- 2. Mental Health Counseling (licensure qualifying)
- 3. Educational Psychology and Methodology

All three of the proposals were approved on campus and sent to SUNY for further review. Two of the three proposals were subsequently withdrawn from SUNY review when we were advised that SUNY/NYSED review and approval was not required. The third and final proposal has now been resolved (confirmation below) in the same manner, after SUNY consultation with NYSED. UAlbany and the School of Ed are authorized, therefore, to implement all three of the combined BS/MS program pathways listed above.

The proposals as originally submitted in April 2018 are attached for your reference.
