Make-Believe Democracy

The convention was made up to a great extent of self-appointed "delegates" of rump groups. It showed its "Imitation UE" character by trying to copy UE in claiming to fight for better wages and working conditions and for democracy, but everything else about the convention showed the phony "ersatz" character of the the IUE's colective bargaining demands and "democracy."

Red-baiting was the note through the convention, and the reliance of the outfit will be redbaiting and the hope of favors from politicians and employers.

Carey complained that some employers were not giving him enough help, because they are not yet ready to disregard binding contracts and take on fights with the workers. He demanded that the employers show "the same kind of patriotism" as himself in fighting UE members.

Politicians and 'Labor Statesmen' conventions, outside speakers are the rare exception and the delegates have the floor. The "Imitation UE" convention listened to four speakers from or close to the federal administration.

A fifth, Secretary of the Navy Francis P. Mathews, missed the meeting because fog kept his plane in Washington. There also were several speeches by "labor statesmen," all from unions that have given up any idea of wage increases for either 1949 or 1950.

Carey ran the convention from the platform with a heavy hand, making concessions once in a while to "delegates" who complained that some of the actions would not look good to the people back home. Carey was backed all-out in a speech by Philip Murray, who virtually demanded that the convention accept Carey's dictation.


Because of the repeated protests of "delegates" on how things would look back home, a proposed provisional constitution was changed to make it look democratic. It is meaningless because there is to be no election of ofticers now. Carey and his "administrative committee" are in full control.

Any reference to officers' salaries was left out of the provisional constitution, because "delegates" expressed fear that a proposed \$9,500 salary for president would look bad by comparison with the UE's \$7,500 salary. Carey himself is paid \$10,000 a year as CIO secretary-treasurer.

The Local 301 membership scored a partial victory in its dealings with GE last week when A. C. Stevens, assistant to the Works Manager, backed down on the company's refusal to recognize changes in union shop stewards and board members in accordance with the contract.

Works Manager Lewis J. Male had ordered supervision to continue to recognize a former board member who had taken a public stand with the "Imitation UE." There was widespread membership protest against this open attempt to establish a company union and Wednesday of last week members met in groups all over the plant at lunch hour and demanded that the company abide by the contract. The next day Stevens notified the union that changes in representation would be recognized as in the past.

Dermody's Charges

After GE tried to scrap further negotiating of contract improve ments, International Representative Joseph Dermody, in a letter to the company, charged GE with:

1. Wanting as always "to save money at the expense of its employees, while handing out extra dividends to stockholders of enormous profits." 2. "Hoping to give underhanded

assistance to the efforts of the CIO officialdom to capture GE employees, in the knowledge that the crew fronting for Murray Reuther and Rieve would sacrifice the wages, seniority and other conditions of GE workers, as their snonsors sacrificed the interests of the workers in the Steel, Auto and Textile industries."

GE Plans Downgrading Of Boring Mill Work

Works Manager Lewis J. Male committee that the company intended to go ahead with its plan to downgrade part of the boring mill work. The action came a week after a splitting drive by "Imitation UE" forces among the big boring mill operators on the first

The downgrading plan came up months ago, but had been held up by Male for further study, because of union opposition. The move affects principally the big boring mill group, which has a single timing rate of \$1.45 an hour.
