Dear Sir:-

Representing the General Hospital Board of Virginia, I have in charge a test case under the Virginia Eugenical Sterilization statute approved March 20th, 1924. (Acts of Assembly 1924, page 569), with which you may be somewhat familiar, as I recall that Dr. Arthur H. Estabrook from your office made some inquiries about this act in my office some weeks ago.

The first trial of the case will probably be in the Circuit Court at Amherst. Va., about the middle of October. Whichever way that Court may determine the case it will be taken to the Supreme Court of Appeals of Virginia. If the Act be sustained by this our highest court, it will then be taken to the Supreme Court of the United States as the Hospital Board is unwilling to proceed under the Act until it shall be sustained by the highest court, which, of course, is the Supreme Court of the United States, because of the alleged rights under the Federal Constitution involved.

Both in the preparation of the statute and in preparation for the trial of this case we have found your book on "Eugenical Sterilization in the United States", published by the Physchopathic Laboratory of the Municipal Court of Chicago in December, 1922, very helpful and it has occurred to us that perhaps because of your interest in the subject you might be willing to assist us in making up a proper record for the test case.

This case as it has so far been made up involves a feeble-minded young woman nineteen years of age, who together with her mother, who is also feeble-minded, is an immate of the State Colony for the Feeble-Minded, and the young woman is herself the mother of a feeble-minded child. What I should like to get, if possible, would be a deposition of some authority

who has made a study of the hereditary considerations involved in such cases so that we might get into the record testimony from the most approved sources tending to support the theory of such laws by showing if we can that such a patient is the probable potential parent of defective offspring and that considerations both of public welfare and of the welfare of the individual patient counsel the performance of the operation in view.

some one else well qualified and willing to do so? If so, I think we could arrange simply to forward agreed interrogatories to which the person testifying could make such written answers under oath as appear to him proper. But to have the matter in place at the trial will require some expedition, and if the suggestion appeals to your interest I would very much appreciate hearing from you just as soon as convenient.

Also if you have knowledge of any later cases in point, decided by the courts after those cited in your book, I would appreciate receiving a reference to them.

My dear Dr. Estabrook: -

Your letter of the 3rd inst. saying that you could come to Amherst for the trial of the Carrie Buck case on the 18th inst. for the payment of your expenses and a per diem of \$20.00 per day while in attendance in court reached me this morning after I had written Dr. Laughlin on yesterday seeking to confirm your present address.

I am glad to hear from you and to know that you can assist us in this matter.

As you will note from my letter to Dr. Laughlin, a copy of which I sent you, we should be glad to have you come on two or three days in advance of the 18th to make some preliminary investigations for us at Charlottesville, Va., Carrie Buck's home, which you had previously offered to do but which I thought then could be satisfactorily done by Miss Duke and other social workers there who were assisting us in the matter. However, the information obtained by Miss Duke was not as full as we had hoped to get and I think it not unlikely that you in co-operation with her and others there might be able to run down some additional pertinent facts, as we wish to present in this test case as strong a showing of facts as possible, both for the trial court and for the appellate courts, as we shall not have another opportunity to get the facts in the record upon which this case must be tried.
