RED FACES IN STEAM TURBINE

G.E. has been harping continuously about the disastrous effects that can befall American Industry due to foreign competition. They particularly stress the Electrical Industry.

Apparently they do not practice what they preach!

Recently an Electrician in Large Steam Turbine Department, #273, had occasion to replace an electronic tube in a test equipment. The original was a G.E. tube. The Electrician noted with amazement that the container holding the new tube was made and printed in Holland. The tube itself was made in France.

Vice-President Bill Kelly brought the incident to the attention of Union Relations officials in Steam Turbine. He asked for an explanation as to why a G.E. tube was replaced by one made in France. This they were unable to do. However, they said that an investigation would be made. The answer should be of interest to everyone!

JOB RECALL INFORMATION

In reply to a query from Union Headquarters, the Company stated that there are between 400 and 500 people who still have recall rights in the plant.

When asked how they would call back the people without recall rights who had been out less than three years and who could get their service back by being rehired, the Company stated that they would rehire generally by service but only on a selective basis.

When asked what this meant, they said that they were reserving the right to weed out any employees who, in their opinion, had bad work records.

The union representative closed the conversation by predicting that if much weeding out was done, there would be some real hot arguments with the Company in the future.
