## IV. Comptroller's Report

- 1. Tony Kelley, Comptroller
  - i. I did implement our new credit card process
    - 1. Student group puts in request
    - 2. Credit card authorization is put in
    - 3. I will authorize first
    - 4. Pam or MJ will authorize
    - 5. After both of us authorize, then I will purchase it. When we do it this way, the approved amount will be the exact

amount. When we get statements, the reconciliations will take a day. It speeds up the process tremendously. The campus designee authorized everything on there so the Board of Finance will likely have less questions. I want this to be part of SAFRA. We need FL things in the bylaws.

- ii. The audit is going really well. The directors and officers were off, but it will be fixed. Shannon sent them the updated list.
  - 1. There were a couple discrepancies in the numbers. The main thing I'm trying to figure out is dippikill tax numbers. I am trying to break it down.
  - 2. The tax returns will be impacted by the impeachment because of the signature at the end. We would have to change the name at the bottom, but it shouldn't be too big of a deal
- iii. Salazar Does Shannon have my Senate list from last year?1. Comptroller Yes.
- iv. Salazar In terms of the bylaw overhaul, I will finish it. It's just the numbers that are getting to me. Having to change the number of the bylaw is difficult. The credit card policy is included.

### V. Senate Report

- 1. Sabra Simon, Chair of the Appropriations Committee
  - i. We've seen Sigma Gamma Rho, PP Gen, WCDB. In total, I believe it is around 4k that we approved
- 2. Kelley Why did SGR cut the flights?
  - i. When they first came, we had to table the bill because they didn't have significant documents to show that they needed to go to this conference. They came with the document. They said they would be derecognized if they did not go to the conference. The committee felt that since they didn't budget properly it would be okay to cut the flights and just pay for the 6 person at 660 per person. Hotel was around 300 per person. Since they didn't come in a timely manner or bring documents we cut the flights.
- 3. Kelley When that goes to senate would that be something that the VP has to sign instead of the president?
  - i. Salazar In my opinion, it's an interesting because of the possible conflict of interest. Since the bill needs 2/3, maybe

Nick can have the bill sit for 6 days so it automatically becomes law

- 4. Kelley Do you know why I asked that?
  - i. Salazar -Yes.
- 5. Simon Did former President Langie Cadesca sign any bills for the Zetas?
  - Salazar You'd have to give me a few minutes to look back for that
- 6. Simon For the appropriations from last week, would it be possible for new format
  - i. Salazar -Ever since I sent it to Nick's computer the format looks off for some reason
- 7. Simon Zeta Phi Beta did ask for things last year.
  - i. Salazar Let me find the emails from last year. When was it?
    - 1. Simon The first semester
    - 2. Salazar I can't find it right now but we would have to talk to Nick about that.

### VI. Budgetary Business

- 1. Myinvolvement update
  - i. I extended the deadline to Friday since we have been super busy. We are at 55 submissions, last year it was 93. I also have the Comptroller applications up.
  - ii. Comptroller I only need 1 deputy comptroller and 4 assistants. I was thinking a deputy comptroller can have signatory up to expenditures up to a certain amount.
