## CSEA Lashes Out Against Union's Radio, T.V. 'Attacks & Lies'

(Special To The Leader)

ALBANY — The Civil Service Employees Assn. last week cautioned personnel at State correction institutions against what it termed inflammatory radio and television broadcasts beamed in their direction by a smaller, rival labor organization.

CSEA did not identify the union by name, noting that this was unnecessary since any public employees hearing the broadcasts should readily recognize "the same old tired party line."

"Only the medium has changed," a CSEA spokesman said. "What this irresponsible group used to circulate through printed material, they now attempt to voice in an inarticulate manner on the air."

CSEA said the union appeared to be concentrating its broadcast activities in the Catskills, where several well-known correction institutions are located.

### Message Gist

The gist of the union's message, according to the Employees Association, is twofold. "They divide their time pretty equally between attacks on CSEA and an all-out effort to stir up resentment among correction officers against their employers for various alleged atrocities."

"They talk in loud, gutsy language," the spokesman said, "like using the word 'strike' every few sentences. But when it comes to suggesting any more positive remedies, they lapse into evasive generalities."

The Employees Association emphasized its own concern over the numerous inequities in work conditions which persist among correction institution personnel. "No one is more familiar with the correction officers' problem

than CSEA", the spokesman said, "certainly not this inexperienced union that just came on the scene."

CSEA, he pointed out, has been fighting and resolving those problems for many years. "This is written on the record, and it is agreed to generally among both the correction officers themselves and the State officials. Ask this out-of-state union where it was all those years — and that's the answer right there. It was out of state, not knowing or doing anything about correction officers," the spokesman added.

While CSEA expressed the conviction that the union's broadcast campaign was received by most correction officers as "a lie in the wilderness," it acknowledged the potential of the "big lie" technique in swaying an ever-present, gullible minority into disruptive action which might hinder effective representation for the "thinking" majority.

CSEA predicted an end to the union's broadcast activities in the

## Representation Election Set CSEA Cites Proud Record Of Accomplishments For Troopers Over The Years

ALBANY — The Civil Service Employees Assn. has expressed confidence that members of the State Police will select CSEA as their bargaining agent in elections, called by the Public Employees Relations Board, to be conducted within the next several weeks.

"It's plain and simple," said CSEA President Dr. Theodore C. Wenzl. "We have the most to offer out of the contenders." The CSEA leader went on

to note that troopers have received pay raises and retirement benefits down through the years as the result of CSEA efforts.

"Before the Taylor Law, we negotiated on a de-facto basis and won many wage increases and concrete benefits for the State workers," he said. "These same benefits were also accorded to members of the State Police at our urging."

Dr. Wenzl pointed out that the recent record-breaking ten percent cross-the-board pay raise negotiated by CSEA for most State workers was also given to State Police members — at CSEA's request. Further commenting, the CSEA chief said: "It is safe to say that no other employee organization except CSEA has won any significant improvements for troopers."

"Unfortunately," said Dr. Wenzl, "the Governor chose not to ap-

prove the 20-year retirement bill for State Police this year because of what he called deficiencies. We don't agree with his reasoning, but in any event, we plan to again sponsor this legislation next year and push for the same effective date — April 1, 1969. In his disapproval message, Rockefeller said he would support a 'properly-drawn' 20-year plan for State Police next year. We intend to take him up on this," Wenzl declared.

### Unit Changes

As a result of appeals filed by CSEA and other interested parties, PERB recently changed its original designation of bargaining units by establishing two instead of three units. The main unit will now include troopers, corporals, sergeants, investigators, senior investigators, and investigative specialists of the BCI, while the other unit would consist of lieutenants, captains and majors.

PERB in its most recent determination excluded the officers from the main unit and gave them the choice of having no representation or of forming their own unit and selecting either CSEA or the Police Benevolent Association — State Police, the only contenders, as their bargaining

## CSEA's '68 Legislative Program Makes Gains For Civil Service

(Special To The Leader)

ALBANY — The Civil Service Employees Assn. has announced that its 1968 legislative program has resulted in the passage of several laws of vital interest to public employees in the State.

Major gains were attained in record breaking CSEA negotiations on behalf of most State employees. Those points won included a 10 percent salary increase, with a \$600 minimum. For those in lower grades, this raise amounted to from 14-18 percent. The other portion of the \$101,000,000 package provides for a guaranteed retirement allowance of 1/60th final average salary for each year's service, with half-pay after 30 years. This measure included provision for adoption by local government units.

CSEA sponsored or supported additional legislation to bring about the inclusion of employees of Health Research, Inc. in the New York State Employees Retirement System, a final average salary based on three highest years for members of the Police and Firemen's retirement system including State Police, extension of supplemental pensions for retirees, continuation of the \$2,000 survivor's benefit for State employees, and the extension of provisions relating to ordinary death benefits, disability retirements, and veterans benefits.

As a result of other laws, strongly supported by CSEA, institutional teachers under the jurisdiction of the Narcotics Addiction Control Commission gained equality with other institutional teachers in the State, while sheriffs and their deputies were brought into a 25-year retirement plan.

Several measures, although passed by the Legislature, were vetoed by the Governor. The major defeat concerned a joint CSEA-PBA measure to provide a 20-year retirement plan for members of the State Police. CSEA has promised to introduce a similar bill in the next Legislative session.

The Governor also rejected measures aimed at providing waivers for local employees not wishing to participate in the Retirement System; providing bridge toll allowances for non-resident employees of Manhattan State hospital, despite CSEA dispositions that most of the employees involved earned too little for this added burden; providing full pay to members of the Regional State Park Police who are injured in the line of duty; providing for the employment of retirees in public service; providing retirement credit of up to five years for veterans of World War II and the Korean Conflict; and providing service credit upon transfer between retirement system.

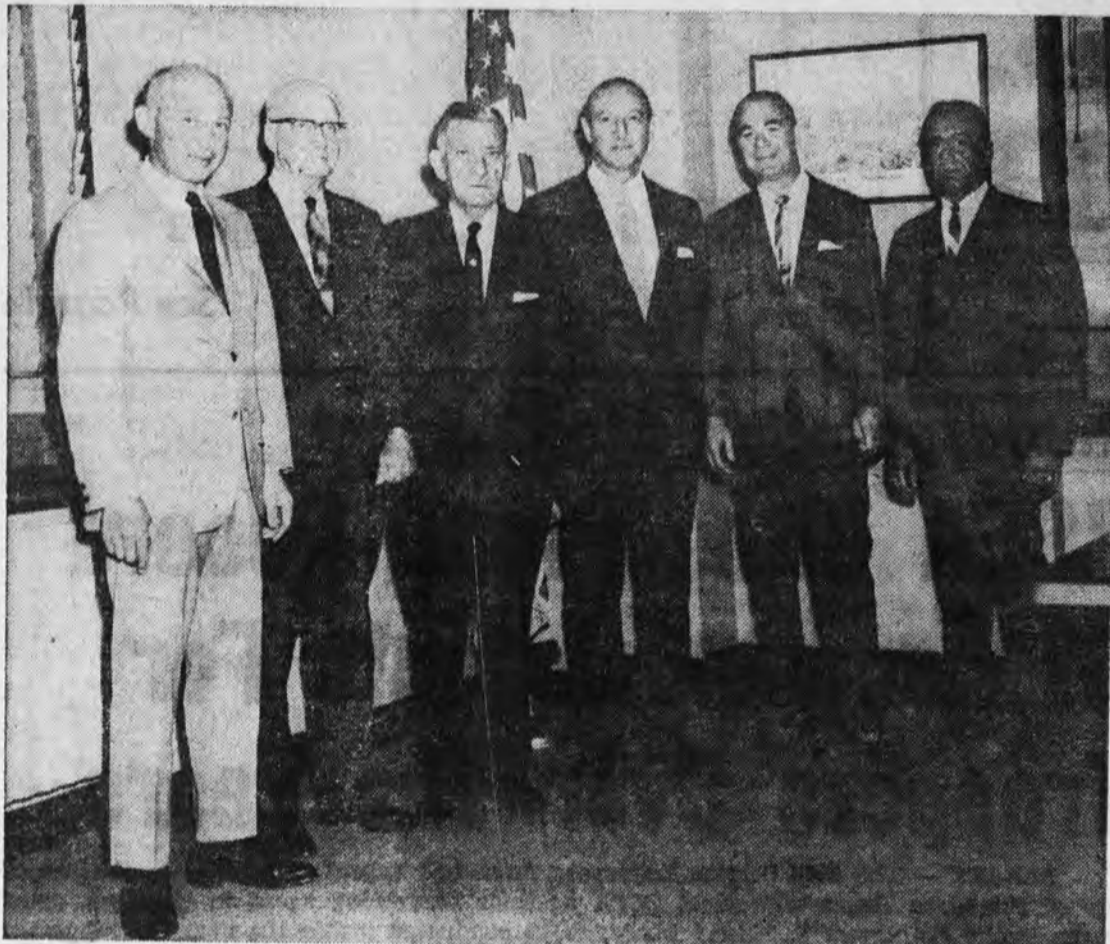

**Your Public Relations IQ**

**Serious Damage**

SERIOUS DAMAGE was inflicted on the good public relations of the civil service corps by the disgraceful violence outside New York's City Hall by 1,500 youngsters two weeks ago.

LOOTING, vandalism, missile-throwing and robbing a defenseless 50-year old woman civil servant were the methods these young hoodlums employed to protest cutbacks in the summer job program financed jointly by the City and the Federal government.

THE DAMAGE done to civil service stemmed principally from the leader of the protest demonstration—a City employee. He is Willie J. Smith, director of the City's Neighborhood Youth Corps, who told newspapermen:

"VIOLENCE—that's the only thing this city understands."

THIS DECLARATION was made by Smith after the violence, the principal victims of which were several blind newsstand operators and itinerant hot dog purveyors.

THE SIGHT of a City employee leading a demonstration against the City which deteriorated into violence dealt a serious blow to civil service. Smith was asked by reporters:

"DON'T YOU think you take too many chances—a City employee leading demonstrations against the City?"

TO WHICH he replied: "No, I just believe in what I am doing."

WE'RE AFRAID that Mr. Smith, whose reputation otherwise

is that of a highly intelligent, articulate leader, is completely misreading all the dials on the indicator board of the social revolution control center.

FOR EXAMPLE, he lost the sympathy of the most potent single group in government—the civil service corps. The overwhelming majority of these dedicated public employees are doing everything possible to better the lot of the have-nots.

BUT WHEN these knowledgeable people see with their own eyes destruction just for the sake of destruction, they are keenly aware of a threat—a threat to the stability of government and therefore a threat to their jobs.

A PEACEFUL demonstration of 1,500 determined, serious and well-behaved young people would have strengthened the sympathy and cooperation of the civil service corps. Instead, the civil service corps was lost—perhaps irretrievably.

ANOTHER EXAMPLE of how the dials on the indicator board are being misread is the series of recent experiences of civil service firefighters in New York City. These badly overworked firemen have had to contend with barrages of rocks, bricks and bottles while fighting fires in the City's poorer neighborhoods.

# Funeral Rites Held For Edward D. Meacham; Civil Service Official

ALBANY — Funeral services were held recently for Edward D. Meacham, director of personnel services for the State Department of Civil Service, and widely known in public employee circles.

Mr. Meacham, 56, died after a brief illness at St. Peter's Hospital here.

Prior to his illness, he participated as a department representative in negotiations between the State and the Civil Service Employees Assn. CSEA officials were in contact with Meacham down through the years concerning personnel matters involving State employees.

Mr. Meacham was a veteran of 31 years' State service, 19 of which were spent with the Department of Civil Service.

A former administrative assistant to the State Commerce Commissioner, he began his career with the Civil Service Department as a senior classification examiner.

Former Governor Averell Harriman appointed him chairman of

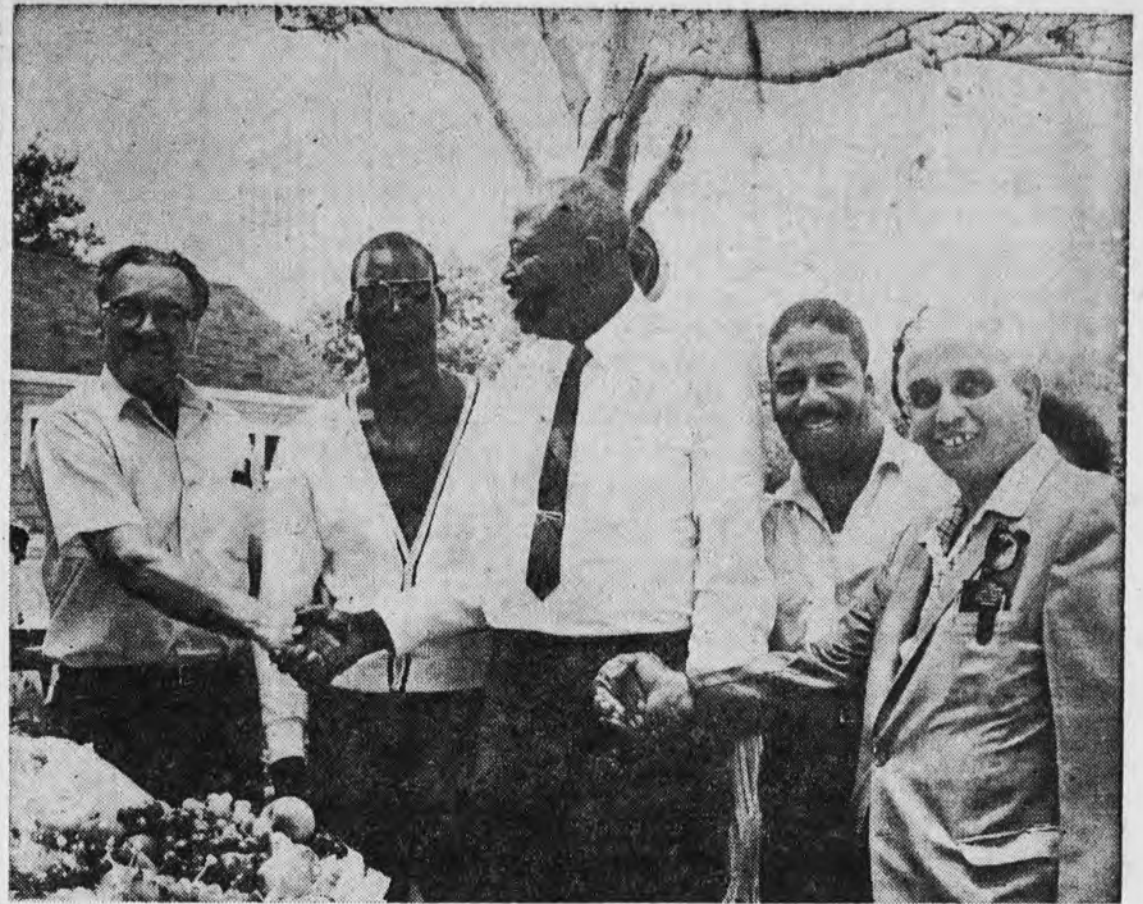
the State Grievance Board in 1955. In 1957 Meacham received the Alfred B. Smith Award from the Capital District chapter of the American Society for Public Administration, for his outstanding service in public administration.

He also was active in local civic and religious affairs.

# Broome Chapter Asks For Closed Bargaining Sessions; Retroactive 1/60 Retirement Tops Demands

(From Leader Correspondent)

BINGHAMTON—The Broome chapter of the Civil Service Employees Assn. has opened its campaign for a 1969 contract with a demand for closed-door bargaining sessions.

There are signs the CSEA demand will be granted.

John E. Herrick, president of the chapter that represents most of Broome's 1,200

employees, said a proposed contract is being prepared by chapter officials for presentation to a county negotiating team later this month.

The only CSEA demand made public so far is that Broome County take advantage of State enabling legislation making the 1/60th retirement plan retroactive to 1938.

That benefit already has been extended to State employees, Herrick pointed out.

If granted, it would mean that a Broome worker who joined the county in 1938 or before could retire now at half pay.

Last year, at the urging of CSEA, Broome approved the 1/60th plan for its workers. But it was not retroactive beyond 1960.



## Responsibility

NEW York City's civil service corps of men who perform the man-in-the-street type duties, such as policemen, firemen, water supply inspectors and sanitationmen, is facing a growing number of attacks each day from a small lawless element in ghetto areas.

These dedicated men are in these areas to perform a duty which protects the ghetto residents. They do not like conditions in these areas any more than the residents. They must fight fires in dilapidated tenements with stairs ready to collapse any minute as flames lick at already-weakened supports. Policemen must be ever on alert, as criminals seem to prey on residents of these areas more often than on those in middle class areas.

Sanitationmen are forced, daily, to clean up overfull refuse cans or those overturned by rowdy children and teenagers so that filth and disease will not spread through hot, stuffy tenements. Water supply inspectors are in these areas to check static pressure to assure residents that an adequate supply of water is available for drinking, cleaning and fire-fighting purposes.

Yet, these men suffer a constant barrage of bricks, garbage and even gasoline bombs. They are not responsible for the social conditions which exist in these areas. Moreover, they do the job because of personal dedication to the principles of alleviating these conditions.

Three years ago, Fireman Lawrence Duenas, while working in Harlem, rescued a family trapped on the top floor of a tenement and ready to jump from the window to certain death six floors below. Despite the terrible personal risk, he made his way to the family, calmed them and removed them to safety. He received several neighborhood citations for his work. He also received the James Gordon Bennett Award from the Fire Department—the highest award in the service—comparable to the Congressional Medal of Honor.

Last week, Duenas was one of the many firefighters seriously injured by the brick throwers.

It is up to the City Administration to start taking positive action against those who would take out their frustrations on the civil service corps. Responsible leaders of the ghetto community should be contacted and a grass roots program of support inaugurated for the civil servant.

Prejudice is unknown in civil service operation.

The only thing a prospective civil service employee is asked is: "Can you do the job?" These men live, work and, yes, even die together. They are responsible for the community's safety.

The community is responsible for theirs.

## Mr. Wyman Persists

STATE Social Service Commissioner George K. Wyman is persisting in moving the State Commission for The Blind offices from New York City to Albany despite the protests of many private agencies connected with the work of the Commission.

To date, the Social Services Department has shown no real benefit to be gained by the visually handicapped by such a move. Supposedly, the act is being done in the name of "reorganization," but there has been no explanation in depth of just what the value of the reorganization will be. In addition, there is no evident concern for the future of the employees of the agency, who have served the visually handicapped long and well.

Once again we urge Governor Rockefeller's personal intervention in this matter to insure that the well-being of these disabled citizens has the first priority.

### Hospital Problems

Editor, The Leader:

The freeze may have been lifted, but things are in a turmoil here at Buffalo State Hospital.

More patients and extra beds are being put on already-overcrowded wards, with no extra help (attendants) in sight. Employees are complaining of being overworked. Some call in sick. Perfectly clean wards are being closed after the State spent money having them painted and fixed up. Does not this overcrowding pose a hazard, especially when each building is supposed to have a specified number of patients?

Employees are disgruntled because of all the changes, and also because staff attendants and seniors are being pulled off the wards and being made to work in offices, and to replace supervisors for eight-hour shifts. This has caused a hardship on the wards for both attendants and patients, since sometimes one employee is left alone to care for an entire ward on which some patients need constant supervision.

The newest thing is that employees are being made to change from uniforms to their street clothes. Most of us cannot afford to throw these uniforms aside and buy other clothes. This would increase our laundry bills, since the laundry at the hospital washes the uniforms free. Most of us also do not think this would be very sanitary.

Does all this have to be because of the cutting of the budget? Just how far do they intend to push us?

## Civil Service Law & You

By WILLIAM GOFFEN



### First Constitutional Case

IT IS NOT often that a civil service examination is protested on Constitutional grounds. The usual basis of protest is that the candidate's answers cover the same material as the official answers, or that he made correct points for which he should have received credit although they were not part of the official answers.

IN MATTER OF LIPSON (New York Law Journal, June 17, 1968, page 17), the petitioner failed an examination for Chairman of Department of Music in the Junior High School of New York City. She contended that the examiner who rated her on class teaching was not qualified to evaluate a lesson in choral music. On the other hand, the Board of Examiners contended that he was an expert in both orchestral and vocal music. While an issue of fact was thereby apparently raised, Justice Charles J. Beckinella who wrote a learned, informative opinion, noted that the Education Law makes the administration of examinations the responsibility of the Board of Examiners. In the Jurist's view, if the Court had authority to weigh the qualifications of examiners, "this Court would be swamped by proceedings brought by failing candidates who fancied that their failures lay not in themselves but in the poor qualifications of their examiners." However, a just cause ought to be judicially entertained even if it may encourage similarly aggrieved persons to bring suit, a consequence that should not cause the court to flinch.

MUCH OF THE petition consisted of the petitioner's rebuttal of the Board of Examiners' Summary Statement of Reasons for her failure. Such Summary Statement of Reasons is routinely supplied to a candidate requesting it. Sometimes, unfortunately, it is written in such general terms as to fail to indicate the reasons for failure. However, in the Lipson case, the Summary Statement was clear and explicit. For example, the statement under "III. Teaching" stated, "Use of singing voice. The applicant did not sing for the group and, when the group sang, her contributions, if any, were inaudible. Use of piano. Although the applicant's piano playing was adequate, she seldom looked up from the piano. She actually said, at the end of the lesson, 'I cannot conduct when I'm playing the piano.' Results—quality. Although the group did manage to run through the selection once, there was no evidence of understanding the emotional impact that this selection should provide. The feeling of this selection was never created, and, indeed, never mentioned during the lesson."

WHILE THE PETITIONER argued that the examination did not meet the requirement that civil service examinations be subject to objective rating, Justice Beckinella noted that the test was of a nature that does not lend itself to wholly objective rating and that subjective standards must be permitted.

PETITIONER'S MOST interesting complaint was the novel one that her examination violated the Establishment Clause of the First Amendment of the Bill of Rights which declares that "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof . . ." The test required petitioner to teach the composition, "Jesu, Joy of Man's Desiring" by Johann Sebastian Bach. Petitioner based her argument upon the well-known United States Supreme Court decisions in Engel v. Vitale and Abington School District v. Schempp. The Engel case, of course, invalidated the practice of reciting a prayer composed by the New York State Board of Regents at the beginning of the school day. The prayer read:

Almighty God, we acknowledge our dependence upon Thee, and we beg Thy blessings upon us, our parents, our teachers and our country.

PARENTS OF TEN pupils challenged the constitutionality of a New York State Law authorizing the use of prayer in public schools and a regulation of the Board of Education of Union Free School District No. 9, New Hyde Park, New York, ordering the recitation of the prayer.

THE ABINGTON School District decision disposed of two related cases. One arose in Pennsylvania and was initiated by the Schempp family, members of the Unitarian faith, to enjoin enforcement of a statute requiring the recitation of

# Stein Urges Governor To Call Special Session Of State Legislature

Andrew Stein, the Democratic and Liberal Party candidate for the State Assembly from the 62nd Assembly District, delivered to Governor Rockefeller's New York City office over 25,000 petition signatures urging the sponsorship of vitally-needed gun control legislation.

In presenting the petitions to the Governor's representative, Stein urged a special session of the legislature in order to bring about prompt action in this highly critical area. Stein, explaining the reason for his signature drive, stated, "The tragic use of violence, which culminated in the assassinations of Dr. Martin Luther King and Senator Robert F. Kennedy, once again makes it painfully evident that this country needs immediate and effective legislation to control the sale and possession of firearms."

"We should not be interested," Stein added, "in the sponsorship of a 'token' statute which appears, but in fact fails, to restrict ownership of guns to those who are mentally and socially capable of using firearms with intelligence and responsibility."

Stein is also working in conjunction with Col. John Glenn's National Emergency Committee for Gun Control in bringing to the attention of the public the urgent necessity for a federal statute for effective and meaningful gun control.

In addition, Stein is a member of the New York Citizen Committee for Gun Control Laws, an organization which was created by Queens Assemblyman Leonard Stavisky. The New York Citizens Committee is attempting to implement on the State level the proposals and suggestions offered by community leaders active in this extremely important area.

Adopting a constitution and by-laws, representatives of the department last week scheduled a mass meeting within three weeks for election of officers. The new unit aims to deal directly with

victory much closer to home—control of the State Assembly in this Fall's balloting.

Joseph Bruno of Glen Falls, president of the Young Republicans told this column last week that after long thinking and analysis, his group felt the most effective job they could do for the State GOP would be to concentrate on picking up the six extra Republican seats needed to regain Assembly control and, at the same time, getting GOP incumbents re-elected.

Bruno said that an analysis of the 1966 Legislature campaign results showed that only 3,449 voters determined control of the Assembly. He said a switch of 3,449 votes from the Democratic to the Republican column would have assured Republican control of the Assembly by a margin of 76 seats to 74. (The Democrats won 80 seats and the Republicans 70.)

"Those 3,449 votes," said Bruno, "were a mighty small segment of the 5,358,511 votes cast for all Assembly delegates."

**Basic Plan**

The Young Republicans have divided the State into five areas, each of which has a co-ordinator. After thorough examination, the group will pick those Assembly areas where victory appears most likely as the result of an all-out effort for the GOP nominee, who will receive fund-raising as well as vocal support.

"Naturally," said Bruno, our efforts will be co-ordinated with the Republican State Committee and we don't intend to lose the ball game by picking up victories in one area and losing them in another. We want six new seats, at least, and the 70 we already have."

In addition to plans for fund raising, pamphleteering, speech-making, etc., the Young Republicans are letting it be known they feel the present disarray in the New York State Democratic ranks is an added asset for the Republicans.

The Republicans now control the Senate and expect to keep that control. Should they recapture the Assembly, control of the State government would then be complete.

Note: The very fact that Democrats might return to a completely minority role in Albany could be just the spur they need to put on an all-out, cooperative effort to keep the Assembly leadership. It's the kind of thing that does happen in politics all the time and the Democrats have some bright, new faces of their own to show off this November.

Only questions of general interest can be answered here.

**Q. I have a few basic questions concerning the Statewide Plan: (1) Specifically, what are my coverages for me and my family? (2) How are payments made in terms of sickness and accidents? (3) Do I pay the hospital, medical and drug-gist bills and then submit an itemized statement to your office?**

**A.** Coverage under the Statewide Plan consists of three separate services. Hospitalization is provided by Blue Cross; doctor's care is furnished by Blue Shield and the third part is Major Medical, provided by the Metropolitan Life Insurance Co.

When you use the hospital benefits, Blue Cross will deal with and pay the hospital directly. When you use surgical benefits, Blue Shield will pay the doctor if he is a participating physician, and send the check to you if he is not a Blue Shield doctor. The Major Medical is the only portion of the program that has a deductible. During a calendar year, you must pay the first \$50.00 of Major Medical expenses and then Metropolitan will pay you 80% of all the services included in their contract.

**Q.** Several letters have been received at the Statewide Plan Office asking that a new Identification Card be furnished. The General procedure for securing a new card is as follows:

**A.** Participating agency employees go to the appropriate officer in their own agency for replacement of their identification cards. State employees should contact the Health Insurance Section, New York State Civil Service Department, Albany, N.Y. for their replacement of ID cards.

# File By Aug. 19 For Toll Equipment Repair Positions With State

Once upon a time in New York State there was a toll equipment repairman who made \$7,340 to start, up to \$8,950, and his companion the toll equipment repairman trainee. He made \$6,175. In order to get these titles and salaries they had to file for application by August 19, for the examination was to be held on September 21.

They worked with the New York State Thruway Authority and the East Hudson Parkway Authority.

In order to apply for their jobs they had to have at least two years of satisfactory experience in the maintenance or repair of complex electro-mechanical equipment such as tabulating equipment, telephone switchboard, PBX, or similar equipment involving work with control circuits; or they had to have four years of satisfactory experience in the maintenance, repair and trouble shooting of electrical and mechanical equipment with a minimum of one

year devoted to each category.

The toll equipment repairman had to start at the same level as the toll equipment repairman trainee at first because he did not have the required additional year of previous experience in the maintenance of highway toll equipment before he applied for the New York State job. He made it to toll equipment repairman after the one year minimum period as a trainee however, although he had two years to learn as a trainee if he had needed it.

They had three other friends who had experience as radio and television repairman, telephone installer and telephone lineman, respectively, who did not get to

be toll equipment repairmen or even to take the test because those jobs were not considered as proper experience for the repairing of toll equipment.

They got their applications and further information about the jobs when they decided to take the test by contacting the State Department of Civil Service Office Building, Campus, Albany, New York 12226; or Room 1100, 270 Broadway, New York, New York, 10007; or Suite 750, 1 West Genesee Street, Buffalo, New York 14202; or Room 818, State Office Building, 333 East Washington Street, Syracuse, New York 13202.

They were also sure to enter their social security number on their applications. For whom the tolls jell.

# News Of The Schools

## Classes Planned For Child Care

The New York City Board of Education has announced the establishment of three special classes for socially-maladjusted and emotionally-disturbed pupils, to be known as The Child Care Center School and located at the Child Care Center, Farmingdale, New Jersey.

The Child Care Center is an institution for neglected and dependent children who have been assigned through the Bureau of Child Welfare and the Family Courts of the City. In 1966 the State passed a bill which authorizes the support of an educational program by a city school district in an institution not only within the State but within an adjoining state.

Approximately 20 boys and girls ages 11 through 16 will attend the New York City Board of Education school program at the Child Care Center. These children are too emotionally disturbed to be accepted into the regular public schools and need intensive supervision, guidance and clinical support, which will be available at the Center.

The superintendent said that the classes will be established effective for the September, 1968 school term.

## Board Approves Bi-Lingual Teacher

The Bylaws of the Board of Education have been amended to add a bi-lingual teacher in school and community relations (Chinese).

Requirements for the position are a baccalaureate degree with 30 semester hours in approved professional courses, including the following: (a) 2 semester hours—history, principles, problems and/or philosophy of education, (b) 6 semester hours—elementary school curriculum and/or methods of teaching, (c) 6 semester hours—psychology for teachers or child development or child psychology or psychology of the early adolescent, or any combination of the foregoing, (4) 4 semester hours—history and culture of China and/or the culture of the countries of Asia, (e) 3 semester hours—cultural, social, educational and York City, (f) 9 semester hours—in guidance, including practices

of guidance, techniques of counseling, mental and education testing.

An applicant may offer, in lieu of three of the six semester hours in elementary curriculum and/or methods of teaching, one year of satisfactory experience in teaching or experience as substitute bi-lingual teacher in school and community relations (Chinese).

## Ford Gives City \$17,800 Grant

The Ford Foundation has granted \$17,800 to the Board of Education of the City of New York to conduct a work study summer program in industrial arts, in the Ocean Hill-Brownsville Demonstration District.

The Foundation is granting the sum for an industrial arts program, to be known as, "A Home and Community Practical Work Experience Project," in Ocean Hill this summer.

The program has been approved by the Ford Foundation, the local Governing Board of Ocean Hill and the Industrial Arts Department. It will be carried out in cooperation with the Ocean Hill-Brownsville Demonstration District and will be under the direction of Herbert Siegel, director of industrial arts.

The disbursement of funds for supervisory personnel, tools, evaluation fees and materials, will be under the direct control of the Board of Education. The youngsters involved are being paid by the Neighborhood Youth Corps.

The program will be run without cost to the Board of Education.

## Special Teachers Wanted By City

Industrial arts teachers with experience in woodworking, metals, electrical or maintenance, with or without New York State certification are needed in Manhattan. Salary range is from \$5,500 to \$7,200 a year.

Secretarial teachers with New York State certification or background of teaching experience in typing, stenography, business machines, or clerical practices are also being sought, at \$5,400 to \$7,200 a year.

Key punch teachers, regular or part-time are wanted by the City. No degree is required. A background of one year's teaching experience is necessary. The salary

is \$6,500 plus a year.

## P.R. Communication

Fourteen public school teachers from New York City and 20 from Puerto Rico joined in a 10-day institute that began on June 3 to study the communication needs of elementary school pupils of Puerto Rican background on the island and in New York City.

Cooperating agencies will be the Board of Education, the Department of Public Instruction of Puerto Rico, the National Conference of Christians and Jews and Fordham University.

The conference sessions will take place at the Fordham University Graduate School, 302 Broadway.

## 152 Teachers To Aid Appointees

A group of 152 trained and experienced teachers will devote their time and skills to helping new appointees to the City school system beginning in September, 1968.

The experienced teachers will be known as teacher-trainers and will be assigned to selected elementary schools in districts where they are most needed.

Teacher-trainers will be paid their regular salary and will work in one or more schools. Each teacher-trainer will be a regularly licensed teacher of early childhood education or common branches, with a minimum of five years of successful experience in teaching at least two elementary grades.

There will be a ratio of about one teacher-trainer to nine new teachers in the districts and schools affected.

During the school year, teacher-trainers will devote some time to introducing new curriculum to the entire faculties of the schools where they serve.

All of the services of the teacher-trainers will be a supplement to the normal teacher training and curriculum development functions carried by the supervisors in the schools. All teacher-trainers will serve under the supervision of the principals of the schools to which they are assigned.

The teacher-trainer program was initiated by Dr. Theodore H. Lang, Deputy Superintendent for Personnel in the City school system. It is being coordinated by Assistant Superintendent Abraham Wilner.

# CSA Seeks Supvr. Test Case

The Council of Supervisory Association of the Public Schools of New York City is seeking a licensed supervisor with a bona fide case of assault or threat of deprivation of position who is willing to go to court and pursue his rights legally under due process of law.

CSEA's purpose in this quest is to develop up-to-date general principles of action for supervisors. The Council will provide legal counsel for the supervisor and will pay all legal expenses required to get a final legal ruling on supervisors' rights.

# Post Office Jobs Open Across N.Y.

The Post Office Department has openings throughout the State for clerks, carriers, handlers, automobile mechanics, custodians and fireman-laborers.

The largest number of vacancies are in the clerk and carrier positions which pay \$2.80 to \$3.82 an hour—not counting a July 1 raise. The jobs are open to persons over 17 or high school graduates at age 16.

Mail handler positions pay \$2.59 to \$3.55 an hour and are open to persons at least 18 years of age.

Automobile mechanics receive \$3 to \$4.10 an hour. They must be 18 years old, have a driver's license and have experience in automobile repair work.

Janitor and custodian positions are open at \$4,460 to \$5,564 a year to men over 17 and in good physical condition.

Fireman-laborer jobs pay \$5,215 to \$7,151 for persons at least 18 years old and in good physical

shape. Candidates will be tested on their ability to operate a low-pressure heating plant.

Most of the above positions are on a substitute basis, but may lead to career appointments. Most jobs are open to both men and women. Premium pay—10 percent over base pay—is given for work between 6 p.m. to 6 a.m.

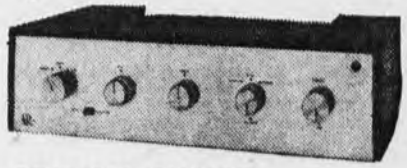

# Early Summer Closing Of Watertown Offices Causes Pact Confusion

WATERTOWN — In what was probably one of the wierdest municipal operations in local annals, the Watertown city council has amended three Taylor Law contracts without benefit of amended organization agreement and ordered a 4 o'clock closing in City Hall offices during July and August.

The earlier closing came late when City Manager Ronald G. Forbes declined to officially order it after discovering there was no ordinance requiring it.

Then the maneuvering started, all of which finally ended by almost everyone benefiting although those directly involved gained least.

The City Hall offices, excepting police, were ordered closed at 4 p.m. by ordinance. Police and firemen were given compensatory time, or the money, at the rate of an hour a day, or \$5 a week.

The time can be accrued. In amending the new Taylor law contracts with the Jefferson chapter, CSEA; the Police Benevolent Society and the Fire Fighters' Local, the council acted arbitrarily

without offering to re-open contract negotiations.

The group directly affected by the dispute which, it was claimed, three policemen raised in the first instance — the office group — got the earlier closing but lost a half hour from the usual hour and one-half lunch hour. Now they get an hour during the summer months, thereby gaining a half hour a day or two and one half hours a week.

The police and firemen got double the benefit while workers in public works, water and electric, parks and parking meters got nothing.

The groups not included in the new benefit are now pressing for equal treatment especially in the face of a public statement by Mayor Theodore Rand that "all groups must be treated alike."

And the mayor thinks the ordinance might be amended next year revoking the 4 o'clock closing summers "in the best interests of the public."

# Joseph McCullough Feted On Retirement

Joseph J. McCullough, long-time Civil Service Employees Assn. representative of the New York City CSEA chapter's Education unit, was honored by friends and fellow workers at a dinner marking his retirement ending 46 years of service as a New York State employee.

The dinner honoring McCullough, who had recently been presented with the 35-year service award of the State Education Department, was held at the President Restaurant and was attended by some 70 persons.

Among those paying tribute to McCullough was Solomon Bendet, former president of the chapter, who praised the retiree for his unstinting support to the cause of high civil service standards and improved status for civil service employees.

McCullough's civil service career began in 1922, when he started work as an investigator for the State Insurance Fund. Eleven years later he transferred to the professional conduct division of the State Education Department, where he has been a senior investigator for the past 12 years.

# Broome County Chapter Seeks 1/60 Retirement

ford, Board of Supervisors chairman, that the county would pay about one percent of its payroll to take advantage of the new State plan.

Crawford pointed out that one percent would be about \$110,000 this year and \$120,000 in 1969.

Under the 1/60th plan, an employee gets 1/60th of his pay in retirement for each year worked up to 30 years, with a maximum of half pay. The benefits are based on the five highest consecutive years of earnings.

The CSEA officials went to bat for two employee groups in a pre-negotiating meeting with Crawford and other supervisors.

CSEA asked that non-professional employees at Broome Technical Community College get raises this year based on results of a professional salary study now being conducted by a consulting firm. The firm is studying all county jobs and salaries and is expected to report soon.

However, the supervisors this month adopted a salary schedule for the college workers for the school year starting in September. Although college faculty received raises, the non-professionals received only increments and county officials have said they cannot give any further raises based on the results of the study until next year.

This means the Broome Tech non-professionals won't get raises until September 1969, and Herick's group has protested this ruling.

The CSEA chapter also arranged a meeting of county infirm-ary employees with the supervis-

bers. August 9 is the deadline for reservations. Further information about the clambake may be obtained from May M. De Seve, publicity chairman, 474-5853.

ors. The infirmary employees are concerned about losing seniority, pension benefits and other advantages if the county carries out its plan to surrender management of infirmary facilities to a private group.

The infirmary employees were assured they would receive jobs either at other municipal hospitals in the county or at the Broome Community Health Center if they do not choose to work for the private group.

Crawford told reporters after the meeting he was willing to submit the request for secret bargaining sessions.

John Tangi, vice president and chairman of the CSEA Employees Committee, said the request was made at the advice of John Dolan, CSEA director of county affairs.

It was contained in a "statement of policy" for bargaining distributed to supervisors by Herick. The statement said:

"In order to conduct collective negotiations which are free from outside influence or pressure and to insure frank and uncensored discussion, we feel that meetings should be restricted to persons who are directly connected with the negotiation teams.

"In addition (we request), that all proceedings be conducted under a strict confidence until such a time as the two negotiating teams may feel it desirable to make public certain matters or until the negotiations are completed."

It also asked "that the chairman of one of the negotiating teams remind the parties involved of the confidence at the outset of each meeting."

Should Broome honor the request, as Crawford suggested would be best, it would be a departure from a system where all committee meetings, including those involving employee benefit talks, are open to the press.

# CSEA Recounts Gains Made For State Police; Elections Set

agent. Council 50, AFSCME, failed to file a petition to represent the officers.

CSEA, PBA and Council 50 are seeking to be designated as bargaining agents for the main body of State Police, most of whom favor representation. According to PERB, ballots will be mailed to all State Police members later this month with the vote count to be made no later than August 10. Representatives of the competing organizations will be present for the official tally.

### The Best Job

Joseph D. Lochner, CSEA executive director, commenting on the upcoming elections, said, "State policemen must consider the one important factor before casting their vote — who can do the best job?"

"Of the three contenders vying for the right to represent the State police, CSEA is the best qualified, and has the largest professional staff to serve the needs of its members. In bargaining for the State Police in the past, it has been our State Police members who have made the recommendations and have done the talking. This is the way it should be," Lochner said. "They know what they want and we help them to get it."

"CSEA exists for the sole purpose of protecting and representing its members in collective negotiations. Every cent of our members' dues money is channeled back into programs benefiting them. Not one cent is used for insurance. If our members want insurance, it's optional," the executive director added.

"We pushed for and were successful in having passed the 25-year retirement plan for State

Police several years ago and having it reopened in 1964. This was accomplished without negotiations through our strong lobbying force in the Legislature. Again, this year, State Police were not represented officially by a bargaining agent, but we co-sponsored and successfully lobbied for a 20-year retirement plan," Lochner concluded.

near future, noting that this would be characteristic of the group's generally inconsistent, sporadic program.

"Besides," the CSEA spokesman pointed out, "this union has built itself the biggest credibility gap ever seen — its wild claims have long since passed the point of no return."

This was clearly evident in a recent union broadcast on a program calling for phoned inquiries from the audience, the CSEA spokesman continued. When the State Trooper union member who appeared on the program finally opened it to phone calls from his audience after speaking at length on State Police representation matters, he received only three phone calls within the remaining half hour of program time, the spokesman said, and none of these was on the subject under discussion.

"The three people who called wanted to talk about driving safety and the legality of the use of radar traps," said the CSEA spokesman, noting that the union obviously was not attracting the interest of the people it was attempting to reach.
