Dear Friend,

We realize that we have many times in the past come to you for funds for the rescue of anti-fascist victims. Our last appeal was an indirect one made through the Joint Campaign in which we and the Emergency Rescue Committee were engaged. With that campaign suspended for the time being we again find it necessary to come to you directly. Not only are conditions abroad making it increasingly difficult for Hitler victims to escape, but new regulations by our own government are leading to the same result.

These regulations which bar refugees with relatives in occupied countries are intended to guard against spies and fifth columnists. The weight of these regulations fall upon innocent anti-Nazis who in the face of great suffering have proved their integrity, while those against whom the new rules are aimed would not hesitate to evade them by lies and misrepresentation. Those on our lists are people who have been known to us for many years as antagonists of all forms of totalitarianism.

However, there are still victims who can be saved. Time is short and we must have your help. The costs of transportation for each refugee amount to at least \$300 and we now have many waiting in Marseille - fortunate enough not to have relatives in occupied territories but unable to leave until their passages are paid. We plead for these and for the less fortunate ones still in the concentration camps who if they do not receive continuous help from us will surely die.

The following letter is a direct appeal to you from anti-Fascists still rotting in French concentration camps:

"There isn't much time left for us unless you help. There are a lot of us here - Czechs, Austrians, Germans, Spaniards - who have to get out. We've been fighting against Fascism, against Hitler, against Totalitarianism, since 1933. That's when the war started for us. We've had to retreat. Now our backs are to the wall. But we can fight again if you help us. We have only one claim on you - you are our kind. We are your kind - we think the same thoughts, we believe in the same things. We fought and worked for them as you would. Now help us get out where we can continue to fight. Otherwise we die - all of us - men, women and children..."

The International Relief Association has evacuated over three hundred of these brave fighters and hundreds more can be saved. Time is short and we must have your help. The costs of transportation for each refugee amount to at least \$300 and we now have many waiting in Marseille, with American visas, unable to leave until their passages are paid. We plead for these and for the less fortunate ones still in the concentration camps who, if they do not receive continuous help from us, will surely die.

DIRECTIONS FOR FILLING OUT AFFIDAVITS OF SUPPORT

- 1. All three copies of the affidavits must be signed and notarized.
- 2. The affidavit must be put in the plural if signed by more than one person.
- Proof of all assets listed must be supplied. Income: 1) Income 3. Tax returns (State or Federal) for 1940 are the best documentary We will have the returns photostated and return the originals to you. The income tax return must be signed and notarized. (If you cannot furnish a copy of your income tax return the evidence of employment, salary and assets will be 2) Letter from your employer certifying to your sufficient.) Insurance: letter from insurance company stating size of policy and cash surrender value, or your last receipt of payment (the first is preferable). Bank savings: photostat of balance in your savings book or bank statement. Real estate: real estate tax receipts. Other assets: letter from your bank certifying to the contents of your safe deposit box (stocks and bonds), letter from your bank giving your average balance for the last three months. It is preferable not to list assets that will take a long time to substantiate, particularly when your income is a substantial one.
- 4. The minimum requirement of income for an affidavit donor is \$25 per week per person. Thus for a man and his wife to give an affidavit for one refugee, the joint income of the man and his wife must be \$75.
- 5. Dependents: If your wife is self-supporting and/or has an independent income, they are not called dependents. This is in a case where man or wife alone signs the affidavit. Self-supporting children are also not dependents.
- 6. Remember that a refugee's life may depend on your prompt return of these affidavits.

- 1)-Have you executed other "affidavits of support" or otherwise sponsored the proposed immigration of anyone? If so, in favor of whom?
 - 2)-If your sponsorship in the present case was solicited, who solicited it?
 - 3)-Explain the circumstances which led you to extend your present sponsorship.
- 4)-Please explain accurately your relationship, if any, to the alien or aliens whose immigration is sought. If not related, explain the extent, nature and past duration of your friendship.
 - 5)-Have you ever seen the alien or aliens you are sponsoring?
- 6)-What, if any, communication have you had with such alien or aliens in the past?
- 7)-Please state whether or not it is your unqualified intention without mental reservation to provide the alien or aliens sponsored with food, shelter, clothing and medical services, whenever the need may arise?
- 8)-If your answer to the next preceding question is in the affirmative, does your intention so expressed extend to the giving of such necessary aid directly, without recourse to any other individual or organization?
- 9)-Should the necessity for your aid cease for a time but recur later, do you unconditionally agree to resume such aid and continue it to the extent and for the period of time necessary?
- 10)-Approximately how much money a week or a month are you prepared to expend for the purposes in question?
- 11)-Is it, or is it not, your intention to take such alien or aliens into your home for maintenance there until a self supporting status is obtained, regardless of the length of time it may take to attain such status?
- 12)-Please explain briefly, but in reasonable detail, what, if any, concrete plans you have toward establishing the alien or aliens concerned in a self supporting status?
- 13)-Do you consider that the affidavit you have already filed and the one submitted in response to the questions and explanations now asked, legally pledge your resources to support the alien or aliens for as long a time as may be necessary?

This office will be glad to weigh carefully all the sworn statements submitted in reply to the foregoing numbered paragraphs.

Those on our lists are people who have been known to us for many years and who have sacrificed family, jobs and have often risked their very lives in their dauntless struggle against Fascist barbarism.

We have evacuated over 300 of these brave fighters. Hundreds more can be saved. Time is short and we must have your help. The costs of transportation for each refugee amount to at least \$300 and we now have many waiting in Marseille unable to leave until their passages are paid.

We plead for these and for the less fortunate ones still in the concentration camps who, if they do not receive continuous help from us will surely die.

The International Relief Association was formed in May, 1933, as a non-partisan, non-sectarian organization to aid the families of political prisoners in Germany and political refugees from Nazi terror who are not cared for by other relief organizations.

The wives and children of men in concentration camps and prisons cannot be aided by the large agencies that have legal offices in "Greater Germany". Those agencies are under the supervision of the Nazis and dare not aid the families of so-called political prisoners. The only way, therefore, of helping these unfortunate victims of oppression is through underground channels unsupervised by the Nazis.

The political refugees in France which include Spaniards, Germans and Austrians, are in equally desperate need. They are in a strange country, the men have all been interned in concentration camps where conditions are indescribably miserable and the women are not permitted to work. Besides helping these people, the I.R.A. is caring for large groups of refugees in England, Holland, Belgium, Switzerland and Norway.

May I appeal to you on behalf of these unfortunate people who have sacrificed their very lives for freedom.

You have been reading between the screaming war and political headlines stories of the plight of these refugees. You know that some have been rescued. But the majority are still caught in the coils of oppressive fascist terror in France.

The final step in the long process of rescuing these trapped anti-fascists is the payment of their steamship tickets. Passages will cost \$250 per person.

These brave men and women who have been driven from country to country because of their incessant, dogged fight against fascism, are our true allies against reaction. You can enlist their aid in America's struggle for democratic freedom by making possible their escape.

We have now obtained emergency visas for more than 100 of the many cases we have cared for over the years. Close to 200 others are pending. Transportation money now will carry them to safety. If you can supply it their lives will be saved -- if not, starvation, pneumonia and typhoid raging in French concentration camps will, during the winter, decimate them by the hundreds.

Each day brings its quota of cables sent in desperation by these dauntless refugees who have put their trust in us. We in turn put our trust in you.
