

## Seek 'Separation' Pay In GE Plant Closing

"Because of the increasing cost of living", the "ad" stated, "our members have been unable to make any substantial savings. Our merchants and businessmen in Kokomo will also suffer from our loss of jobs."

Pointing to GE's tremendous profits, estimated at \$700 on each employee, the local said:

"It seems only fair that the company help tide over the employees until they can find other work."

# **CIO** Longshoremen Win Strike Victory

The International Longshoremen and Warehousemen's Union, CIO, has won its three-month strike on the west coast with a smashing victory over the employers' associa

Terms of the settlement include a pay increase of 15 cents an hour and improved vacations. But most important of all is the saving of the hiring hall, safeguarding members against unfairness and graft in hiring. The shipping companies had declared they would destroy the hiring hall, with the help of the Taft-Hartley Law.

Employers tried to split the union membership from the president Harry Bridges, and other officers by refusing to negotiate with these leaders. The strikers remained solid, however, and for 85 days not a ship moved on the west
