INDIANA FUNERAL DIRECTORS OPPOSE FORAND BILL

Typical of the opposition to the Forand Bill, which would give medical and hospital assistance to the aged and the aging, is the resolution sent Rep. For and by the Indiana Funeral Directors Assn. The undertakers said they opposed his plan because, among other reasons, "it would weaken the patient-physician relationship".

"Could it be that undertakers are opposed to good health?" Forand asked in calling the resolution to the attention of the House of Representatives in Washington.

On the other side, however, the steady increase in the volume of letters backing the Forand Bill, the measure to provide hospital surgical and nursing home benefits to Social Security pensioners, is beginning to impress Congressmen.

Doctors, undertakers and insurance company executives are fighting stubbornly, however, and letters and telegrams attacking benefits for the aged as "socialism" still outnumber the letters of support.



UE DEFEATED IN BALTIMORE

The UE suffered another defeat last week when the IBEW, AFL-CIO won an NLRB election in Baltimore, Md."

The Westinghouse workers in the Air-Arm of the Baltimore Plant voted 839-337 in favor of the IBEW.

The tally made by the NLRB showed a total of 1,263 votes. More than 1,300 workers were eligible to vote. Only thirty-nine cast ballots for no union.

The IUE victory at Lynn, Hass., last week was hailed by abor leaders throughout the country as a sign of solidarity among the IUE-GE workers in this vital year of contract negofiations with the General Electric

Leo Jandreau, Business Agent of Local 301, called the IUE victory "a sign of repudiation of the UE by GE workers". He further stated, "The victory for the IUE in Lynn, Mass., will help solidify the entire membership of the IUE-GE local unions. This unity will be reflected in the union's ability to negotiate a new contract with the General Electric Company . . . a contract which will provide the benefits to which our members are justly entitled.

Ultimatum

"This repudiation of the UE by GE workers should serve as an ultimatum to all disruptors that the GE workers, 90,000 strong, will not be moved by false promises and misrepresentations which are designed to disrupt the unity and solidarity of the GE workers who are a part of the American Labor Movement."

The UE, as an organization has done nothing to protect its members during the past 10 years while the IUE has been very successful in not only strengthening and improving its contract provisions but it has also organized 37

Mr. Ginn Favors Increase In Unemployment Insurance...But...

In recent weeks, Mr. Ginn, Vice-President of GE, came out publicly in favor of an increase in Unemployment Compensation from the present \$45 a week to \$50 a week . . .

BUT...

at the same time, he would have the present law so full of amendments that those now covered by the law would not be eligible to collect the Unemployment Benefits which they are entitled to. Further, he is opposed to the strike benefit clause which permits a person on strike to collect benefits after a 7 week waiting period.

Local 301 and the Central Labor Council have gone on record as opposed to any amendments which would weaken the present law. The NY State AFL-CIO is not asking for \$50 per week BUT \$65 . . . new GE plants which had no with an aim at increasing and strengthening the present coverage and benefits.

> If a striker were allowed to collect Unemployment Insurance from the first week of a strike, we're sure that Management would be less willing to force workers out on the street but would come to a quick, fair and peaceful settlement.

*Run-A-Round

Eight years ago, President Harry Truman set up a special Commission to study the health needs of the nation. After a year of painstaking study they reported the need for public health insurance, especially for the aged.

Six years ago, the House Committee on Interstate and Foreign Commerce set up a subcommittee to investigate the people's health and reported on the inadequacy of private health insurance policies.

Four years ago, the Health Information Foundation published the results of its nationwide survey on Family Medical Costs and Voluntary Health Insurance.

Two years ago, the House Ways and Means Committee asked the Secretary of Health, Education and Welfare to study and report on the health needs of the aged. That report was submitted by Secretary Flemming in April, 1959.

Last year, a subcommittee of the House Ways and Means Committee conducted hearings on the Forand bill to provide hospital, surgical and nursing home care to Social Security pensioners.

This year, the Senate Subcommittee on the Aged and Aging has reported on the results of its hearings in seven cities across the nation. Its volumes of testimony are packed with facts on the health needs of our senior citizens.

Last week, President Eisenhower let it be known that before his administration will support any bill to provide health insurance for the aged-or anyone else-he wants the subject studied.

It's like meeting yourself coming back or, as some like to call it, the runaround.
