1957 INCOME TAX RETURNS

The following figures were recently released by the U.S. Bureau of Internal Revenue in reference to 1957 income brackets:

- ...223 individuals reported incomes that year of more than \$1,000,000
- ...22,936 reported incomes of between #100,000 and #1,000,000
- 44.600,000 reported incomes of \$20,000 to \$100,000 On the other hand:
- ...4 million had gross incomes of \$1,000\$ to \$1,500
- www3 million had gross incomes of \$600 to \$1,000
- ...3.8 million had adjusted gross income of less than \$600

The Dept. of Commerce reports that 14 per cent of U.S. families had incomes below \$2,000 in 1959; that 21 per cent had incomes of \$2,000 to \$4,000; that 23 per cent had $$_{4}$,000$ to $$_{6}$,000$; that 18 per cent had \$6,000 to \$8,000; that 9 per cent had \$8,000 to \$15,000 and that only 5 per cent had incomes of #15,000 or over.

14 SENATORS UP FOR REELECTION VOTE AGAINST AID FOR UNEMPLOYED


On May 24, the Senate upheld President Eisenhower's veto of the Depressed Areas Bill which would have brought new life and hope to thousands of American families in communities where there is widespread unemployment.
