Global Warming to be Focus of Special University Lectures

Three University at Albany professors will discuss the issue of global warming in special lectures on Nov. 6, 8 and 9 as part of a week-long national program spearheaded by the Union of Concerned Scientists to focus attention on the issue.

University atmospheric scientist Harry Hamilton will focus on the massive amounts of carbon dioxide, CO2, being spewed into the atmosphere -- largely from power plants and cars -- and its observed and theorized impact on global climate. Volker Mohnen, another Albany atmospheric scientist, will discuss alternatives to CO2-producing fossil fuels and other possible ways to reduce the threat of global warming. And University political scientist Walter Goldstein will discuss political constraints influencing action on the issue.

Hamilton, Mohnen and Goldstein will be available for media interviews during the week, and their global warming lectures, delivered to regularly scheduled classes, will also be open to the media. The classes which they will address meet Monday, Nov. 6, and Wednesday, Nov. 8, at 1:25 p.m. in Lecture Center 7 and Thursday, Nov. 9, at 11:15 a.m. in Lecture Center 20. The lecture centers are on the University's main campus at 1400 Washington Ave.

Concentrations of so-called "greenhouse gases," especially CO₂, but also methane, nitrous oxides and chlorofluorocarbons, are increasing in the atmosphere. These gases absorb heat radiated from the earth but are transparent to solar radiation. Since in this regard they act much like the glass over a greenhouse, they are commonly referred to as greenhouse gases. And in the view of many scientists, they are responsible for a warming trend in the global climate that could lead to rising sea levels, new drought belts, and worsening air pollution, among other things.



The Taylor and Edith Belcher Cyprus Room at the University at Albany will be dedicated Thursday, Nov. 16, at 3 p.m. Located in Room 320 of the campus's main library at 1400 Washington Ave., Albany, the room will house a rare collection of Cypriot artifacts donated to the University by the Belchers.

INFORMATION SCIENCE PIONEER HEADS NEW ALBANY PROGRAM

Thomas J. Galvin, executive director of the American Library Association and formerly dean and professor in the School of Library and Information Science at the University of Pittsburgh, will join the faculty of Rockefeller College of the University at Albany this fall, as professor and director of a new interdisciplinary doctoral program in Information Science

The appointment of Galvin, recently named one of 16 "field-wide leaders" in a national study of the information sciences and library profession conducted at Rutgers University, was announced by University at Albany President Vincent O'Leary.

"Professor Galvin's appointment to head the new Ph.D. program in Information Science," O'Leary said, "is a major accomplishment of the Graduate Education and Research Initiative. Three years ago we told you we were going to make a major thrust in the area of information sciences. This appointment is a direct result of that commitment. But it would not have been possible without the continuing support of Governor Cuomo, the legislature and Chancellor Johnstone for the Graduate Initiative."

Galvin characterized Albany's new doctoral program as "having the potential for national and international distinction." Albany, he said, "has impressive faculty strength in both theoretical and applied information studies and a unique focus on the public sector as an arena for applied problem-centered research."

Warren Ilchman, Executive Vice President for Academic Affairs, said, "There can be no doubt in anyone's mind that our new found ability to store, organize and retrieve massive amounts of data presents us with incredible opportunities for the enrichment of society. But it also offers a challenge to our fundamental rights of privacy. Dr. Galvin's appointment and the launching of the new interdisciplinary Ph.D. means that Albany will be an even more active participant in the debate of these major issues."

Closely linked to the University's newly established Institute for the Study of Information Science, the new Ph.D. program will involve collaboration among several

Warren Ilchman, Executive Vice President for Academic Affairs, said, "There can be no doubt in anyone's mind that our new found ability to store, organize and retrieve massive amounts of data presents us with incredible opportunities for the enrichment of society. But it also offers a challenge to our fundamental rights of privacy. Dr. Galvin's appointment and the launching of the new interdisciplinary Ph.D. means that Albany will be an even more active participant in the debate of these major issues."

Closely linked to the University's newly established Institute for the Study of Information Science, the new Ph.D. program will involve collaboration among several

academic units, including Business Administration, Communication, Computer Science, Information Science and Policy & Public Administration. The first students are expected to enroll in the fall of 1990.

"With the appointment of Dr. Galvin, the innovative quality of the program and a person of vision and experience unite," said Dr. Richard Nathan, provost of Rockefeller College. "Having been a pioneer in information science, both in print and in the development of an innovative school, Dr. Galvin arrives with a clear understanding of the dynamic nature of this expanding field."

Thomas J. Galvin graduated with distinction in the field of English from Columbia College of Columbia University in 1954. He went on to get his masters in Library Science from Simmons College in Boston and his Ph.D. in Library & Information Science from Case Western Reserve University, whose Distinguished Alumni Award he received in 1979.

He served on the faculty at Simmons from 1957 through 1974, twice serving one year terms as acting director of its School of Library Science and serving as its assoicate director the last two years of his tenure. From 1977 to 1985 he was dean and professor of the School of Library and Information Science at the University of Pittsburgh, and then assumed his present position as Executive Director of the American Library Assoication, located in Chicago, Ill.

Among his many honors, Galvin, along with co-author Allen Kent, received in 1979 American Society for Information Science Award for his book, Structure and Governance of Library Networks: Issues for Consideration. He was given the Distinguished Service Award from the Pennsylvania Library Association in 1985. And in 1988 was awarded the Ida and George Elito Prize from the Medical Library Association of published work deemed "most effective in furthering medical librarianship."

He has authored six books in all, including Freedom and Equality of Access to Information: A Report to the American Library Association, in 1986, edited five others, and writen and edited numerous articles for anthologies and the leading journals in the field.

University to Dedicate Cyprus Room

The Taylor and Edith Belcher Cyprus Room at the University at Albany will be dedicated Thursday, Nov. 16, at 3 p.m. Located in Room 320 of the campus's main library at 1400 Washington Ave., Albany, the room will house a rare collection of Cypriot artifacts donated to the University by the Belchers.

Since 1983, the Belchers of Garrison, Putnam County, have presented the University with 69 antiquities from Cyprus valued at more than \$22,000. The collection consists of pottery, glass, figurines and bronze pieces from the Early Bronze and Iron ages to the Roman Period. The collection is an invaluabe resource for the University and a critical addition to the work of the University's archeological expedition to Cyprus.

Ambassador and Mrs. Belcher served twice in Cyprus. From 1957 to 1960, Mr. Belcher was United States consul and consul general, and from 1964 to 1969, he served as U.S. ambassador to Cyprus. Ambassador Belcher was instrumental in the establishment of the University's Institute of Cypriot Studies.

The dedication will be followed by a lecture, "Cyprus between East and West," presented by Vassos Karageorghis, former director of the department of antiquities of Cyprus and a visiting fellow at Princeton University's Institute for Advanced Study.

Dr. Karageorghis's lecture will take place at 4 p.m. in Humanities 354.

Rockefeller College to Honor Alumni

The Nelson A. Rockefeller College of Public Affairs and Policy at the University at Albany will honor eight graduates at its Alumni Awards Banquet on Monday, November 27 at the Century House in Latham (Reception 5:30 p.m., dinner 6:30 p.m.).

Composed of the School of Criminal Justice, the Graduate School of Public Affairs, the School of Social Welfare, and the School of Information Science and Policy, Rockefeller College is one of the largest institutions of public service training in the country and has educated many state and national leaders in education and government.

This year's honored alumni are Peter B. Hoffman, principle technical adviser with the United States Sentencing Commission; E.J. Josey, professor of library and information science at the University of Pittsburgh; Dennis R. DeLong, dean of Empire State College's Capital District Regional Center; Shirley B. Schlosberg, director of the Prevention Program at Parsons Child and Family Center; Robert J. Sampson, professor in the Department of Sociology and Institute of Government and Public Affairs at the University of Illinois; Esther R. Dyer, Director of Empire Blue Cross and Blue Shield Public Affairs Research and Information Services; Robert J. Morgado, Executive Vice-President of Warner Communications, Inc.; and Fredrick W. Erlich,

Executive Director of the Living Resources Corporation.

Peter B. Hoffman received both his M.A. ('73) and his Ph.D. ('74) from the University at Albany. Building on his dissertation research, he now investigates factors influencing parole determinations and judicial sentencing in both federal and state jurisdictions. In this position Hoffman also prepares training materials to help probation officers implement sentencing guidelines, and manages a data collection and monitoring system.

E.J. Josey received his masters of library science from the University in 1953. He is a champion of intellectual freedom, access to information and equal opportunity for women and minorities in the profession. He helped develop the American Library Association's first comprehensive international relations policy statement and conducted the first national assessment of community use of academic libraries. A prolific writer, Josey has authored more than 200 articles for professional library, history, and educational publications.

Dennis DeLong received both his M.A. ('69) and his Ph.D. ('78) in political science from Albany. As Dean of Empire State College's Capital District Regional Center, he administers the learning center in the capital region and seven external units. Aside from his administrative responsibilities, DeLong has taught extensively and continues to teach at Empire State College. He also currently is an adjunct professor in political science at Rockefeller College.

Shirley Schlosberg received her masters of social welfare in 1976 from Albany. In addition to her position at the Parsons Child and Family Center, she also is a consultant for the departments of Social Services in Rensselaer, Albany, and Schenectady counties and a therapist at Albany Community Maternity Services. Schlosberg has been in the social work profession since 1946.

Robert J. Sampson also received both his M.A. ('79) and his Ph.D. ('83) from the University. Currently a professor at the University of Illinois, he also served as visiting scholar at the National Center for Juvenile Justice, and the National Juvenile Court Data Archive in Pittsburgh. Throughout his career, Sampson has published extensively, established a prolific record of research and has been a

panelist at professional meetings and symposia.

Esther R. Dyer, a native of Albany, received her masters of library science in 1973. Her present responsibilities include production of weekly public and cable television and radio shows for the Blue Cross/Blue Shield in English and Spanish, administration of the corporate library, and liaison with Congressional offices, community agencies and educational institutions in developing joint conferences and seminars. Dyer also is heavily involved in creating linkages between business, education and government.

Robert J. Morgado received his masters of public administration from Albany in 1965. His career features distinguished public service at the highest levels of the state government and great achievement in the private sector. He has served in his present position since 1986. He also is the senior executive for the corporation's Recorded Music and Music Publishing Division.

Fredrick W. Erlich received his B.A. ('69) and his masters of social welfare ('72) from the University. He is one of the original founders of the Living Resources Corporation, a not-for-profit human services agency that provides housing, employment, and health care services for more than 250 clients. Erlich also serves on the National Board of Directors of the National Barrier Awareness Foundation.
