This registration will expire on September 1, 1972.

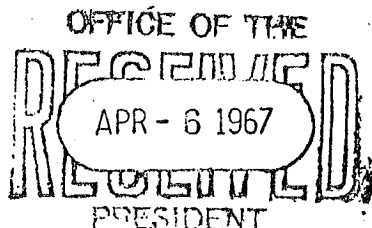

Librarianship (College, Government, Public, Special) -- Master of Library Science (M.L.S.)

Public Administration (Administrative Management, Human Resources, International Affairs, Public Finance, Public Information, Urban Development) -- Master of Public Administration (M.P.A.)

Social Welfare -- Master of Social Work (M.S.W.)

This approval--except for that leading to the degree of Doctor of Philosophy (Ph.D.) in Clinical Psychology--will expire on September 1, 1972. (Approval for general purposes of the Ph.D. in Clinical Psychology will terminate September 1, 1968, if conditions stated in the critique memorandum--signed by Dr. Owen A. Knorr, Director of the Division of Higher Education and chairman of the visiting team--have not been met by that date.)

Approval of programs in school psychology and in school librarianship is not covered by this letter, since action on such courses of study is a function of the Division of Teacher Education and Certification, and action on the former program has already been taken.

Action on the University's graduate programs in Education--Business, Curriculum and Instruction, Developmental Reading, Educational Administration, Educational Psychology and Statistics, General Professional Studies, Guidance and Personnel Services, Reading, Social Studies Education, and Speech Teaching--will be taken at a later date.

Approval of the curriculum in Clinical Psychology is for general purposes only because courses of study leading to licensure are the responsibility of the Division of Professional Education.

Approval of the extension program conducted at New Paltz by the University's School of Library Science has already been effected.

If a major revision is made in any of these curricula, it is required that such information be filed with the Division of Higher Education.
