## NO INVENTORY CHANGE IN STEAM TURBINE

Last week it was reported in the Local 301 News that the MAC and LM&G Departments had revised their inventory schedules to conform with the wishes of the hourly rated employees.

The original inventory plans of the two departments called for a shutdown of operations on a particular day which would have resulted in the loss of a day's pay to the employees. The great majority of the workers upon hearing of such a plan, strongly protested. The Union representatives of the two departments met with management and the results as stated in last week's issue were mutually satisfactory.

In the same issue of Local 301 News, a suggestion was made to other departments who are contemplating shutdowns for inventory to seriously consider similar methods.

Such a department is the Large Steam Turbine Generator...management there announced that it will shut down 1st shift operations on Monday, August 28th, for inventory.

Last Wednesday, the Union Office contacted the Turbine management and asked if some other way could be found to take inventory that would act deprive the hourly rated workers of a day's pay. They were made aware of the actions other departments had undertaken to resolve the problem. In spite of this, their reply wasn't very optimistic or reassuring. They agreed to give the matter further consideration.

Turbine management notified the Union Office that the Union's suggestions had been discussed; however, the decision to shut down the 1st shift on Monday, August 28th, will stand.

Suffice to say, their decision is a callous one, emphasizing a complete disregard for the moral responsibilities they owe their employees. This sort of action on their part leads to dissention and dissatisfaction and causes a deterioration of the good will that exists between employer and employee. One can visthe Schenectady Team! ualize the inspired G.E. headlines in the local and area newspapers if a so-called "work stoppage" took "Thousands of man hours lost workers lose thousands of dollars"! Yet, no one should feel hurt or alarmed when management arbitrarily decides to shut down operations caus-the Schenectady Boys Club. ing workers to lose a day's pay.

It is suggested that Steam Turbine management re-evaluate their position on this very important matter.

## DON'T BE FOOLED BY UNEMPLOYMENT FIGURES

Don't be fooled by unemployment statistics. That's the warning Sen. Paul Douglas (D., Ill.) gives. Douglas says the present method the Govt. uses to figure joblessness fails to give the true percentage of unemployed workers.

The Census Bureau's sample of 35,000 families includes many selfemployed and unpaid workers in family enterprises who rarely can be listed as unemployed. Eliminating this group from the over-all work force and adjusting the Bureau's sample would have brought the percentage of unemployed, not corrected farming in work or scheduling some for seasonal factors, to 8.9% in June, for instance, instead of the 7% commonly used. Second factor is the understatement of part-time work or "involuntary unemployment," Correcting the statistics for this factor would add 2.4% more to rate of unemployment for June, bringing the total to 11.3%. Giving due weight to these factors, it can be seen "the total proportion of time lost by those in June rose to 11.3%. In absolute terms this is a full 3% higher than the figure commonly used."

#### ROTATION STOPS LAYOFF IN RES. LAB.

Recently a serious lack of work developed in the Res. Lab. Tool Room. The Company informed Board Member Korszun that it would be necessary to lay off several tool room employes with service of 20 years or more.

Other Depts. in the plant could help by giving some of their work to the Res. Lab. instead of farming it outside the plant as was done recently in the Steam Turbine Dept.
