NLRB Orders Special Hearing Thousands More Rally To UE

The National Labor Relations Board in a surprise action of far-reaching implications Tuesday ordered a special hearing on the IUE-CIO's election petition.

The Board's almost unprecedented action followed shocking revelations of conspiracy and conniving by

the Carey-Jandreau clique.

1,800 In Turbine Form Unity Group To Guard UE Contract

Acting on the demand of fellow Turbine workers, representatives from each bay and on all shifts met on Monday to set up a permanent Rank and File Unity Committee as proposed by UE.

This development followed neetings of between 1,800 and 2,000 Turbine workers in the shipping yard last Friday. They were called together by UE Local 301 as a result of the events of last week.

Last Wednesday, the IUE-CIO group suddenly ordered all Turbine workers to stop work. Nobody knew what the issues were. There was no explanation . . . no preparation . . . no consultation. There was confusion.

Some groups walked—others worked; departments and shifts were pitted against each other. Bitterness mounted as it became known that Jandreau after pulling the stoppage went to Washington to get the help of the Taft-Hartley Board to break the UE contract, using the Turbine stoppage for pres-

These principles applied to the stackers' stoppage resulted in a victory over a rate cut. The Turbine Rank and File Unity Committee will meet in three lunch-hour sessions today at the Traffic Tower (Rice and West Rds.). The sessions, slated for 12 noon, 7:00 P.M. and 3:00 A.M., will discuss the next moves in forging Bldg. 273 unity.

On Tuesday, five stewards representing the Turbine Rank and File Unity Committee went to a "lost time" meeting of IUE-CIO "stewards." They went to present proposals for united action approved by 1800 Turbine workers at last Friday's meetings called by UE Local 301.

Realization that the so-called "secession" is a conspiracy, not a legitimate union development has been growing among GE workers. It is one of the reasons the tide has definitely turned to UE in recent days.

UE intends at the special hearing which is scheduled for Tuesday, May 18 in Washington, D. C. to expose the conspiracy and protect the UE contract, UE Counsel David Scribner said today.

"Our contract is a bar to an election and a protection for every GE worker," Scribner declared. "Under all current rules, the Board must hold our contract is valid. It can not change the rules for Mr. Carey and Mr. Jandreau."

In the earlier Board hearings, UE had been prevented from showing the full extent of the conspiracy and misappropriation which was later brought out at the contempt hearings:

"We're entitled to prove the true nature of these financial dealings and of the conspiracy." Scribner added.

"We've shaken a hearing out of them," said UE Local 301 President Ernest W. Kopper upon learning of the sudden development. Noting that the IUE-CIO had advertised May 14 as the date for the election, Kopper pointed out that, "the stampede time table of the Carey-Jandreau clique has been knocked out."

This latest development will undoubtedly accelerate the swing to UE which picked up tremendously because of the leadership given in Turbine.

Porcelain Workers Unite In Job Fight

The workers in Bldg. 68 are getting together to do something about the work situation and the downgrading which between them are hurting where it hurts most.

Many are working only four days a week while others are bumping around the lower pay-

This has been going on for months without any sign from the Jandreau clique that they were even mildly interested.

Last Friday a group of Bldg. 68 workers came to UE Local 301 Hall, 2011/2 Broadway, where they formed a committee to unite the workers to save jobs and earnings. They re-ported that there was no lack of Porcelain work since the company is expanding the joboutside of Schenectady.

UE Local 301 promptly filed a grievance under Articles I, XI and XVII of the UE contract. These articles limit layoffs to lack of work, prohibits the involved in a grievance, and

The grievance is being circulated for signatures. A leaflet accompanying the grievance points out that the situation in Bldg. 68 is facing workers in other divisions and that the UE's fight for jobs deserves the support of all regardless of union preference.



MEMBERSHIP MEETING HEARS OF SWING TO UE 301 IN PLANT

A membership meeting that packed Scottish Hall on Clinton Street Monday night heard reports on humming UE Local 301 activity in the fight for jobs, the negotiation of grievances, national wage and contract negotiations and swelling support for UE.

As pointed out by UE Inter national Representative Michael Jimenez, the upsurge of fight ing activity in the shop and community mark a striking contrast to the situation just eight short weeks ago, when the Jandreau clique, after swallowing the local treasury, pulled its blitz raid against the local

A highlight of the meeting was a report by Elsa Ferguson, a member of a UE Local 301 delegation that went to Essington, Pa., to learn just how UE Local 107 carried on its successful fight to save 2,600 jobs that the company threatened to

"They fought just like we are fighting here," she said. "They had to contend with treacherous leaders too people that sold out to the IUE-CIO and wouldn't fight to save jobs. But the people got together in the Westinghouse shop, beat the IUE-CIO by five to one, and 2,600 people that would be out in the street are now working. That's the way it's going to be here. The UE strength is growing by leaps and bounds."

A report on national negotiations with GE was given by Chief Shop Steward Andrew Hmura, a delegate of UE Local 301 on the national negotiating committee.

Jandreau failed to submit the proposals which were unanimously adopted by all three shifts at the meeting in the Bldg. 273 shipping yard. Nobody in "lost time park" at 301 Liberty St. rose to insist that the demand of the Turbine workers be brought on the floor.

The five who came with the proposals for united action on grievances were Alex Kotarski, who spoke on the rank and file proposal, Kenneth Brantley, George Crandall. Bert Hansoman, Howard Lawrence.

The rank-and-file proposals were:

1.—That the overwhelming majority of Turbine workers have voiced their approval for united action of everybody in the Turbine Division based on the proposition that an injury to one is an injury to all.

2.—That nobody should use the legitimate grievances of Turbine workers for any political purposes.

3.—That a Turbine Unity Committee be set up composed of a broad representation from each group to cover the entire Turbine Division.

4.—For the purpose of establishing the machinery of this Committee, that both sides should designate an equal number of representatives to work out the details and the program of this Turbine Unity Committee.

UE AND GE CONTINUE WAGE AND JOB TALKS




