Subject: Senate Response to Program Deactivation

Dear Jim,

I read your article in the UUP Newsletter today, and wanted to make a correction. In the article, you write that "the University Senate....[was] supposed to be consulted on any program deactivations and flagrantly [was] not last year." Contrary to popular belief, though, the Senate WAS consulted. Below and attached is the e-mail sent out to the entire senate last year in response to the memo from the President of October 1. There were a few reports that came in late (after November 10), so they are separate. I'm also attaching the memo itself, and the minutes from the November 15, 2010 Senate meeting.

Consultation with the faculty happened over a long timeline, beginning with the Budget Advisory Groups, as I outlined in the GOV memo (part of the attached Senate summary). In his October 1 memo, the President wrote, "I am writing to invite the University Senate to comment on the academic component of my campus financial plan....I would appreciate receiving your comments by November 19, 2010." The Senate, thus being consulted, responded by various Council reports (also attached here).

These are all public documents, so feel free to forward them.
