ADOPTED UNANIMOUSLY STATEMENT BY LOCAL 301 EXECUTIVE BOARD, November 18, 1949

Organized hooliganism by the Carey forces, directed and organized by Frank Kriss through his complete disregard of the membership, prevented the membership from holding its meeting Thursday night at the Armory, attended by 4,000 members from the first and third shifts.

The second shift meeting also was broken up by Kriss by completely ignoring the members at the meeting.

Therefore, the Executive Board finds that no membership meeting was held under the constitutional requirements in November. Frank Kriss and Frank Fiorillo have left the union, by their public action in accepting a charter from a dual paper union.

The Executive Board names Vice-president William Hodges to carry out the duties of President, and Assistant Recording Secretary John P. Green to carry out the duties of recording secretary, pending the annual election of officers in accordance with the constitution.

In view of repeated experiences showing that in the Armory a meeting can be disrupted by a small minority, making an orderly meeting there impossible, the Executive Board is proceeding to call the adjourned November meeting at the hall in sections, so that the union can nominate officers, set up the election machinery, and conduct other pending union business in accordance with the 301 constitution.

The illegal actions of a handful of traitors to their oath of office will not keep this union from its normal operations and handling of members problems under the contract. The union here is UE Local 301 supported by the vast majority of the workers in the Schenectady plant of the General Electric Company.

UE President Albert J. Fitzgerald on Monday suggested that a labor board election be held March 15 to settle the question of union representation in GE and Westinghouse plants, so that the contract benefits of workers may be protected.

He made the suggestion at a joint meeting of GE and Westinghouse conference boards of UE in New York.

Fitzgerald suggested the March 15 date because UE has binding contracts with the two companies expiring April 1, 1950. He said:

"The procedure we suggest would prevent reckless flouting of established collective bargaining procedures. Any action on the part of the Taft-Hartley Board to break existing contracts would lead to chaos in collective bargaining relations not only in our industry but throughout the entire nation."

GE's L. R. Boulware continues to say loudly that GE is "neutral," but the company showed its colors in two very specific ways here. In direct violation of the contract and the rights of individual workers, the check for members' dues checked-off early in November is still being withheld. On Tuesday the company allowed the Carey-Kriss-Fiorillo stooges to hand out leaflets on company property, in a direct attack on UE 301, the only organization recognized as the representative of the workers here.

Tougher on Grievances


Of course the company has toughened up considerably on grievances, even by comparison with its tough attitude of the past two years. But where the membership is united, grievances are being won.

Kriss and Pals Face Libel Suit

A summons in a libel action has been served on Frank Kriss, Frank Fiorillo and Ralph Mirando by Local 301 for a slanderous statement made about 301 officers in connection with union funds.

The Schenectady Gazette, which printed the statement Nov. 4. printed an apology after receiving a letter from the Executive Board that a libel action would be started unless there was a retraction of the statement, Kriss, Fiorillo and Mirando were also sent letters demanding a retraction.

301 Gets a Smell Of Carey 'Democracy'

Frank Kriss has given GE workers a foretaste of the kind of CIO "democracy" they would find in Carey's outfit by the way he conducted recent 301 membership meetings.

He refused to let members speak, prevented any discussion of issues, rushed through important votes without telling people what was being voted on, and announced the result of one vote after another contrary to what the vote really was. Then he ran out.

Gazette Is Trying New Way of Lying

The Gazette tried a new trick in lying about 301 during the past week. This time it tried to make its stories appear reasonable and honest, but the lies were there just the same. And it called itself "neutral."

Thus when the Carey stooges claimed that the Armory meeting voted "overwhelmingly" to leave UE, the Gazette said they had "a slight edge." The vote against the motion, even with all the confusion, was at least 2 to 1, probably much higher, as shown in the photograph on page 4.

With some more phony "impar tiality," the Gazette pretended that UE supporters as well as Carey followers were disrupting the Armory meeting. The truth is that the shouting by UE supporters was simply the effort of large numbers to get the floor on a proper point of order to protest Kriss' violation of democratic procedure and abuse of his office. The small minority of Carey supporters were organized in selected spots in the hall to break up the meeting.

Other newspaper stories on the past week's events ranged from just sloppy reporting to outright lying. Typical examples:

The Union-Star reported that "right-wingers predominated at the second-shift meeting." The fact is that when Kriss declared the meeting adjourned, the meeting staved in session to hear Leo Jandreau, and only about one-third walked out, leaving every seat taken and some members standing.

The Union-Star said a "Daily Worker" photographer was admitted to the Armory meeting. This was a barefaced red-baiting lie. The only photographers admitted were those hired by the union to make a record of the activities.

The Gazette described the 301 Executive Board as "all-powerful." The Gazette knows that the 301 Executive Board is limited to making recommendations to the membership, and has less power than executive boards in the great majority of unions.

And the Gazette tried to help out the Carey union-busters by crediting their pitiful Monday night meeting with 60 present instead of the 47 who were there. But that's just chicken feed alongside the over-all campaign job the papers have been doing for the company unionists. It would take many columns to point out all the distortions of fact.

301 Presses Fight **Against Downgrading**

Local 301 has sent to the New York level three grievances involving what the union believes is a determined move to downgrade jobs. A. C. Stevens, assistant to the works manager, of course denied there was any such idea.

Two of the cases involve assembly jobs in Building 46. Although the jobs are included in the company's job descriptions for A, the company now classifies both jobs as B. The excuse is that the way the assembly work is now being done makes the jobs B work.

Union Fights Lay-Offs In Move to Morrison

Local 301 last week protested against the General Electric's plans for moving work from refrigerator controls to Morrison, Ill., and for laying off 200 employees, mostly women, between now and March as a result of the move.

After being informed by A. C. Stevens, assistant to the works manager, that the company is now proceeding with the transfer of some of the work now being done in Building 53 to the new plant at Morrison, the union office wrote Stevens last Friday.

The letter called the move "an arbitrary one" that is "intended to reduce labor costs at the expense the descriptions GE can tear down is uncalled for, especially at a time like the present, the union de-

Thomas Stanton. 866 Emmet St., reported in the Gazette as "a right winger," was arrested by police at the Armory meeting Thursday night, Nov. 17, on a charge of disturbing the peace. He is not a member of the union, but is reported to be a brother of Martin Stanton, one of the leaders in the Carey outfit.

A 301 sergeant-at-arms, who discovered that Thomas Stanton was carrying a piece of brass four or five inches long and an inch wide, turned him over to police. He pleaded innocent in Police Court last Friday and the case was pu over until today by Justice Charles

301 Files Appeal From Judge Alexander

Local 301 has appealed to the Appellate Division from the inunction obtained by Carey followers from Supreme Court Justice John Alexander interfering with the right of the 301 membership to handle their own funds The injunction limited the union's expenditures to \$3,500 a week.

Labor History Repeats Itself

There's an interesting parallel between the refusal of UE to submit to the dictatorship of national CIO leaders and the fight between the original 10 AFL unions who formed the CIO and the AFL Executive Council.

In 1935, 10 unions of the AFI including the Mine Workers and the Amalgamated Clothing Workers, demanded that the AFL start organizing the unorganized in the mass production industries on an industrial basis. The AFL Executive Council not only refused to do this, but threatened to suspend these unions from the AFL unless they dropped this plan.

The 10 unions continued the drive as the Committee of Industrial Organizations and they were expelled by the AFL on the issue. Phillip Murray, one of the leaders in founding the CIO, took ex-

actly the same stand against UE, at the CIO convention at Cleveland in October, as the AFL Executive Council took 14 years ago against the AFL unions demanding that the unorganized be organized on an industrial basis.

UE was expelled for insisting that CIO should organize the unorganized instead of disorganizing the organized.

Awards for Injuries

Workmen's compensation awards obtained recently through cases handled by the union office included an award of \$275 for John Jab-'lonski, punch press operator in Bldg. 11, for a lip scar incurred 12 years ago. No claim had been filed until the union took up the case

As a result of illness caused by dust conditions in Bldg. 68. Antonia Prevratil was awarded \$28 a week for lost time from June 7 to June 24.

The committee is undoubtedly attempting a smear campaign to help James B. Carey, who cooperated so willingly last year with another Congressional committee investigating UE,-the Taft-Hartley Labor Committee.

Meanwhile it is interesting to read that Repesentative J. Parnell Thomas, former chairman of the Un-American Activities Committee, has obtained another delay in his federal court fraud trial. He has been accused of defrauding the government by receiving "kickbacks" from congressional em-
