Union Here Is UE; CIO Is NOT A Union

UE established the present working conditions at GE. UE did it alone, as the joint action of the workers at GE. CIO never had anything to with it. Expulsion from the CIO changes exactly nothing.

The outside forces now trying to destroy our union have raised some confusion because of freauent misunderstanding of what he CIO is.

The CIO is not a union. It is a loose federation of separate unions.

UE was formed as an international union in our industry in 1936, and affiliated with the CIO in 1937. It was certified as bargaining agent for GE workers before we joined CIO. CIO is no part of the contract or bargaining

GE Is Fined Again In Anti-Trust Case

The federal court of Los Angeles recently fined the General Electric Company \$5,000 for antitrust law violations.

The company did not defend criminal anti-trust agreed to a consent judgment against it in a companion civil case. GE was indicted with Westinghouse and other firms charges of conspiring to fix noncompetitive prices for disconnecting and grounding switches. They also were charged with price fixing on switches sold to public utility

Carey Group Is Trying To Wreck Local

The defense of UE Local 301 and its contract will come before the membership meeting at the Armory next Thursday night, Nov.

Because of the effort of President Frank Kriss and Frank Fiorillo to use their offices to destroy the union, the Executive Board has suspended its own meetings and is placing the matter before the membership.

The November meeting was originally planned mainly for nomination of officers and the election of an election committee. It was scheduled for the union hall Nov.

Plan for Big Meeting

Since that announcement, activities of the anti-UE forces have made it clear that there must be a big meeting to consider the situation and act to protect the union's gains of 14 years. Therefore the board has changed the date to Nov. 17 to get the Armory.

Kriss and Fiorillo, in league with the Union-Star and Gazette and other outside forces, have thoroughly flouted their oath of office as elected officers of Local 301 of UE. UE is the only union concerned in both the contract and the local constitution.

Working for Carey

Kriss and Fiorillo have used their offices in a campaign to spread confusion and to promote the new Carey paper outfit which has no standing under our contract. They have gone beyond that, and have taken direct steps to try to prevent 301 from handling grievances, by asking the Schenectady Trust Company to freeze the 301 funds. Kriss, Fiorillo, and Trustee Ralph Mirando failed in this only because the bank, faced with an injunction and damage suit by 301, realized it was in hot water under the banking law and agreed to unfreeze the

The discussion centered on the union's complaints over slowness in calling back workers with longer service. Howell insisted that his department was calling such workers back as fast as it was reasonably possible to arrange suitable "bumps" or openings. He said that the process of calling workers back was moving faster now in view of the relative leveling off of the employment situation at this plant

Howell estimated that at present there are 700 men and 500 women out for lack of work.

Here Are the Facts On CIO Convention

November II, 1949

Here is a brief summary of what went on at the CIO Convention as it affected UE:

A committee of the UE General Executive Board met with Philip Murray and proposed that there be simple, straight-forward noraiding agreements between the UE and the CIO, Steelworkers, and Auto Workers. Murray called the proposal a Communist plot.

The resolutions committee and constitution committee of the convention, both completely topcontrolled, prepared a resolution expelling UE and constitutional amendments giving the executive board power to expel unions and bar union representatives simply for disagreeing with the executive board. (This is just as if a local executive board removed a shop steward for disagreeing with the board's views on city politics.)

UE Asked End to Raiding

The convention passed the resolution expelling UE. The resolution could not make a single charge that the UE had DONE anything against the welfare of the workers. The resolution consists of a long series of red-baiting lies about UE. The most obvious lie is the statement that UE "demanded that CIO "subordinate itself to the UERMWA." All that UE asked for was that CIO stop raiding. Any decent union leader should agree to that.

Through the smokescreen set up by the resolution one thing stood out, namely that CIO topshots were bitter at UE for daring to demand an end of raiding and for opposing the policy of going to fact-finding boards instead of bargaining directly with employers.

Phony Excuse

Murray and his fellow red-baiters said the issue was "Communism." The fact is that they expelled UE, whose officers had signed Taft-Hartley affidavits, while delaying action against other unions they attacked, including the Fur Workers, whose president makes no bones about being a Communist.

Later Carey admitted that detailed plans to expel UE and set up a phony union were completed before the CIO convention. CIO topshots made up their minds to expel UE and set up a dual union as soon as they found they failed to control the UE Conven-

Kriss and Fiorillo Betrayed Membership, Not Functioning as Officers, Board Says

Jandreau Says Membership Will Decide; Schenectady Papers Mangle Statement

Business Agent Leo Jandreau gave a statement to the Gazette and Union-Star Nov. 3. He made it very short in hopes that it would not be distorted by the newspapers, but they managed to mangle it beyond recognition. Here is the complete statement:

Attempt to Tie Up 301 Funds Beaten

Efforts of Frank Kriss, Frank Fiorillo and Ralph Mirando to tie up Local 301 funds and to stop the union from functioning failed this

The three Carey followers sent a letter last week to the Schenectady Trust Company asking the bank not to release any of the union's funds.

Technically from late Friday afternoon until Monday morning the bank complied with the request of these three officers. The bank ended the tie-up early Monday, however, and the union dropped legal proceedings it had started against the bank.

On Saturday the union obtained a Supreme Court order directing Kriss. Fiorillo and Mirando to show cause yesterday why they shouldn't be stopped from taking any action to tie up union funds. The union also filed a \$150,000 damage suit against the three.

In its complaint the union showed that Kriss, Fiorillo and Mirando acted without authority from the membership or the 301 constitution. "GE workers know that their contract is between the company and UE alone. The present conditions of employment in the shop, including some of the greatest gains in the labor movement, were established through UE and its policy of reliance on the membership and control by the member-

"This happens to be one of the too few big unions in which the membership have the opportunity to vote every year for their officers. In about one month there will be such an election in 301, with a direct membership vote on voting machines. That election will afford a clear-cut test. The membership will then decide whether they want UE, continued control by the membership, and continued contract gains, on the one hand, or Jim Carey and control by GE and its labor, political and newspaper stooges, on the other hand. I have no doubt of the outcome."

Papers Again Caught In an Outright Lie

For a long time both the Gazette and Union-Star have been twisting news about UE and 301. But there has never been a clearer illustration of the papers' disregard for truth than the way they treated the resolution adopted by 301 shop stewards last week recommending steps to safeguard the union's funds and property.

The law requires GE to continue dealing with UE alone under its master contract, the company advised James B. Carey this week.

Thus Carey's attempt to pull a huge bluff on the GE workers fell flat. He had been pleading with employers to help him take over the UE contract and membership. He sent a wire to President Charles E. Wilson of GE, claiming that his new phony outfit spoke for the GE workers under UE contract.

Carey evidently thought that his stooge union appeal would make employers forget the law and the rights of employees.

The GE letter to Carey this week was signed by L.R. Boulware, vice-president in charge of labor relations. It pointed out that GE had no evidence that Carey's outfit had been designated as representative "by a majority of our employees in any bargaining unit."

The letter continued:

"It is our opinion that under present circumstances until we are otherwise ordered by the National Labor Relations Board we are required under the law to continue to recognize and to bargain with those unions which have been certified to us by the Board as the collective bargaining representative of our employees in the respective bargaining units.

Everywhere where the contract applies, UE alone was voted the bargaining representative, in official National Labor Relations Board elections.

If Carey and his backers had their way, GE workers would be back where they were 14 years ago, without a contract.
