SUNYA FACULTY MEMBER NAMED DISTINGUISHED PROFESSOR

William N. Fenton, research professor of anthropology at State University of New York at Albany, has been named distinguished professor of SUNY at a meeting of the SUNY Board of Trustees.

The title was conferred in recognition of Dr. Fenton's achievement and esteem in anthropology as a result of original contributions. Recognition may be gained through publications, lectures, research findings, and the teaching of students.

Dr. Fenton received a bachelor's degree from Dartmouth College and a doctorate from Yale University. He formerly was assistant commissioner of New York State Museum and Science Service and joined the SUNYA faculty in 1969 as research professor of anthropology. An exceptionally productive scholar, he is a leader in the development of research on the Iroquois and in the new field of ethnohistory. In particular, Dr. Fenton was one of the first to apply anthropological skills and knowledge to the handling of the Indian wampum collection.

The anthropologist is one of two named distinguished professors of SUNY, the other being Leendert Westerink, professor of classics at SUNY-Buffalo. To date, 27 scholars in the SUNY system have been honored with the title.

SUNYA JUDAIC STUDIES MAJOR APPROVED

The State Education Department has approved a State
University of New York at Albany program in Judaic Studies leading
to a Bachelor of Arts. Students initiated the major, and Sefton
Temkin, department chairman and associate professor of Judaic studies,
will supervise the program.

Those seeking the degree will pursue studies in a combined major and second field sequence. Students will be required to take a minimum of 54 credits in Judaic studies, to include 12 in Hebrew language and literature; six in Jewish history; six in the Bible; and 30 in electives within the major, 24 of which are to be at the 300 and 400 level.

The establishment of the program has come about as a result of expanding of Judaic studies in the country which has created an increased need for scholars in the field. In addition, the demand for Hebrew language teachers in many public high schools is growing and the number of qualified Jewish religion school teachers is small.

The SUNYA Judaic studies, the only such department in the SUNY system, has been prepared to offer a B.A. with a major in Judaic studies since 1969. The present enrollment in the courses is 750 and the projection for next year is 825.

In addition to the on-campus studies, State University of New York has established a program with Tel-Aviv University in Israel for

undergraduates. Hebrew University, also in Israel, will accept SUNY graduate students for advanced study and research under joint supervision of Hebrew University and SUNY faculty.

Professor Temkin, who joined the faculty at SUNYA in 1970, received his doctorate from Hebrew Union College in Cincinnati and a law degree and Master's in modern history from the University of Liverpool, England. Before coming to Albany he was editor of the Encyclopedia of Judaic Studies, New York City.

SUNYA'S O'LEARY APPOINTED TO NATIONAL CORRECTIONS BOARD

Vincent O'Leary, professor at the School of
Criminal Justice, State University of New York at Albany,
has been appointed to a three-year term on the Advisory
Board of the National Institute of Corrections. O'Leary
is one of 10 criminal justice experts who have been selected
for the board.

The National Institute of Corrections is a division of the U.S. Department of Justice and was established by a Congressional act which President Ford recently signed into law. The advisory board will supervise the overall policy and operation of NIC.

The function of the institute is to assist federal, state, and local correctional agencies through management training, research and evaluation, clearinghouse and information services, policy formulation and implementation, and technical assistance.

Commenting on his appointment, O'Leary said, "I am looking forward to serving on the board because correctional reform has been too long delayed in the United States.

I am hopeful that the new institute can play a major role in stimulating those efforts. The impediments to reform are formidable but by working closely with state and local leaders, hopefully, the Institute can make a difference."

Prior to joining the School of Criminal Justice at SUNYA in 1968, Professor O'Leary had served as head of the parole systems of the states of Texas and Washington and as an advisor and staff member to several presidential commissions in the area of crime. He also has served as a consultant to a number of agencies in the correctional field and has written extensively on correctional programs, organization, and policy.

SUNYA ANNUAL FUND SURPASSES GOAL

The State University of New York at Albany Alumni Association Annual Fund has reached \$200,000, Paul G. Bulger, national chairman of the fund, has announced. The drive thus has surpassed its two-year goal of \$175,000.

SUNYA SCHOOL OF LIBRARY SCIENCE PUBLISHES CAPITAL DISTRICT DIRECTORY

The School of Library and Information Science at State
University of New York at Albany has published "Capital District
Information Sources," a referral pointer to social service and
information-disseminating organizations in Albany, Rensselaer,
Saratoga, and Schenectady counties.

The 118-page booklet lists and describes Capital District organizations which offer information, social services, or community facilities to the public, either directly or through referral to other organizations. The directory is intended to lead those with questions to a place where answers can be found.

The greater part of the book is an alphabetical listing of 339 organizations in the Capital District. Each entry contains the name of the organization; primary mailing address; telephone number; a description of activities, in abstract form, based on information submitted by the organization; the size and scope of library, if any, maintained by the organization; office hours of administrative staff; and the source of funds as reported by the organization.

The directory also contains a list of 145 lobbyists and the interests they support; a list of libraries in the Capital District;

and a bibliography.

It is indexed according to subject matter.

Names and addresses for the directory were taken from existing directories, public and organizational phone books, bulletin boards, and suggestions made by acquaintances of the compilers. An openended questionnaire and cover letter were mailed to about 1200 organizations in the Capital District, and information was culled from the 400 organizations which responded.

Edward M. O'Connor served as chief compiler for the catalogue and was assisted by nine students from SUNYA student chapters of the Special Libraries Association and of the American Society for Information Science.

The project was funded by the Hudson-Mohawk Association of Colleges and Universities, Latham, N.Y.; the Mid-New York Library System, Utica, N.Y.; and the School of Library and Information Science at SUNYA.
