NO STATEMENT

Although no statement can be made about the findings until after they are reported to the court, the IUE-CIO is confident that its accusations of huge expenditures above and Fond ordinary needs will be "stantiated،

Time Catching Up With UE

DATES BEING SET

Three months after the IUE-CIO first sought to set the Labor Board machinery into action to get immediate elections, election dates are being

General Motors elections will be held at five plants on Feb. 28. Dates for the RCA, Westinghouse and GE elections should be announced within the next two or three weeks, with GE being the last of the group.

Interestingly enough, the IUE is expected to win all plants at General Motors, although just two years ago GM was overwhelmingly left-wing. The answer to this riddle: the communist party and the UE came out so openly and vigorously volt cleaned up District 7. Right now, District 7 is 80% IUE-CIO.

GET IT RIGHT

The IUE-CIO, believes that a local union has not only the moral right, but the inescapable duty to spend an amount of money sufficient to care adequately for the running of its affairs. UE Stalls Court Examiners

THE IUE-CIO NEWS

Stalling by UE Local 301 over books to be turned over to auditors and examiners is just about as bad as the stalling by the defense attorneys at the trial of the 11 Communists in New York City.

Armed with a Supreme Court order to discover and inspect all accounts, books, vouchers, receipts, checks and other entries and papers of US Local 301, a contingent of IUE auditors, attorneys and assistants went into the UE offices at 301 Liberty St. this Monday. By 1:00 p.m. UE attorney Perlin had already rushed to court to seek a delay in the investigation.

A referee was appointed by the Court to superintend and direct the inspection. After many delays created by bickering and stalling by the UE attorney, the referee ordered the UE to produce the required books and papers.

"I Refuse to Answer"


The UE began producing the books and papers on a piece-meal basis. Joe Whitbeck and Emil Radosevich (Sentner's brother-in-low) attempted to delay the inspection. Time and again, when asked to produce certain records, or when questioned, Radosevich would argue against bringing those records or would say, in answer to questions: "I refuse to answer any questions."

The UE introduced a rotation system for their representatives. First, Radosevich would be there; then Perlin: then Whitbeck. Very soon after the inspection began, it could be seen that we had here the identical strategy as that practiced on Judge Medina at Foley Square. Does the UE here also feel quilty?

Referee Stops Stall

On the third day of the inspection, the accountants made a plea to the Referee to clear the room of the UE interferers. The Referee was quick to recognize the justice of the request and granted the motion immediately. Work on the books was stepped up for a few minutes. Then, in came one of the UE attorneys and made some excuse about having to be away for a while and asked the Referee to allow Radesovich, who is not a lawyer, to act as UE supervisor in his place. By this time, the Referee had had enough of Radosevich and told the lawyer he was refusing his request because Radosevich would wrangle and interfere with the work.

From 10:00 a.m. to 11:25 a.m., Radosevich stalled about bringing in UE records. Perlin had been told the evening before exactly what records were needed for the third morning. He wrote down the list dictated by Gus Gomprecht, one of the IUE auditors. At 10:00 a.m.,

Flip Flop Continues

Forgot Miners

We want to point out, however, that the UE, on this question, continues its policy of 'flip, flop''. It wasn't too long ago that the communist party, completely supported by UE top officials, attacked J L. Lewis as a Labor "renegade". The line then was to smear John L. and forget the problems of the miners . . . GE workers remember, even though UE officials hope they have for-

All this time, the UE attorneys were running out of the room and back, on orders of the Referee, to get Radosevich to hurry up with the records. He finally came back, but without the bank statements. claimed no request was made for them, although requests had been made twice.

All in all, you can't help wondering what they're trying to hide by all these delaying tactics.

Let's Talk Politics

Yes, let's' talk politics. We decided a long time ago in the Labor movement that our strength on the economic front alone was not sufficient to win the kind of security which all of us need and all of us deserve. You just couldn't negotiate better housing with the boss. You just couldn't solve the problems of the Taft-Hartley act, price control, inflation, rent control or improved social security benefits across the collective bargaining table. So we got into politics. We set up the CIO's Political Action Committee, better known as PAC. We set it up because Labor had a purpose and a political program.

And we went to work with our PAC. We went to work with a great deal of determination. We decided that if Labor was to become a truly powerful social force in America, we had to have in the legislative halls of

the nation people who were dedicated to our program, people who were sympathetic to the needs of the majority of our population.

And so we stumped in every village and every town and every city in America. We supported those candidates, regardless of political affiliation, who stood for better housing, improved old age pensions, abolition of the Taft-Hartley act. In short, we stumped for all those candidates who stood for the building of a more secure America, for a more abundant life for YOU and your kids.

Where Was the UE

But where was the UE during all this. Let's look at 1948. During that year we had a job to do. We rallied around President Truman's Fair Deal program. We rallied around that Wallace and his so-called third program because it held out real hope for America. The forces of Labor worked hard to assure the election of Truman, of those who backed Labor's program. But the UE was nowhere in sight. The UE which spoke in angry terms about the Taft-Hartley act, pursued a role which was designed to perpetuwhe that act, a role which would Le made it impossible to achieve a single one of Labor's

LET'S COMPARE

Just what does an honest local spend for lost time and organizational expenses?

That's a question that lots of GE workers asked in recent weeks when they saw the exhorbitant bills paid by UE local 301. UE spent about 38% of "its total income last year on "lost with UE's time" and "organization" expenses. That is, the total of both items amounted to 38% of all income.

The steel local at the American Locomotive plant spent 13% of its income on the same items. If UE had spent the same proportion of monies, it would have cost the UE local \$29,000 instead of \$86,000.00 a nice saving to the membership of \$57,000.00.

IUE Asks Chandler Keep Baseball Here

Turning from the more serious side of life for a moment, the Executive Board of Local 301 IUE-CIO passed a resolution asking Baseball Commissioner Chandler to keep baseball in Schenectady. The resolution which was passed unanimously was decided upon as a result of the insistence of Tom McCaffery owner of the Albany baseball club that the Schenectady Blue Jays of the Canadian-American League be forbidden the right to play ball because such play would constitute an infringement of the territorial rights of the Albany gate by only one team—the

The resolution, a copy of which was also sent to McCaffery as well as to Pete Mc-Nearney; owner of the Blue Jays, asked the retention of the franchise on the grounds that the GE workers in particular and the public of Schenectady in general were entitled to retain a team in this city, particularly since that team was very well supported at home. The Blue Jays last year played before the second highest turnout of fans in he Canadian-American League, being surpassed at the Quebec Royals.

It is possible, of course, that someone made the discovery that in addition to its digestive property, "In Fact" is sugar coated propaganda. And while no one expects anyone to pay for propaganda, it is an indisputable fact that in this world of ours sugar is a fairly costly commodity, which no one in his right mind gives away for

PENSION PATTERN

The Philco Radio Co. ininformed IUE Local 101 officials recently that its contribution to the pension fund the first week of 1950 amounted to \$13,000 or more than one-third of the total amount needed for over 100 workers eligible to retire in

The company has been paying at the rate of 81/2 cents an hour for every hour worked since Jan. 1, 1950. The Philco plan is the pattern for the IUE Pension Program and is different from all known industrial. plans because it provides severance pay and death benefit as well as maximum pensions.
