

Union Speaker Repeats FDR's Bill of Rights

William Turnbull, first president of Local 301, who took part this week with Milo Lathrop in a Local 301 radio broadcast, used the occasion to remind the voters of Schenectady of the Economic Bill of Rights which the late President Franklin D. Roosevelt set forth over two

The eight-point program was presented by FDR in his message to Congress Jan. 11, 1944. It included: The right to a useful and remunera-

tive job in the industries, or shops or farms or mines of the nation.

The right to earn enough to provide adequate food and clothing and recre-

The right of every farmer to raise and sell his products at a return which will give him and his family a decent living.

The right of every businessman, large and small, to trade in an atmosphere of freedom from unfair competition and comination by monopolies at home and abroad.

The right of every family to a decent

THE PROPERTY.

The right to adequate medical care and the opportunity to achieve and en-

joy good health. The right to adequate protection from the economic fears of old age, sickness, accident and unemployment.

The right to a good education.

"That's FDR's Economic Bill of Rights," Turnbull said.

"It is already the program of every liberal, forward looking and progressive group in the country, including church people, professionals and many others. It is the program of the CIO".

Turnbull outlined the big job ahead of CIO-PAC in cooperation with the National Citizens Political Action Committee, consisting of non-union people, and the Independent Citizens Committee of the Arts, Sciences and Professions.

McAvoy said that after the UE won the General Electric strike, GE and other corporations succeeded through their Washington lobbyists in getting price ceilings lifted more than enough to offset the money they had to pay out in wage increases.

He described the lavish wining and cining methods of the manufacturers' lobby which he watched while he was UE legislative representative at the nation's capitol.

Representatives of GE and other great corporations are working day and night to destroy price control, to weaken labor and to act against the interests of the overwhelming majority of the people of the country, he told the ward

"If OPA is killed the cost of living will shoot up at least 50 per cent. There's no doubt about it."

McAvoy also warned that powerful forces are trying to bring on a third World War.

"Enough groups like these Schenectady PAC clubs can stop the drive against labor, the drive toward inflation, the drive toward war," he declared. "But it will take a tremendous amount of effort and a tremendous number of people. And there's no time to lose."

Bernard W. Kearney of Gloversville, who represents Schenectady in Congress, has one of the worst records in Washington, McAvoy declared.

McAvoy addressed meetings of the 9th Ward, the 10th Ward and the joint 7th and 13th Ward clubs.

Later she was sent to Building 29 where she was given work with mica and varnish which she could not do because the odor of the varnish made her violently ill.

The interviewer at Building 1 put it on the record that the woman had refused work offered and had resigned.

According to the Local 301 office, which has taken up the case with management as a grievance, the interviewer couldn't help knowing that the woman would be disqualified for unemployment insurance if the record said she quit voluntarily.

Contract Brings New UE Victory

A contract with the General Cable-Co., signed by the national UE, provides a general pay increase of 18 1/2 cents an hour, six paid holidays and the union shop and converts all piece work into day work on the basis of average earnings.

A competitor of GE, General Cable has a plant at Rome, N. Y. The contract was described at the recent District 3 UE conference as one of the best union contracts signed anywhere in the country this year.

Aid District Work

Bill Mastriani, chief shop steward of Local 301, will spend tomorrow in Utica helping with wage negotiations at the GE Tube Plant. After winning an election recently, UE is now the bargaining agent there.

Mastriani and Sadie Iovinella of the Local 301 staff were speakers this week at an organizing meeting of workers at the General Battery Drive Plant at Gloversville.

plies to women workers, it seems. Thirty girls were notified recently they would be laid-off for a week to disclipline them for leaving their machines five minutes before quitting time to wash up.

On receiving this report from a UE Board member, the union office made a complaint to management at once. The company hasn't answered yet.
