To the Executive Committee

Gentlemen.

This day completes a term of fifteen years' service in the Institution under your care. In accordance with my purpose made known some time since, I respectfully tender my resignation, to take place effect at the close of the present term. Memorandum.

The Executive Committee of the State Normal School at Albany, with sentiments of profound regret, accept the resignation of its President Joseph Alden D.D. LL.D. He came to us with a high reputation as a Scholar, an author and a teacher, and he goes from us with that reputation elevated and extended. After a term of service of fifteen years, notwithstanding the unanimous wish of the Committee, he remains firm in his determination to resign his charge. He leaves the School in an excent condition of efficiency and usefulness, a condition in a high degree due to his admirable administration of its affairs. He has been very successful in awakening, training and disciplining mind. Under his presidency his pupils have been taught to think, and have learned to develop thought in others. The Committee bear witness and well deserved testimony to the great value

of his long term of service.—to the living and lasting effect of his influence upon the faculty, the students, the graduates and upon the cause of education in this state. Such results as he has achieved here and elsewhere mark him as one of the few really great educators.

We congratulate Dr. Alden upon this success and upon all the success of a long life spent in the service and cause of education. We assure him that he retires from his present position round, loved and honored by all. We rejoice that he is still in the full possession of his vigorous mental and physical powers; and we cordially wish him many more years of active and happy years.

The subject of electing a president in place of Dr. Alton was then considered and (Mr. Waterbury having retired) it was unanimously resolved that Edward F. Waterbury A.M. a graduate of the School in 1849 be chosen President, his service to begin at the close of the present term. The compensation of the president was fixed at \$2500 per annum with the same privilege as to a residue as enjoyed by the present incumbent. Without further action the committee then adjourned.
