

Congress should quickly repudiate the House Un-American Activities Committee and end its existence, CIO President Philip Murray said in a letter sent recently to Congressional leaders.

After mentioning the Thomas-Rankin group's "probe" of the movie industry Murray declared:

"I suggest in all sincerity that the leaders of Congress cannot permit this type of performance to be conducted without rebuke or other appropriate ac-

"For many years now, the Un-American Activities Committee has constituted a shameful blot on the pages of American legislative action and a reflection upon our standards of decency and fair play."

He went on to say: "The new depths to which this committee has descended poses to the responsible leaders of Congress a sharp challenge—a challenge to maintain the name and standing of the institution they represent. It creates for leaders like yourself an obligation to the people of the country to act promptly and decisively to repudiate the committee and to terminate its existence once and for all."

Murray noted that in the past "labor has felt the whiplash of this committee and its predecessors." He said labor has seen the committee's willingness to "use the cloak of Congressional immunity for purposes of slander and character assassination—all to serve the political end of weakening and vilifying any progressive thought in our nation."

The committee issued the following statement on voting procedure:

"Members will sign the card bearing their check number, card number and name before voting. Any member whose name and number do not agree with the official card, such as a member whose check number was changed recently, will vote a paper ballot. He will place this ballot in a plain envelope and seal it, and this envelope will be placed in another envelope on which he will sign his name and check number and seal it. These envelopes will be checked against the records at the close of the polls, and ruled valid or invalid before any ballots are opened. The sealed envelopes which are ruled valid will be placed in a ballot box which will be opened and counted after all such challenged ballots have been ruled upon.

"The votes on the machines will be tallied immediately upon the closing of the polls.

"The chairman of the Election Committee shall declare the polls closed promptly at the hour stated above, but any members who may actually be in line waiting to vote at the time shall be permitted to vote."

UE Demands GE Arbitrate Cases

November 28, 1947

A demand that the General Electric Company submit a list of 25 grievances to arbitration in accordance with the contract was sent to J. W. Burnison last week by Joseph Turkowski, international representative of UE. Of the 25 grievances, 12 are from Local 301, involving disputes in Schenectady.

Turkowski's letter called for a reply by Nov. 30, and declared that "otherwise, this office will assume that the company is refusing to arbitrate."

The letter was a further attempt to pin down the company, which has been ducking arbitration for months. Turkowski pointed out in the letter that the union had been trying to get the cases arbitrated for many months. It is expected that this question will be an important issue in the coming contract negotiations.

Among the Schenectady cases listed in the arbitration demand are the union's claim that AER's on women's piece work jobs are figured incorrectly and should be raised; the company's refusal to comply with the contract provision under which many timing rates should have been raised through application of the step rate plan; the union's claim that the carboloy speed-up in the Turbine Division should have made increased earnings possible; the threat of punishment made against a Turbine Division shop steward whose group discussed the carboloy case while eating their lunch; and three cases involving groups who were denied regular Saturday and Sunday overtime though their jobs were not properly on continuous process.

"I do not like to see the Civil Liberties Union being used to break a union, especially through injection into a dispute which seems to have no civil liberties issue involved." Mr. Harvey wrote Nov. 20 in a letter to the national organization in New York city.

UE Local Wins Severance Pay

New York (UENS)—Severance pay based upon seniority totaling \$150,000 was won by UE Local 475 for the 1,800 workers who will be out of jobs Dec. 31 when the E. W. Bliss Manufacturing Co. closes its doors after 75 years of operation here. The company is transferring operations to its four western plants.
