Albany Dec. 16, 1856

Rev V. M. Rice, Chairman of the Executive Committee of the State Normal School,

Having on the 4th Inst. been elected Secretary of the Regents of the University, I hereby present my resignation as Principal of the State Normal School.

In communicating this to the Executive Committee, I beg you to express to them my high sense of their uniform courtesy & kind cooperation in all my efforts for the prosperity of the School and to assure them of my continued interest in its highest success.

The Professorship of the Natural Sciences having become vacant by the appointment of Prof. Cochran as Principal, the committee proceeded to consider the appointment of a successor. Several letters from the Professors in the

Military Academy at West Point were presented by the Chairman, highly recommending for the place Capt. Edward C. Boynton, of the U.S. Army, late assistant Professor of Chemistry in the Military Academy. After a full discussion on motion Capt. Boynton was unanimously appointed Professor of the Natural Sciences in the State Normal School to enter upon his duties at the commencement of the next term of the School. The Secretary was directed to inform Capt. Boynton of his appointment.

On motion Resolved that the thanks of the Committee be tendered to Prof. Cochran for his address delivered at the closing exercises on the 31 Ult. and that a copy be requested for publication.

Fort Moultrie Charleston, S. C.

Feb. 16, 1858.

Albany N.Y.

Dear Sir,

I have the honor to acknowledge the receipt this day of your letter of the 3rd inst. announcing that I had been unanimously elected Professor of Nat. Sciences in the State Normal School at Albany.

It is with profound regret, that I am constrained by the following circumstances, to decline this much coveted position. Previous to my departure from Florida in Dec. last, I received an invitation from the Board of Trustees of the University of Mississippi, to accept of the Chair Mineralogy Geology & Chemistry, then vacant in that Institution. It was accepted with a pledge on my part to enter upon the duties there if the conditions I dictated were strictly complied with, and as these involved the action of the State Legislature, no hopes were entertained by me of their acceptance.

During my absence in Florida, letters were forwarded to that point from Mississippi, announcing that my terms had been accepted, and that I had been elected to fill the vacant Chair on the 2nd of Jan. Prof. Davies was apprized of my action in the matter, and on my recent visit to Albany I repeated to him that I was most delicately situated and that I could not pledge myself to come to Albany until I had heard from Miss. and that I expected to hear at this point on my arrival. Disappointed in not receiving the expected letters here, I telegraphed at once to Miss in the expectation of a release and on the 10th inst. received notice in reply that I had been elected in Jan last, as before stated and that I was expected immediately.

Pledged as I was, and rendered so by my desire to abandon the Military Science, I could not without dishonor refuse to comply with an engagement I had framed myself, to enter upon the duties of Professor &c at Oxford, and I hastened at once to inform Prof. Davies, hoping thereby to apprise him before any action had been held at Albany.

I can only repeat here what I wrote Prof D-- that I much regret that I am deprived of my position at Albany, and that I at no time expected I should be called to Mine.

Permit me Sir to express my heart felt gratitude to the board, of which you are Secretary for the distinguished honor conferred upon me and to thank you personally for the kindly interest you have exhibited and expressed for my welfare.

The letter of Capt. Boynton being decisive of his not accepting the appointment of Prof of the Natural Sciences made at the last meeting of the Committee, after full deliberation on the subject and the reading of several communications recommending Mr. Edward F. D. Orton as possessing high qualifications for the position he was unanimously appointed to the vacant Professorship to enter on the duties at the earliest possible day.

Resolved that the salary of Miss Rice be increased to Five hundred dollars, commencing with the next term, it being understood that her entire services are to be given to the school.

Mr. Townsend, Mr. Woolworth and the Principal, were appointed a committee to make such changes in the arrangements of the rooms, and in the ventilation of the building during the next vacation, as on examination they may deem prac-

The minutes of the last meeting were read & approved.

The Superintendent submitted to the consideration of the Committee the expediency of increasing the charge for tuition in the Experimental department. After full discussion of the subject in consideration of the increased expenditures for the department, and that rates of tuition for corresponding studies in the Academies of the City very considerably exceed those in this School, it was resolved that from the commencement of the term in Feby next, the charge for tuition in the Experimental Department of the Normal School shall be Twenty five Dollars a year.

and that the Principal be directed to give due notice of this increase to the parents of pupils.

The following letter was read,

To the Executive Committee

of the State Normal School.

A year's absence from the Normal School has failed to restore to me the health necessary to resume teaching in the school; I must therefore entirely resign my place in it.

With this resignation allow me to offer you my most grateful thanks for the kindness and generosity you have so long extended to me.

The Secretary was directed to communicate to Miss Hance the acceptance of her resignation, with the expression of the deep regret of the committee that the School must be deprived of her long continued & valuable services, and the hope that her health may yet be so restored, that she will be able to resume her labors in the cause of education, which she has illustrated and adorned by so many years of active & effective duty.

The Principal was authorized to purchase a Piano for the use of the School at an expense not exceeding Three

Hundred dollars where the Committee adjourned.

Nov. 18, 1856

The Committee met at the call of the Chairman.

The Minutes of the last meeting were read and approved.

The Treasurer reported that at this date the balance to the credit of the school in the Bank of Albany is and that he has not means at his command for paying the salaries of the teachers one month of which will be due on the 18th Inst. Mr. Townsend submitted the following.

Whereas from the failure of the Legislature to pass the Annual Appropriation bill at its last Session, the Treasury of the Institution has become exhausted, and there remains no other mode of supporting the school until the usual appropriations are made, than borrowing the money required, on the individual responsibility of the members of the Executive Committee, it is hereby Resolved that the Treasurer be authorized to borrow in the manner proposed, a sum not exceeding three thousand dollars and that the said loan be paid out of the first moneys appropriated by the legislature.

This resolution, after due consideration, was unanimously adopted.

The Chairman reported the resignation of Mr Amos N. Kellogg Superintendent of the Experimental department, he having been invited to the Principalship of the New Jersey Preparatory, or French Normal School. The chairman further stated that in consequence of Mr Kellogg's withdrawing from the school on only a few days notice, and when two members of the committee were absent from the city so that a quorum could not be convened, on consultation with Mr. Townsend and the Principal he had Mr. William D. Huntley of Buffalo to take charge of the School--that from his intimate acquaintance with Mr Huntley as an experienced and successful teacher, he believed him eminently qualified for the charge of the Experimental Department--Whereupon it was unanimously resolved that the appointment of Mr. Huntley be confirmed.

The Chairman further stated that on the first intimation of Mr. Kellogg's resignation, correspondence was opened with several gentlemen with the view of securing a proper teacher, and that an expense of about forty five Dollars had thus been incurred.

After full discussion the following resolution was unanimously adopted.

Resolved that while this committee entertain a high sense of the fidelity and success with which Mr. Kellogg has conducted the instruction and discipline of the Experimental School they cannot but regard with disapprobation his leaving his position in the school before his resignation could be formally acted on by this Board

or a successor could be appointed--thus subjecting the committee to much embarrassment and inconvenience.

It was further resolved that the Treasurer be directed, after having ascertained the sum which may be due to Mr. Kellogg for his services in the School the present term, to deduct therefrom such part of the expense which has been incurred in obtaining a successor as he shall deem just & proper.

Mr. Austin presented the following resolution which was unanimously adopted.

Resolved that the Secretary be directed to communicate to the Professors and teachers of the School, the resolution of this Committee that they will not except at their own option, accept the resignation of any Professor or teacher, without a previous notice of two months, which notice shall expire with the close of a term.

The Principal was requested to prepare the draft of the Annual Report to the legislature.

The Secretary was added to the committee on text books, in place of the late Secretary and the committee adjourned.
