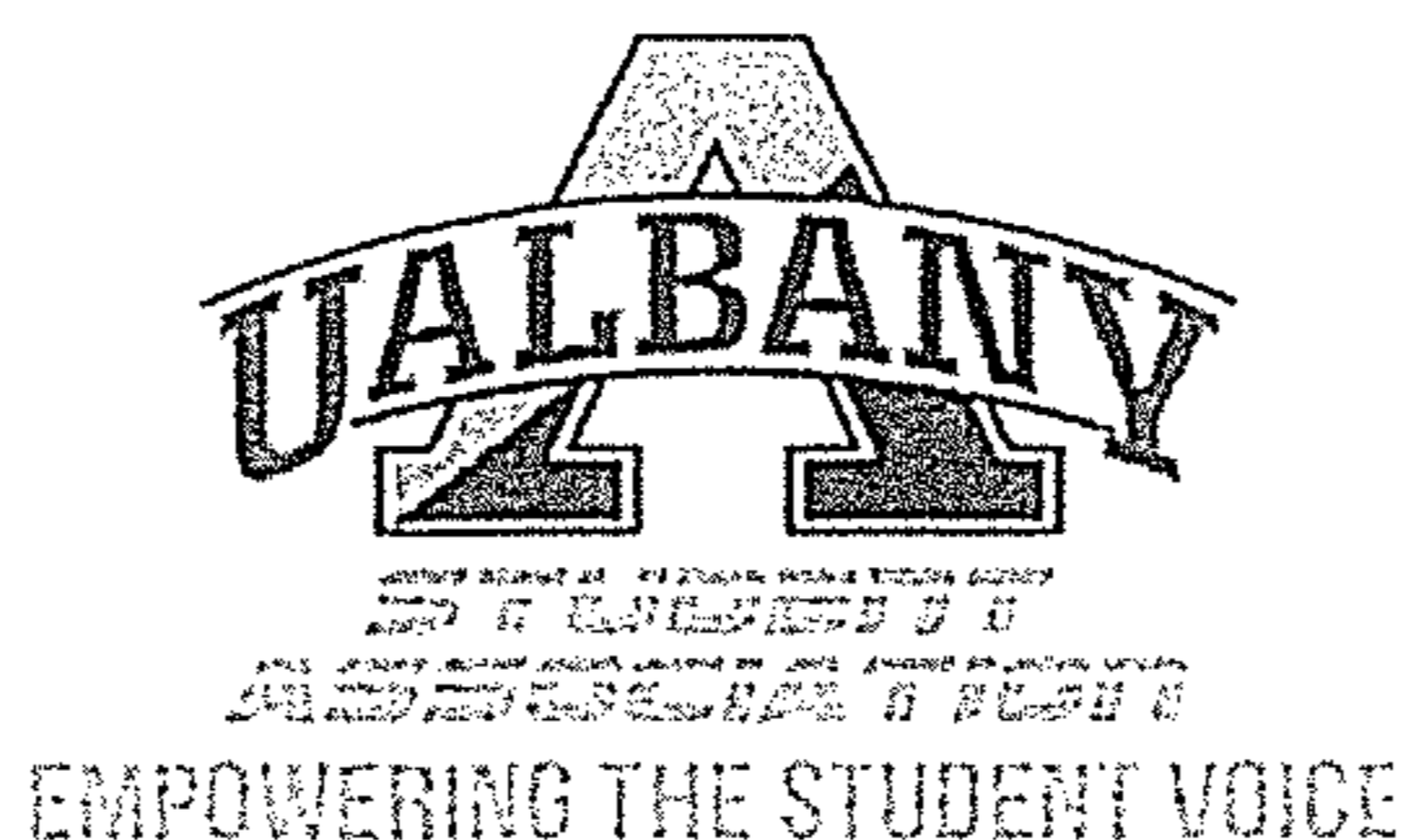

Be it hereby proposed that the following be enacted:

- I. WHEREAS, The Supreme Court Justices Petra Holness, Chidiogo Igboekwe, and Andrew Thomas of the Student Association enacted an injunction on September 25th, 2019 on Senate bill S1920-44; and
- II. WHEREAS, The Student Association Constitution and Bylaws outline that the Supreme Court must hold hearings and adhere to proper filing procedure for any injunction; and
- III. WHEREAS, The Oversight and Reform Committee has determined, following a series of hearings with the Supreme Court Justices, that the Supreme Court did not hold a proper hearing on the injunction and did not adhere to proper filing procedure; and
- IV. WHEREAS, The Student Association, as an exemplar of proper American governance, is empowered to uphold a system of checks and balances upon the branches of government and to ensure inalienable human rights, such that the right to free speech and fair hearings; and
- V. THEREFORE BE IT RESOLVED, That Justices Petra Holness, Chidiogo Igboekwe, and Andrew Thomas of the Supreme Court are censured on matters pertaining to an improper injunction that occurred on September 25th of 2019; and
- VI. BE IT FURTHER RESOLVED, That all Student Association bylaws, precedents, and the Constitution be carefully examined by each Student Association officer before the execution of any action; and
- VII. BE IT FINALLY RESOLVED, That a copy of this resolution be sent to Nicholas Chin, Chairman of the Student Association Senate, Desann Chin-Carty, President of the Student Association.
