O. Box 3002, Albany, New York hereby state for an agreement regarding the filming and production of a video documentary about Capital District Coalition Against Apartheid and Racism and its history.

- 1. The COALITION and its' member will cooperate in providing MARTIN access to clipping archives, organizational files, personal recollections, resource people, etc. All COALITION materials remain the property of the COALITION or individual member.
- 2. The COALITION is entitled to copies at cost of all "raw" video footage filmed by MARTIN or provided to him by other source.
- 3. No documentary or other video product shall be released or distributed to the public or any third party by MARTIN without the written agreement of the COALITION.
- 4. Any obligation of the COALTION to participate financially in the expenses of the production of this documentary shall be in writing and signed and acknowledged by two (2) members of the Coalition Steering Committee.



Dear Anne,

At the recent January CDCAAR meeting, members reviewed a number of activities we had sponsored or worked on in the past several weeks. Among these events was the Anti Klan Counter Rally cosponsored by the NAACP and the CDCAAR.

What follows is a summary of the strengths and weaknesses noted by some of our members.

It was felt that the event was an overwhelming success. The attendance, 1,500, went far beyond our expectations and the crowd was extremely diversified. In part this could be attributed to the endorsement of over 30 organizers.

It was felt that the people responded quickly to the call for assistance, the Marshalls were well trained and much was accomplished in a very short period of time.

Advance press was good and comprehensive. The working relationship between the NAACP and CDCAAR was seen to be positive.

The goal of the counter rally had been to provide a way for broad sectors of the community to concretely unify behind the Klan in a peaceful way. That goal was achieved despite the altercations that occurred after the rally was over.

There were a number of areas that we felt needed strengthening and could be instructive for future events. They are:

- Marshall Buddy plan may have been too restrictive and may have left some Marshalls feeling that they couldn't move without their buddies.
- 2. More Marshalls were needed due to the size of the crowd.
- 3. Marshalls may have been positioned incorrectly at one point (outside the picket line and spectators).

- 4. Counter Rally area become too defuse and spread out
- 5. More security was needed at the podium. Speakers' backs were not covered. Marshalls need to provide a buffer between speakers and the crowd i.e. preventing open access to the microphone.
- More thought should be given to contingency plans for heckling, being overpowered by other megaphones, and dispersal.
- 7. More thought to be given to youth representatives particularly African American youth expressing different points of view (looked like we were shutting youth out). Most felt this was important but must be dealt with realistically. The inclusion of more youth as Marshalls was also suggested.

Some have also mentioned that the lack of an early and obvious presence by the Capital Police might have led demonstrators to feel as though they had access to Klan members who appeared. Also better sound system needed. Walkie talkies great idea but they were dead.

It was agreed that we were not prepared for the incredible size of the crowd or the Klan not appearing in an organized manner.

Media after the event focused on "violence" and did not give the whole picture, although it was quite clear from all accounts. which included most New York papers, The Amsterdam News, Daily World, Jewish Forward, New York Times and local papers, that Albany said no to the Klan.

It was suggested that we (CDCAAR and NAACP) write our own review of the event, perhaps for the Scene, so that we have the final analysis and not the mainstream media. In spite of the objections of the naysayers, we concluded that we "did the right thing" and the 1,500 people who were there became proof of that.

In closing we say to you Anne and members of your board that we were pleased to have collaborated with the NAACP Albany Branch on such an important issue. We look forward to working with you in the future.

nor pured bes Recent revelations of the South African government's covert funding to Gatsha Buthelezi's Inkatha Party come as no surprise to anyone who has closely studied the South African scene.

Buthelezi was appointed by the regime to become "Chief" of the Kwazulu homeland, an apartheid structure established to disenfranchise Black South Africans. He has been doing the government bidding for many years. He has worked against everything the African National Congress and the anti-apartheid movement in South Africa have struggled for. He has attempted to sabotage the sanctions campaign internationally. He has organized Inkatha thugs to attack those who participate in rent strikes or boycotts. His death squads have hacked and shot people randomly on buses and trains. They have also targeted anyone suspected of sympathizing with the ANC. The police and security forces have been seen assisting them in these attacks.

In your July 31st editorial you say that by secretly funding Inkatha, de Klerk did the "wrong thing for the right reasons". You say that "the covert payment helped level the playing field between the non violent antimarxist Chief Buthelezi, who opposed sanctions but whose organization could not hope to match the world-wide network enjoyed by the pro Soviet ANC which supported

Posing Buthelezi and Mandela as equal players in the anti-apartheid movement with different perspectives on violence and

It is true that the African National Congress has received support for its'struggle from the Soviet Union. It also got support from the Scandinavian countries, most African nations and millons of people around the world. Does unis make the ANC "pro Soviet" and therefore not worthy of support? Does this make Mandela a bad guy and Buthelezi a good quy.

What is the justification for concluding that Buthelezi is . non violent. Should it be inferred then, that the ANC is

It is true that the ANC has long conducted an armed struggle to liberate their country, much like the patriots who founded this country, much like many others who fight for their freedom. But the ANC has always seen the armed struggle as a last resort and has never called for the kind of horrific random violence that Inkatha is guilty of.

In fact the ANC, in an extraordinary move has put it's military struggle on hold, an indication of the seriousness with which it regards the negotiation process.

In addition, Mandela and the ANC has been successful at calling for sanctions and isolating South Africa because apartheid is a crime against humanity and sanctions have been an effective weapon against apartheid. The popularity of the demonstrated over and over.


By comparison, Buthelezi has recruited members into Inkatha with force, intimidation and the giving of "favors" to those who live in his homeland; favors like water, electricity, schooling and medical care. The Inkatha organization has created so much fear and terror inside the country that the very process of takes responsibility for stopping Inkatha, not funding it, then and only then will the playing field be leveled.

The situation in South Africa is extremely dynamic now and the ANC along with other anti apartheid organizations will have to make many difficult decisions in the months to come. One such decision is the need for the ANC to establish self defense units in the township to defend the people against Inkatha attacks. Another has been the renewal of the call for sanctions.

We are hopeful in the future that rather than leaping to defend President De Klerk the <u>Times Union</u> will spend a little more time trying to understand the ANC position and why it has to resort to certain measures on the road to freedom.

Honorable Ambassador Huaraka

Apartheid and Racism. By way of introduction, we are a grassroots solidarity group in upstate New York. (Enclosed you will find some materials about our organization) We have been in existence for ten years and during that time, the solidarity struggle with the people of Namibia for independence has been one major focus of our work. We have sponsored SWAPO speakers at public forums in Albany and took a very active part in the Dollars for Democracy in Namibia campaign. We worked to include the church, labor, government and student communities in Namibia work. In many ways too numerous to mention here, we have been a friend of SWAPO.

Last month a delegation of ten Namibian legislators were in the Capital District, we believe at the sponsorship of the New York State African American Institute and the Rockefeller Institute. They were apparently in Albany for approximately two weeks. During that time, no one informed us of their presence here or included us in any of the activities that were planned around their visit. In fact, we only found out that they were here after they left, through a chance conversation with someone in the commmunity who had met with them. We find this to be an untenable situation.

A first hand report from Namibian legislators would have be en extremely beneficial to anti-apartheid activists in Albany who remain activiely involved in the struggle for justice in Southern Africa. To hear of the effects of independence on Namibia would have helped to broaden our vision and strengthen our continuing work and commitment.

Honorable Ambassador, is there any way that an oversight like this could be prevented in the future? Is it possible that the staff of the Namibian Mission could be made aware of the itinerary of similar delegations and in turn notify solidarity groups of impending visits to their cities? We repectfully make this request out of a sincere desire to enhance the efforts of U.S. anti-apartheid work.





With regard to the visit of the ten Parliamentarians, I am pleased to furnish you with some background information concerning this visit. The Parliamentarians were invited by the State University of New York to come and study legislative practices in the United States.
