Kaiser Steel Signs Separate Pact

The first break in the steel strike came recently as the Kaiser Steel Corporation agreed to a separate agreement which was mutually satisfactory to labor and the corporation.

Jubilant David McDonald, President of the Steelworkers' Union, ordered the 8,500 Kaiser workers back to their jobs at Fontana, California, immediately. He called on the rest of the steel industry to raise of \$225.00 per year for this follow suit and accept the same package, which they refused, calling man. it inflationary.

The estimated package settlement comes to about 21½ cents for \$4.868.65 Check the 2 years of the contract.



It's that much harder for us. especially the bigger companies, to argue that we can't give what Kaiser gave."

The effect this breach in the solid front will have on the other companies is likely to be considerable. For one thing, the Steelworkers will not be at all inclined to accept terms from the other companies less than Kaiser offered. For another, there is public opinion to be considered and the public will want to know why a settlement acceptable to Kaiser _ isn't acceptable to the rest.
