Biography

Robert Keller - Born June 12, 1901, at Trebbin, Germany

Annemarie Keller - Born Schulze, January 23, 1905 in Dresden, Germany

Tow children, one 9 years, the other 6 months old.

I have known Robert Keller and his wife since 1924, and have been their personal friend since then. Both Mr. and Mrs. Keller are persons of the finest character. They have been politically active since their youth, and have always fought with all their strength for a democratic and republican Germany. They were always highly thought of because of their unselfish character, and their sense of duty. Through their fearless and ceaseless work against German National Socialism before and after 1933 they belong, undoubtedly, to the group of people whose liberty and life is in danger.

From my own knowledge and with full conviction I am able to say the following about Robert Keller's development:

From 1919 on, K. was active in the "Jungsozialistische Vereinigung" which formed a part of the German Social Democratic Party. The task of this organization was to win the German youth for Democracy and the Weimar Republic, and it included the members of the Social Democratic Party between 20 and 25 years. K. was a member of the National Committee; he was a public speaker and propagandist, and collaborator of the monthly periodical "Jungsozialistische Blaetter."

Through this activity he came to the attention of the Executive Committee of the Social Democratic Party. At that time we were looking for young people who possessed the personal and intellectual qualifications for a further training as functionaries in the labor movement. On my suggestion K. got a job in the bureau of the Social Democratic Reichstag group which was under my supervision. He worked with us for about a year. My opinion of Keller's character and abilities which I mentioned above was justified during this collaboration.

After Keller had finished this training he got a job in the bureau of the Social Democratic Party in Kiel. When, in 1928, I became a DK candidate for the Reichstag elections in the district of Halle I asked Keller to help me. He complied with my wish and took over the organizational conduct, at first only for a part of this district, the industrial region of Eisleben, and later on for the whole district of Halle. This was a very difficult job which required not only a good deal of knowledge but also personal courage. Halle is a part of the large middle German industrial area where the "Leuna-Werk" of the IG Farben A.G. and numerous other important defense industries are located. The Social Democratic Party was comparatively weak in this electoral district, the Communists and National Socialists on the other hand were very strong. It was mainly due to Keller's efforts that the Social Democratic Party gained some ground in this and the following years.

In 1932 and 1933 political activity for the H&O&D Social Democratic Party meant immediate personal danger. In almost every meeting there were serious fights in which very often some people were so badly wounded that they died. In February 1933, when he came home from a meeting, Keller was attacked by National Socialists; his

friend was hurt so badly that he lost his seeing power in one eye. On March 10, 1933 the Nazis attacked the "Volkshaus" in Eisleben. Everyone was shocked by the event; there were several -- I think six -- dead and many wounded. Keller was active in the defense from this assault. He had, therefore, to give up his home, and to escape because the police did not protect him any more.

During the last months of his stay in Germany, in the spring and summer of 1933, Keller founded and left an illegal (underground) Social Democratic group with the name "Roter Stosstrupp". Its members were young and active Social Democrats who in spite of the breakdown of the old Social Democratic Party were anxious to contribute to the defeat of the National Socialist dictatorship, and to the restoration of democracy in Germany. Upon request of his friends Keller left Germany and went abroad in order to organize help for this work. In September 1933, or about that time, he went to Czechoslovakia. There he took residence only a few miles away from the German border so that the communication with his friends and the district of Halle was facilitated. Keller financed his project from his own means; he had made an inheritance of about 10,000 Reichsmark. He gave most of this money for the underground work. He never got any remuneration for his work. The many trials against the members of the "Roter Stosstrupp", and the heavy sentences tell the story of the effectiveness of their work. In every trial the Gestapo mentioned that Keller was really the person most guilty. As a result, he was deprived of his German citizenship. (See "Deutscher Reichsanzeiger" #22 of January 27, 1933).

Friends of mine from the district of Halle let me know that Keller and his activities are still in high esteem among the anti-Nazis there.

Keller and his wife are Aryan, and come from a middle-class family. This makes the Nazis hate them the more. There is no doubt that they are in grave danger because their activities in and outside of Germany are considered as "Landesverrat" (high treason) on which the death penalty stands.

1. That I am a United States citizen.
2. That I have reason to believe the Robert Keller and his family, residing in unoccupied France, German citizens (expatriated), are in imminent danger.
3. That I do not believe that the activities of Robert Keller and his family, if admitted to this country will be inimical to the United States.
4. That I undertake to keep myself informed, concerning the activities of Robert Keller and his family after admission to the United States and to inform the Immigration and Naturalization Service concerning any such activities, not a matter of public knowledge, which may appear to be inimical to the United States.
5. That I have reason to believe in the good faith of Robert Keller and his family in attempting to fulfill any obligation they may assume with respect to leaving the United States at the expiration of any temporary period for which they may be admitted, and that I shall assist them in any way possible within my power to fulfill such obligation.
6. That this affidavit is made by me for the purpose of inducing the American Consul to issue the proper visa to the above mentioned Robert Keller and family, and the Immigration Authorities to admit such persons to the United States.

ADDENDUM

Robert Keller and his wife and one child were able to leave Czechoslovakia in May or June 1938 following the Austrian Anschluss and before the Munich conference. Through the German Social Democratic Party in exile Mr. Keller and his family received visas to go to France in order to escape the dangers in Czechoslovakia as the German occupation became more imminent.

In Paris Mr. Keller was able to ~~XXXXX~~ live from the balance of his own money (he had inherited a considerable amount and had been able to take it out of Germany before the strict laws were imposed.) Realizing the need to equip himself for a new life Mr. Keller devoted his time to attending courses at the Alliance Française where he completed a course of French for teachers and received a certificate that would qualify him to serve as a French teacher in countries other than France. Mr. Keller was interned with most other German men refugees at the start of the war in September 1939. Early in 1940 he was given an opportunity to enlist as a "prestataire" with the French Army, that is, to serve in one of the foreign corps. Mr. Keller was with the French Army until the collapse after which time he was able to join his family in unoccupied France.

Keller is a highly appreciable person who not only suffered for his democratic ideals but supported friends in Germany who carried on the fight against Hitler when he himself was forced to leave Germany and, furthermore, helped other refugees in Czechoslovakia and in France as long as he was able to.



Mother died 1907 in Berlin.

Keller has neither brothers nor sisters.

Parents of Annemarie Keller:

Father died in May 1929 in Berlin.

Mother was living in a home for aged people in Berlin-Zehlendorf. Mrs Keller was not in contact with her since summer 1939.

Two brothers are living in Berlin. Mrs Keller has no contacts with them since 1925 and 1933 respectively.

I am convinced that the visa applicants are friendly to the United States and well disposed toward the good order and happiness of its people, and that they are coming to the United States for a lawful purpose and will not engage in any activity contrary to the public safety of the United States. The reasons for this belief are as follows:

Robert and Annemarie Keller have been active members of the German Social Democratic Party. They have fought against the doctrines of Nazism and Communism and as a result of their expressed opposition to these doctrines left Germany already in 1933. They continued to fight courageously against all Nazi doctrines and, subsequently were deprived of German citizenship.

They have broken every contact with their relatives in Germany.



Das Visa ist im April von Washington bewilligt worden. Durch ein Versehen der französischen Postbehörde wurde das Telegramm des amerikanischen Konsulates in Lyon mit der Vorladung nicht bestellt. 

Many thanks for your letter. Unfortunately, we have no information regarding the Keller family and have not heard from our Marseille Office for more than a week. We have as you know repeatedly guaranteed the transportation of the Kellers but it is questionable whether they were able to avail themselves of the opportunity to reach Portugal on time.

Regarding Josef and Philine Justus - We have never been able to submit the case to the State Department after July 1st, 1941 because we were unable to secure new affidavits for the family. The affidavits given prior to July 1st, 1941, were considered weak and it was doubtful whether they could have been found adequate.

Inasmuch as there is still a possibility that visas may be granted providing applicants can find transportation facilities, I shall be very happy to work on the case if you will let me know who is willing to give the necessary affidavits of support.

Ihren Brief vom 7. cr. fand ich bei meiner Ankunft in Scattergood vor. Ich freue mich, dass Sie bereits an Rosenfelder geschrieben haben und mich seine Antwort wissen lassen wollen.

Hinsichtlich der Erledigung der technischen Einzelheiten haben wir uns offenbar missverstanden, indem Sie unsere Abreden nur auf den Fall eines Mexiko-Visums für RIESS, ich dagegen auf den Fall selbst bezogen und daher Eva Lewinsky im Sinne meiner Abreden mit Ihnen informierte, als sich die Unmöglichkeit ergab, RIESS die Einwanderung nach Mexiko zu ebnen. Ich war tatsächlich der Meinung, dass Sie gemeinsam mit der I.R.A. den Fall weiterbearbeiten wollten.

Letztlich ist es natürlich für RIESS nicht von entscheidender Bedeutung, ob die Bemühungen für sein Immigration Visum von Ihnen allein oder von der I.R.A. allein oder in Zusammenarbeit zwischen Ihnen und der I.R.A. fortgesetzt werden. Von Bedeutung ist lediglich, dass diese Bemühungen fortgesetzt und trotz der neuen vielseitigen Schwierigkeiten mit unermüdlicher Ausdauer fortgesetzt werden.

Wir sind nach einer recht angenehmen und sehr interessanten Bus-Überlandfahrt vorgestern in Scattergood angekommen. Ob es uns hier nach Wunsch gehen wird, lässt sich erst nach Ablauf einiger Wochen überschauen.

Lieben Genosse Keller,

herzlichen Dank fuer Ihren Brief vom 3. und den Bericht ueber Scattergood. Es tut mir sehr leid, dass Sie offenbar nicht ganz gut gefahren sind. Allerdings kann es sein, dass, wie in manchen anderen Faellen, die Quacker sich fuer Ihr weiteres Schicksal interessieren, und dass irgend etwas Besseres dabei noch herauskommen kann. Schade waere es, wenn die ganze Zeit umsonst verbracht wuerde!

Hedwig Wachenheim hat mich seinerzeit angerufen und mir gesagt, dass sie sich wegen des Affidavits fuer Ritter mit Mr. Rosenfelden in Verbindung setzen wuerde. Dann habe ich nichts wieder von ihr gehoert. Aus Gruenden, die ich Ihnen sicher nicht im einzelnen darzustellen brauche, ist es auch nicht ganz einfach fuer mich, sie zu fragen, ob sie etwas erreicht hat. Es muss erst etwas Zeit vergehen, bevor ich mein Interesse an der Sache wieder anmelden kann.

Wegen Mexiko und Cuba hat sich nichts Gutes in der letzten Zeit ergeben. Im Gegenteil, wie Sie sicher gelesen haben, hat es vor etwa zwei Wochen ein allgemeines Dekret sowohl in Cuba wie in Mexiko gegeben, wonach die Visenausgabe, bis auf ganz wenige Ausnahmen, allgemein gesperrt ist. Ja, wonach sogar schon vorher bewilligte Visen nicht mehr gueltig sind. Kurz danach oeffnete sich die Tuer dann wieder ein ganz klein wenig - ich meine die Hoffnung, dass es vielleicht doch noch nicht ganz aus sein moegt. Und wir sind im Augenblick dabei, naehrer auszuprobieren, ob ein Projekt, fuer viel Geld mexikanische Visen zu bekommen, reael ist. Aber das ist noch voellig ungewiss, und im Augenblick ist zu konkreter Hoffnung sicher kein Anlass. Sowie sich die Lage bessern sollte, lasse ich Sie das gleich wissen.

Alles Gute Ihnen - hoffentlich erholen sich die Kinder wenigstens gut in dieser Zeit. Wuerden Sie Marie Juchacz sehr herzlich von mir gruessen? Mit vielen guten Gruessen an Sie und Ihre Familie und andere Freunde.

Scattergood

4.6.1/2

Scattergood Hostel liegt 11 Meilen östlich von Iowa City, das 240 Meilen westlich Chicago gelegen ist. Es liegt also nahe der Ostgrenze des State Iowa, der fast ausschliesslich landwirtschaftlichen Charakter hat. Der hiesige östliche Teil erinnert landschaftlich an Mittel-Pommern: Getreidefelder, Weiden, Wiesen, ein Wald, keine Seen, nur selten ein schmales Wassergerinne. Stellenweise, so wie Scattergood, ist das Land flach gewellt. Baumgruppen, von denen die Farmhäuser umgeben sind, bringen etwas Leben in die Gleichförmigkeit der Landschaft. Neben Getreidebau viel Viehzucht (Rinder, Schweine, Schafe). Iowa City war einst die Hauptstadt des State Iowa. Es beherbergt die State University und hat 15000 Einwohner, von denen Studenten und das Lehrpersonal einen erheblichen Prozentsatz stellen. Die Stadt hat eine Radiostation mit ganzzeitigem Programm, fünf Kinos, viele Warenhäuser. Sie wirkt städtischer als z.B. Ebenleben, das 25000 Einwohner hat.

Scattergood Hostel war bis 1939 eine Schule für Kinder aus Quakersfamilien. Dann wurde es von der Quakers-Zentralistelle in Philadelphia seiner getroffenen Bestimmung zugeführt. In den drei Jahren hat es insgesamt 200 Personen (deutsche, österreichische, tschechische Flüchtlinge) beherbergt.

Das Heim (zwei Wohngebäude, ein kleines Wohnhaus des Hausmeisters, ein primitives Meeting House und ein schuppenartiger Bau, der als Jugendherberge eingerichtet ist) liegt innerhalb eines grossen umzäunten Grundstückes: grosse Wiese, Gartenland, zwei Stroifen Acker für Maisenbau, Weideland. Feld und Garten werden vom Hausmeister-Ehepaar bewirtschaftet, das auch den Viehbestand (etliche Schafe, 10 Schweine, einige Hühner, ein Pferd) versorgt.

Im Hauptgebäude sind in jedem der beiden Stockwerke 5-6 Wohnzimmer und 2 Essräume; im Erdgeschoss sind zwei modern eingerichtete Küchen und der Speisesaal, im mittleren Stockwerk der grosse Living Room und eine umfangreiche Bibliothek, die auch etliche französische und deutsche Bücher enthält. Im Living Room liegen u.a. die "New York Times", drei lokale Tageszeitungen, "Life", "Time", "Reader's Digest" und der "Aufbau" aus. Im zweiten Wohngebäude ist eine Waschküche mit allem Komfort. Die Wohnzimmer sind bescheiden, aber nett und ausreichend möbliert. Jede Familie hat ihr eigenes Zimmer. Alleinstehende Personen bewohnen ein Zimmer zu zweit oder dritt. Neben einem grossen Radioapparat im Living Room haben einige Wohnzimmer (leider nicht das unerträgliche) Radios.

Das zuständige Committee allein oder Verwandte allein oder Committee und Verwandte gemeinsam zahlen den Quakers je Person und Woche sieben Dollars (1.50 je Kind), von denen 2 \$ je Woche jedem erwachsenen Gast als Taschengeld ausgezahlt werden. Diese Geldgeber bestimmen die Dauer des Aufenthaltes im Heim, der in der Regel 3-5 Monate dauert. Es gibt aber auch Fälle längeren Aufenthaltes. Die Quakers stellen den Staff, unterhalten Gebäude und Grundstück und besolden den Hausmeister.

Die Heimbelegschaft hält sich gegenwärtig mit 23 Personen erheblich unter dem Normalstand. Von diesen 23 Leuten sind 5 im Kindesalter; von den 18 anderen sind 11 älter als 45 Jahre. Elf sind politische Flüchtlinge.

Die Beköstigung (Breakfast um 7,15 Uhr, Lunch um 12,30 und Dinner um 18,30 Uhr) ist einfach, aber ausreichend (etwas fleischarm). Zwischen den Mahlzeiten kann sich jeder in beliebiger Menge Milch nehmen.

Für die Kinder ist Scattergood eine gute Sommerfrische. Die schulpflichtigen Kinder werden um 8,15 Uhr vor dem Heim vom School Bus aufgenommen und um 16,30 Uhr wieder heimgebracht. Die Schule ist in West Branch (2 Meilen vom Heim entfernt).

Der Unterricht gliedert sich in individuelle Einzelstunden und in meetings. Lehr- und zugleich Verwaltungspersonal sind die sechs (augenblicklich vorübergehend sieben) Mitglieder des Staff. Von ihnen sind drei Mitglieder der Quakers, die anderen besoldete Kräfte. Mit Ausnahme der Leiterin sind sie alle unter 35 Jahre alt. Zwei von ihnen sprechen perfekt französisch. Dem Unterrichtsplan gemäss soll jeder Beigast wöchentlich drei Einzelstunden haben. Infolge

zu starker Beanspruchung der Staff-Mitglieder durch andere Verpflichtungen wird aber dieser Plan nicht immer eingehalten. Da nur je ein männliches und weibliches Staff-Mitglied im Unterrichten geschult sind, kann für die Mehrheit der Heimbewohner die Wirksamkeit des Unterrichtes nicht sehr hoch veranschlagt werden. Jedes der 6 Staff-Mitglieder hat 3 Eingelschüler. Ein Wechsel in der

464

Person des Lehrers gehört nicht zur Regel. Es ist also eine Sache des Glückes, ob man einem der beiden guten Lehrer zugewiesen wird. Wir hatten dieses Glück nicht. Die meetings verteilen sich auf Nachmittags- und Abendstunden: Rhetory, Grammar, Phonetic, Public Speaking, kurze Vorträge von Gästen aus Iowa City oder aus anderen Orten. Der Sonntag und ein Abend eines Wochentages sind meetings-frei. Der in den Einzelstunden und meetings gebotene Lehrstoff bedarf gründlicher individueller Verarbeitung. Dazu gehört Zeit (siehe weiter unten). Mangels eines ausreichenden Wortschatzes ist trotz häufiger Ermahnungen seitens der Staff-Mitglieder unter den Heiminsassen deutsch die Umgangssprache. Nur während der mit dem Staff gemeinsamen Mahlzeiten wird strenger darauf geachtet, dass englisch gesprochen wird.

Zur Teilnahme an religiösen Meeting wird niemand veranlasst. Nach dem Breakfast geht, wer will, ins Meeting House. Dort sitzt man 10 Minuten still; kein Lied, kein Gebet, keine Predigt. Abgesehen von diesem Brauch verläuft jeder Tag ohne religiöse Handlungen.

Der wunde Punkt ist die Aufteilung der jobs. Für die notwendigen Arbeiten im Hause und ausserhalb des Hauses stehen theoretisch die 18 Gäste und die 7 Mitglieder des Staff zur Verfügung. Von diesen 25 Personen fallen aber mehrere wegen Alters oder Krankheit gänzlich oder zeitweise aus. So sind z.B. für die zahlreichen men's works nur die beiden männlichen Staff-Mitglieder und von den acht männlichen Gästen nur drei arbeitsfähig. Dieser arbeitsfähige männliche Teil arbeitet vormittags durchgängig (Renovierungsarbeiten aller Art, wobei mir das luftige Los des clean the windows zugefallen ist - und es gibt hier unheimlich viele windows) und ist zusätzlich bei der allgemeinen Arbeit innerhalb des Hauses eingeteilt. Diese tägliche Hausarbeit ist kunstgerecht aufgeteilt in Breakfast preparation (2 Personen), Breakfast dishes 2 (Aufwasch des Geschirrs), Lunch preparation (2 Frauen), Lunch dishes 3, Lunch clean up 2 (Töpfe, Pfannen scheuern), Dinner preparation (2 Frauen), Dinner dishes 3, Dinner clean up 3, nach jeder Mahlzeit reinigen des Speisesaals je 1, Reinigen der halls and stairs 1, des Living Room und der Library 1, Washing 2, Ironing 1 und Mangling 1. Das sind also 27 tägliche Einzeljobs. Da es mangels ausreichender Arbeitskräfte nicht gelingen kann, von diesen aufgezählten jobs jene

wählen, die in die Vormittagsstunden fallen, ist der arbeitsfähige männliche Teil zusätzlich nachmittags oder abends 1-2 Stunden beschäftigt (abgesehen von den Unterrichtsstunden). So ergibt sich ein krasses Missverhältnis hinsichtlich der Freizeit, soll heißen bezüglich jener Zeit, die zum Lernen (individuelles Verarbeiten des Lehrstoffes) zur Verfügung steht. So gibt es Gäste, die täglich 1-2 Stunden job machen und die ganze restliche Zeit zum Lernen verfügbar haben, und andere, die nur den Sonntag und an Wochentagen nur 2-3 Stunden Lernzeit zwischen jobs und Unterricht herauspressen können. Hier ist auch der Schlüssel zu den völlig widersprüchsvollen Urteilen, die wir in New York über Scattergood und die Wirksamkeit seiner Schulung in englischer Sprache gehört haben.

Eine wohl durchdachte Organisation des Heimes müsste für die Gäste mit kurzbefristetem Aufenthalt genügend Lern- und Lesezzeit übrig lassen, um das Ziel des Heimaufenthaltes wirklich erreichen zu können.

Über die Chancen und die Art einer Arbeitsvermittlung durch die hiesigen Quakers kann ich noch nicht abschliessend urteilen. Scheinbar beschränken sich aber ihre Verbindungen und Möglichkeiten auf Universitätskreise in Chicago und Iowa City und auf Farmer-Beziehungen im State Iowa.

Résumé: Für Kinder ist Scattergood ein idealer Platz. Für ältere oder kranke Personen ist es ein guter Aufenthalt mit der Chance, englisch zu erlernen. Für Personen in unserer Lage kann Scattergood nicht empfohlen werden, weil

1) bei kurzbefristetem Aufenthalt das Ziel des Heimes (Englisch lernen) unter den beschriebenen Umständen nicht erreicht werden kann, 2) der landwirtschaftliche State Iowa keinen grossen Spielraum für Starts ausserhalb der Landwirtschaft lässt, 3) der gleiche finanzielle Aufwand eines Committees in geringeren Wochenraten auf etwas längere Frist ausgedehnt, sicher, z.B. in New York, einen besseren Start ermöglicht. Ist mit der Entscheidung für Scattergood gegenwärtig noch nutzlos verbunden, dass aliens of enemy nationality Rückkehr nach New York unmöglich ist, dann ist es sogar eine Niere. Verglichen mit allem, was Flüchtlinge in Frankreich erleben müssen, ist Scattergood natürlich ein Paradies.


