Resolved that the adoption of the first two Books be referred to the Standing Committee on Text Books, with power, & that they report to this Committee as to the propriety of the other changes proposed.

A Communication was received from Miss Hance,

stating that on account of her health, it would be necessary to be absent for some time & she therefore resigned her situation.

Whereupon the Committee declined to accept her resignation but agreed that she have leave of absence for one year without salary & the Treasurer was directed to pay her one hundred dollars as an extra allowance.

Resolved that the Principal report a proper person, to fill the temporary vacancy at a salary of five hundred dollars.

The Principal made the following communication which was ordered to be on the table for future consideration.

The Principal regarding items due to the Executive Committee that they should be fully informed of the State of the School makes the following statement & suggestions.

The number of Students who have been connected with the school, the present term is 225. Every county has been either fully or partially represented, excepting seven, viz. Allegany, Essex, Hamilton, Herkimer, Lewis, Seneca & Wyoming. Reports of full appointments have been received from Herkimer & Lewis, but no pupils have entered the school from these counties. Reports of the appointment of 40 pupils, who have not presented themselves, were received soon after the opening of the term. Had these pupils entered, every seat would have been filled. In

addition to those 40 appointments, to fill vacancies, reports of the appointment of 20 Supernumeraries have been recd.

It is presumed that it was the intention of a large number, at least, of these sixty to attend the school, or they would not have sought the appointments. Without attempting to assign a cause of their non-attendance, it is presumed that in many instances, the pecuniary pressure of the times & the greatly increased expences of living, may have operated. In some of the counties, this is assigned as a reason by the Superintendents, of no appointments having been made.

It has long been felt that the mode in which appointments have been made, is not calculated to supply the full quota of first class pupils from all the counties. In some of the counties, the local officers not only neglect to give wide notice of vacancies, but often do not even attend the meetings called by the State Superintendent. In the county of Steuben, which contains 20 towns & the same number of town Superintendents, of which it is entitled to send 6 pupils, only three superintendents attended the late meeting. In the County of Dutchess, no meeting was held. It is presumed that the same may have occurred in other counties. While this apathy in regard to schools exists, it cannot be hoped that this school will be filled with the best pupils.

The means of securing such a class of pupils has occupied the anxious attention of the Faculty. They

have thought it important that the Teachers' Departments in the Academies should be more intimately connected with this school, & that these departments, in many of which the course of instruction is very limited, should be made a means of supplying pupils for a more extended & thorough course than they are able to furnish. A Vacation of two months succeed the close of the present term. The Faculty are not only willing but desirous to improve at least, a part of this time, in efforts to promote the improvements of the schools & the qualifications of teachers. Some of these Schools will undoubtedly be in session during a part of the ensuing vacation.

It is believed that the Principals of many of these would gladly avail themselves of this aid which might be offered in instructing their classes, & should the proposal meet the view of the Committee, for the Principal & Professors to visit such of these Academies, as may be convenient, & to which the service may be acceptable & spend a few days in lecturing the Teachers' Classes in modes of instruction, school government, & other important subjects, they will willingly undertake to do it. It is believed that not only a good may thus be secured to the schools, but that the purpose & plan of this school may be brought to the knowledge of many young men & women, who now know scarcely any thing of it & that some might thus be induced to avail themselves of its advantages, who would become valuable & permanent teachers.

Within a few years, the system of Normal

schools has been greatly extended in New England, Ohio, Michigan & Canada. It is presumed that in some or all of these schools other & improved methods may have been introduced. With these methods, it may be important for the teachers of this school to become acquainted.

Should the Committee regard the objects here suggested of sufficient importance to warrant such an appropriation as may meet the expenses necessary to be incurred in the execution of them, the Principal & Professors will cheerfully employ such a part of the ensuing vacation as can be profitable spent in this way.

To all who are acquainted with the condition of the schools in the State, it is apparent that there is a great need, that every possible means for their improvement should be put in vigorous operation. The instrumentalities by which this may be done are by no means powerful. An oppressive apathy pervades the public mind, and incompetent teachers are often employed to avoid the expense of those who are well qualified. Local School Officers are often incompetent & inefficient. In this state of things, the Faculty feel that the influence of this school should be more widely & more deeply felt. They are especially desirous of bringing to its instruction & discipline, a larger number of young men & those of a higher order of talents & of more advanced qualifications. They are willing to devote their energies to this object & in doing so, they hope to be able to do more than has yet been done for accomplishing the high purposes for

which the School has been established,

The Secretary reported, that during the late Session of the Legislature, the annual appropriation for the support of the State Normal School had been increased from \$10,000 to \$12,000 for the fiscal year commencing October 1855.

The Chairman stated that the Committee had been called together on account of the decease of Dr. T. Romeyn Beck, a member of the Executive Committee, and its Secretary & Treasurer.

The following preamble and resolutions were offered by the Superintendent of Public Instruction, and ordered to be entered on the minutes --

"The Executive Committee of the New York State Normal School, in recording the decease of their Secretary T. Romeyn Beck M.D., take occasion to declare their deep and earnest consciousness, that the spirit of a good and useful man has withdrawn from the earth; that from society has been taken one of its brightest ornaments; that the department of science has lost an efficient

laborer and zealous teacher and that the school of which this committee have charge has been deprived of an able and constant friend. In consideration and as a befitting acknowledgment of this afflictive dispensation it is therefore hereby

Resolved, That in testimony of veneration and respect for the memory of the deceased, and with a desire to emulate his virtues this committee will attend his funeral on Wednesday next and order that on that day the State Normal School be closed and its exercises suspended.

Resolved, That we tender to his bereaved family the assurance of our sympathy with them in the loss which they have sustained in the dissolution of relations the duties of which were performed by the deceased with the most constant rectitude affection and fidelity and that a copy of this record certified by the Superintendent of Public Instruction be transmitted to them as an evidence thereof.
